As a blind person, I have personal experience with issues facing disabled persons in our state. I feel that my experience and perspective will be a valuable asset to the Board.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

It's my understanding that the Board helps to set policy for state agencies, and the Board members propose, discuss, and advocate for these changes.

(3) In what ways do you feel that you can help protect the consumer?

Due to my familiarity with the experiences and vulnerabilities of disabled individuals, I can advocate for positive changes that will lower hurdles and improve access for disabled individuals.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

Aside from my personal experience as a disabled individual, I am familiar with the law, having received a law degree from William S.

Richardson, and I was employed in a legal office where the primary work involved Federal labor law, which included the Rehabilitation Act and the Americans with Disabilities Act.

I hope to facilitate a degree of change, to aid someone in gaining a clearer understanding of these issues, and/or to help craft policy that is sound, fair, and valuable.
