Comments: Chairpersons Shimabukuro and Gabbard and members of the Senate Hawaiian Affairs and Water, Land and Agriculture committees. Aloha. My name is Dr. Davianna Pomaika'i McGregor and I am a professor at the University of Hawai'i Manoa and a member of the Protect Kaho'olawe 'Ohana. I fully support funding of the Protect Kaho'olawe Island Reserve Commission (KIRC) by the State of Hawai'i. I am not able, however, to support HB 2200, HD2. It is unfair and unjust for the legislature to undermine the integrity and authority of the Office of Hawaiian Affairs by extracting a portion of the 20% of the funds designated for the betterment of the conditions of Native Hawaiians for an entity other than the Office of Hawaiian Affairs. As Native Hawaiians we need to stand united and firm together to assure that the entitlements of Native Hawaiians as one of two beneficiaries for the public trust lands are protected. If the legislature wants to fund the KIRC, revenues from the public trust lands for "public uses and public purposes" could be made available or monies from the general fund should be appropriated for this purpose. Mahalo nui loa for your support.
