House Bill 799 proposes to clarify the authority of the State, its employees, or its independent contractors, to remove birds or animals by aerial means in furtherance of official State duties. **The Department of Land and Natural Resources (Department) supports this measure.**

This bill protects state workers and helicopter pilot contractors from criminal prosecution while conducting routine aerial shooting missions as part of their State duties. This legislation is particularly applicable to the County of Hawaii, which in 2012 passed an ordinance making aerial control of animals unlawful.¹

Safety

- The Department's aerial shooting policies were updated and approved by the Board of Land and Natural Resources in 2006 following a publically vetted process. The Department does not own helicopters or employ pilots, and instead contracts certified helicopter companies to transport State gunners.
- Safety protocols for staff shooters and helicopter operators follow the rigorous Federal standards, requiring numerous specialized certifications² and are consistent with federal laws that permit States to conduct aerial shooting.³

- Public legal notices are issued prior to each mission, and lands are temporarily closed. The Department also uses trained spotters in the helicopter and ground personnel to ensure that operational boundaries are secured and safe.

Necessary for Legal and Operational Mandates

- Control of non-native hooved animals in certain locations is necessary because they cause damage and extinction to native species.^{4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25}
- In many places aerial shooting is the only method to control hooved animals due to remote, steep, and dangerous terrain, such as the 3,000-foot high cliffs of Molokai's north shore. Placing staff or the public into such areas is either impossible or creates an unacceptable safety risk.
- Without aerial shooting in Hawaii County, the State is vulnerable to lawsuits that allege the State is in violation of the Federal Endangered Species Act.²⁶ This issue has already been litigated over the Palila, a highly endangered bird, whose critical habitat is found only on Mauna Kea. In 1979, the United States District Court issued a ruling that "...the defendants'²⁷ failure to remove said feral animals [sheep and goats] from that critical habitat, constitutes an unlawful taking of the Palila in violation of Section 9 of the Endangered Species Act."²⁸ In 1998 the Court issued a stipulation requiring the State to aerially shoot any hooved animals observed in the area on a semi-annual basis.²⁹ Critical habitat is designated for at least 40 more species that are threatened by feral animals in Hawaii County.³⁰

Additional Aerial Shooting Benefits

The Department has been conducting aerial shooting for the purpose of natural resource protection for decades.

- Hooved animals eat and dig up plants, leaving barren areas that erode. State aerial shooting on the south slope of Molokai has reduced erosion 10-fold within 5 years.³¹ There, erosion is the largest threat to the health of the coral reef and fisheries,³² and muddies dozens of ancient fishponds.³³ This impedes the restoration and use of these fishponds, a priority for preserving the Hawaiian cultural heritage.³⁴
- Aerial shooting was necessary in the successful removal of all goats from Kahoolawe, where unexploded ordnance and steep terrain prevented ground control.
- Aerial shooting occurs in many other locations in Hawaii, nationally, and internationally.³⁵
- Aerial shooting is also a necessary tool to control wildlife that threatens public safety. Axis deer have caused dozens of vehicle accidents on Maui, Molokai, and Lanai.³⁶ Aerial shooting has been proposed to cull these populations in remote areas to prevent their expansion into populated locations.³⁷

Involving Public Hunters

The Department's policy is to first allow public hunting for hooved animal removal when safe, feasible, and effective to reduce numbers as much as possible before progressing to the use of other methods such as staff hunting, trapping and aerial shooting.

- Approximately 90% of the Department's Division of Forestry and Wildlife (DOFAW)-managed lands are open to public game mammal hunting. The balance is largely safety zones, or areas without mammals.
- The Department actively seeks public hunting participation by providing hunters special access, transport, and animal control permits. However, there remain many areas too dangerous or remote for public hunters and staff to control animal populations on the ground. In these locations, animal populations are unchecked and significant resource damage is mounting.

Meat Salvage and Humaneness

DOFAW retrieves many of the animals shot during aerial missions and gives the meat to the public.

- In Mauna Kea, where the majority of aerial shooting occurs, dispatched sheep are flown to a drop-off point along the highway, unless it is too unsafe to retrieve the animals or if there is no one waiting to pick up the meat.
- In the last year, DOFAW salvaged 80% of the sheep dispatched, and cumulatively over the past two years, 1,474 sheep were provided to the public.
- Aerial shooting also provides flexibility with positioning and speed to get a clean shot and reduce the amount of time the targeted animals are pursued.

Section 263-10, Hawaii Revised Statutes (HRS) Background

There is no evidence that the Territorial Legislature passed Section 263-10, HRS, with the intention of limiting State action or even with the expectation that controlling animals in this way would be an important tool for meeting the State's public trust responsibilities a century into the future.³⁸

- Section 263-10, HRS, was established in 1923 as part of a larger Uniform Aeronautics Act standardizing flying regulations across the nation. At this time, airplanes were just beginning to be used by private entities.
- Section 263-10, HRS, was passed long before helicopters became widely used.

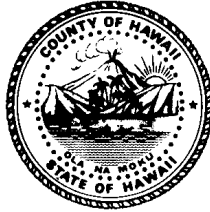

Regarding House Bill 799 – STRONGLY OPPOSED

HB799 exempts the Department of Land and Natural Resources from restrictions on aerial hunting in the State of Hawaii. This authorization permits the utilization of this inhumane and wasteful practice without an associated accountability or prerequisite to explore any alternative solutions.

Instead, we propose that the Committee AMEND HB799 to include cooperative consultation with consumptive resource users prior to any eradication activity including aerial eradication.

It is to be agreed that aerial eradication is to be conducted ONLY in areas that alternative solutions aren't practical to achieving predetermined management goals settled upon with stakeholders and consumptive users.

In this vein, the County of Hawaii Game Management Advisory Commission requests that you support the establishment of a Statewide Game Commission to enable this collaboration.

Testimony of The Nature Conservancy of Hawai'i
Supporting H.B. 799 Relating to the Uniform Aeronautics Act

The Nature Conservancy of Hawai'i is a private non-profit conservation organization dedicated to the preservation of the lands and waters upon which life in these islands depends. The Conservancy has helped to protect nearly 200,000 acres of natural lands in Hawai'i. Today, we actively manage more than 35,000 acres in 11 nature preserves on Maui, Hawai'i, Moloka'i, Lāna'i, and Kaua'i. We also work closely with government agencies, private parties and communities on cooperative land and marine management projects.

The Nature Conservancy supports H.B. 799.

HRS §263-10, which prohibits aerial hunting, was passed by the Territorial Legislature in 1923 as part of a larger Uniform Aeronautics Act being adopted in mainland states at a time when the military was urging states to standardize basic civilian flying regulations. There is no evidence that the Territorial Legislature passed H.R.S. § 263-10 with the intention of limiting State action or even with the expectation that controlling animals in this way would be an important tool for meeting the State's public trust responsibilities a century into the future.

We agree that introduced wildlife resources need to be wisely managed both for their benefits and, in some cases, for the risks they pose. Hawai'i has an important history of hunting game mammals for food and recreation that should be perpetuated and even enhanced, but it is a modern history. With the exception of the Hawaiian bat, Hawai'i has no native land mammals. Wild pigs were introduced from Europe and Asia after 1778. The smaller Polynesian pig brought by the first Hawaiians is gone (except on Ni'ihau), crowded out by these later introductions.

While an important resource, wild pigs, goats, sheep, deer, and cattle are also a major threat to the health of some of our most important native forests and watersheds. Centuries before the introduction of game mammals, Hawai'i's native plants and animals evolved in geographic isolation to form the unique ecosystems that make up these islands. In the absence of predators, native species did not develop defenses such as thorns or other mechanism to deter browsing or rooting animals. As a result, our native forests have no natural defenses against wild mammals. Left unmanaged, feral ungulates can strip large areas of forest bare, contributing to erosion, sedimentation harmful to coastlines and coral reefs, and impairing the natural absorptive function of watersheds. The areas disturbed by these animals also create open soil for weed invasions, further enhancing the decline of native ecosystems and watershed values.

Through years of research, experimentation, and experience, it has been shown that the most effective management strategy for these animals is a multi-faceted approach including fencing, public hunting, staff hunting, live trapping, snares, and aerial shooting under strict safety protocols. In some accessible locations, hunting and live trapping are sufficient for ungulate control. However, many areas of important native forest and watersheds are remote, mountainous, or otherwise so steep as to make standard animal control techniques dangerous, impractical and, in some cases, impossible. Control of animals from helicopters is a proven safe and humane management tool in these types of instances.

The O'ahu Invasive Species Committee (OISC) supports H.B. 799 that allows the state, its employees or independent contractors to remove birds or animals by aerial means in furtherance of official state duties.

The O'ahu Invasive Species Committee works island-wide to remove incipient invasive species from O'ahu before they become so abundant that they begin to damage ecosystems. OISC uses helicopters to survey for invasive plants over terrain that is too steep to be safely accessed on foot. For OISC, aerial surveys cost approximately 75% less than ground surveys. (Ground surveys for certain species are necessary for OISC even though they are more expensive because we need to be able to see under the canopy). We assume that the cost differential would be similar in other applications.

Allowing employees or independent contractors to remove birds or animals by aerial means in furtherance of official state duties will be an important to invasive species control.

The Friends of Hakalau Forest National Wildlife Refuge SUPPORT HB799

Among other things, HB799 would authorize State employees or contractors to control feral game mammals by aerial shooting. There are several compelling reasons to enact this bill.

1. Hoofed animals are rapidly destroying the biological integrity of our forests. These animals destroy the native ground cover, accelerate erosion and coastal sedimentation and lead to rapid invasion of non-native plants. Protection and restoration of native forests is not feasible without aggressive ungulate control.
2. Fencing is an important conservation tool. Where ungulate eradication is the objective, the animals must be removed faster than reproduction or ingress can replenish the population. In most areas, this will require a full suite of techniques. Recreational and subsistence hunters can play an important role early in the eradication process, but other techniques, such as aerial shooting, are more effective once the ungulate population has been reduced significantly.
3. Some argue that aerial shooting is inhumane and in conflict with traditional values. In my experience, aerial shooting, when combined with ground shooting, is a very effective tool that results in rapid mortality of target animals. A well planned and aggressive ungulate control program will also result in less animal suffering when compared to a protracted control program that necessitates killing far more animals due to rapid reproduction.
4. State agencies are directed by law and policy to protect and restore our forested watershed . Failure to permit the use aerial shooting by highly skilled State employees and contractors is akin to tying the State's hands behind it's back .
5. We should be working together to preserve our outstanding watershed and our opportunity to use its resources rather than eliminating the tools we need to get the job done.

This authorization permits an unfettered exploitation of resources without an accompanying accountability, or requirement to explore any alternative solutions to the need of this inhumane and wasteful practice of aerial shooting of game.

We OPPOSE this bill because there are no checks to the DLNR and no mandate to consult with consumptive constituents about management rather than simplistic paradigms issued by those with no experience or obligation to the community that these forestlands serve.

Solutions demand participation of parties. This bill excuses that necessity and validates DLNR's unilateral practices to game management and for those reasons, WE OPPOSE!

Wildlife, particularly on State public lands are, by law, a resource held in the public trust. It would not be prudent to grant the State powers to forever destroy a public resource without any sort of public process.

AERIAL SHOOTING CAN POSE AN UNNECESSARY PUBLIC SAFETY RISK.

The DLNR has demonstrated itself incapable of self-regulating the use of aerial shooting in the past. Residents of Kona Mauka and Kohala, on the Big Island, were witness to the DLNR and contractors aerially shooting wild cattle and goats in unacceptable proximity to residences. Residents were given no notice by the department. This prompted the County Council of Hawaii to enact an ordinance banning aerial shooting. This past December the DLNR attempted to overturn the County of Hawaii's ordinance and have a Judge grant them injunctive relief from State law HRS 263-10. The case was dismissed and till today the DLNR does not want to engage in any public process for using aerial shooting.

There is **no threat of lawsuit** if the State is not allowed to aerial shoot outside of critical habitat. The Endangered Species Act does not mandate methods of killing animals. It is the State's responsibility to find **publicly acceptable** management methods.

For the above reasons and many more, the Hawaii Sportsmen's Alliance opposes HB 799.

It would not be prudent to grant the State powers to forever destroy a public resource without any sort of public process. AERIAL SHOOTING CAN POSE AN UNNECESSARY PUBLIC SAFETY RISK. The DLNR has demonstrated itself incapable of self-regulating the use of aerial shooting in the past. Residents of Kona Mauka and Kohala, on the Big Island, were witness to the DLNR and contractors aerially shooting wild cattle and goats in unacceptable proximity to residences. Residents were given no notice by the department. This prompted the County Council of Hawaii to enact an ordinance banning aerial shooting. This past December the DLNR attempted to overturn the County of Hawaii's ordinance and have a Judge grant them injunctive relief from State law HRS 263-10. The case was dismissed and till today the DLNR does not want to engage in any public process for using aerial shooting. There is no threat of lawsuit if the State is not allowed to aerial shoot outside of critical habitat. The Endangered Species Act does not mandate methods of killing animals. It is the State's responsibility to find publicly acceptable management methods.

In Support of HB 799 Relating to Uniform Aeronautics Act

Aloha, Chair Yamane, Vice Chair Cullen, and Members of the Committee. The Conservation Council for Hawai'i supports HB 799, which clarifies the authority of the State, its employees, or its independent contractors, to remove birds or animals by aerial means in furtherance of official State duties.

Such clarification would be useful. Aerial hunting by the State, its employees, or independent contractors is a tool to help protect essential watersheds and native species habitats. Although it is not used very often, this management tool should be available. Public hunting and ground hunting by the State, its employees, and independent contractors alone are not effective in large, remote areas and areas that are difficult to access by foot or ground vehicle.

Introduced continental barnyard animals gone wild and introduced game mammals, such as deer, are among the most destructive and serious threats to watersheds, native species habitats, forests, and recreation on public lands, as well as private farms, ranches, nurseries, gardens, and business and residential properties.

Here are photos of the endangered palila and its critical habitat on Mauna Kea, which has been destroyed by introduced cattle, sheep, mouflon, hybrid sheep, and goats. The State is under several federal court orders to remove all sheep, mouflon, hybrid sheep, and goats from the palila bird's critical habitat. Aerial hunting is necessary to comply with the court orders.

There may be other areas where aerial hunting is needed and would be effective, including state lands with feral cattle. There are too many introduced browsing and grazing animals in our Hawaiian forests and watersheds.

Please kokua. Mahalo nui loa for the opportunity to testify.

It would not be prudent to grant the State powers to forever destroy a public resource without any sort of public process. AERIAL SHOOTING CAN POSE AN UNNECESSARY PUBLIC SAFETY RISK. The DLNR has demonstrated itself incapable of self-regulating the use of aerial shooting in the past. Residents of Kona Mauka and Kohala, on the Big Island, were witness to the DLNR and contractors aerially shooting wild cattle and goats in unacceptable proximity to residences. Residents were given no notice by the department. This prompted the County Council of Hawaii to enact an ordinance banning aerial shooting. This past December the DLNR attempted to overturn the County of Hawaii's ordinance and have a Judge grant them injunctive relief from State law HRS 263-10. The case was dismissed and till today the DLNR does not want to engage in any public process for using aerial shooting. There is no threat of lawsuit if the State is not allowed to aerial shoot outside of critical habitat. The Endangered Species Act does not mandate methods of killing animals. It is the State's responsibility to find publicly acceptable management methods.

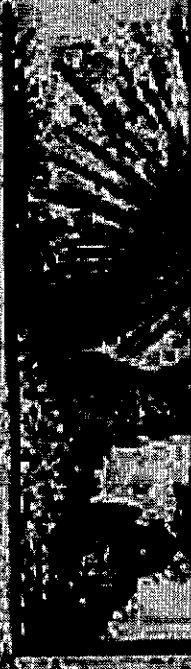
