Chair Nishihara, Vice Chair Espero, and Members of the Senate Committee on Public Safety, Intergovernmental, and Military Affairs:

I am Major General Arthur J. Logan, State Adjutant General and the Director of the Hawaii Emergency Management Agency. I am testifying in support of the intent of House Concurrent Resolution 129 and House Resolution 82.

These resolutions will help to increase public awareness of the causes, symptoms and treatment regiments for post-traumatic stress disorder (PTSD).

What is PTSD? At the Department of Veterans Affairs PTSD website states:

Post-traumatic stress disorder (PTSD) can occur after someone goes through a traumatic event like combat, assault, or disaster. Most people have some stress reactions after a trauma. If the reactions don't go away over time or disrupt your life, you may have PTSD.

The number of reported cases of PTSD have increased after 26 years of military engagement in the Persian Gulf and Afghanistan. Our women veterans suffer higher rates of PTSD and those number will only increase after the recent Department of Defense decision to allow women to serve in all combat related career fields.

Efforts to increase public awareness will help reduce the stigma of PTSD for those who served.

Thank you for allowing me to testify in support of the intent of House Concurrent Resolution 129 and House Resolution 82.

My name is Rae Gee and I am currently experiencing post-traumatic stress. I am not a war veteran, or member of the United States Armed Forces, who risked their lives saving our country. I am a civil-servant that works for the government and has and continually experienced post-traumatic stress at work derived from a hostile work environment.

My case is confidential and I cannot share the details of the source of the stress, but I am suffering injuries from incidents that occur the same way that those who have received physical or mental wounds in service to this Nation. Those injured deserves respect and recognition, and not the stigma of a mental illness.

Anyone who has this disorder deserves proper and timely treatment and no stigmatism of a mental illness, and should be encouraged to seek treatment without fear or, retribution or shame.

I strongly urge your committee to pass this measure and allow June 27, 2016 to be designated as "Post Traumatic Stress Awareness Day" to encourage everyone, all service providers, medical professionals, to continue educating service members and their families, victims of abuse, crimes, and the general public, of post-traumatic stress injuries, derived from war or just everyday life. Post-traumatic stress can happen to anyone.
