Aloha Chair Nishihara, Vice-Chair Espero, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services. I appreciate this opportunity to provide testimony in support of HCR 40 (HSCR 1582-16).

Almost every one of the military services that perform funeral honors for eligible Veterans and retirees in Hawaii bring a full-complement of members of an Honors detail that include these functions: the three-volley salutes, the playing of Taps, and the folding and presentation of the US flag to the next of kin. Only the US Air Force as of December 1, 2015 has reduced their Honors Detail to a three or two person team eliminating the three-volley salutes. Our office has received numerous queries concerning why the difference in service protocol and why only the US Air Force has instituted this change. The rationale provided by the 15th Wing has been due to sequestration and budget cuts. Admittedly, family members and loved ones of the deceased Veteran or retiree have a hard time understanding why the other services have made this a priority for funding, yet one service has not. As a possible resolution, all of the services should be assessed to combine their Honors resources so all funerals are provided the same honors protocol. This is evident when a Joint Service Color Guard presents the colors on Memorial Day, Veterans Day and at military events. Funerals would require that at least one member must be from the decease member's service.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families in support of HCR 40 (HSCR 1582-16).
