**Title of Bill:** SB 2316 RELATING TO HEALTH.

**Purpose of Bill:** Requires a child to receive at least one dosage of the human papillomavirus vaccine prior to attending seventh grade, beginning with the 2017-2018 school year. Authorizes pharmacists to prescribe and administer the human papillomavirus vaccine to persons between eleven and seventeen years of age. Specifies requirements pharmacists must meet prior to administering the human papillomavirus vaccine. Requires all insurers in the State, including health benefits plans under chapter 87A, Hawaii Revised Statutes, and medicaid managed care programs, to reimburse the costs of human papillomavirus vaccination services.

**Department's Position:**

The Department of Education (Department) recognizes the intent of SB 2316 which focuses on an important health issue, but respectfully opposes the proposed mandatory requirement of one dose of the human papillomavirus vaccination (HPV) prior to 7<sup>th</sup> grade entry.

The Department is concerned its implementation would negatively impact school attendance since SB 2316 does not include a provision for medical and religious exemptions. It is important to note that medical and religious exemptions are currently allowed for school entry immunization requirements.

Also, work related to this measure would not end upon enrollment. In order to be effective, students must receive three doses of the HPV. Given the added administrative and operational workload, school personnel will be tremendously challenged to meet the mandates of this measure.

Dear Chairs Baker and Kidani and Members of the Committees,

Thank you for considering my testimony in support of S.B. 2316. I am a longstanding member of Hawaii's public health and cancer control communities, having championed many public health issues over the past 20 plus years. I submit this testimony today, however, as a woman and a mother concerned for the health of our future generations.

For the first time in our nation's fight against cancer, children growing up today can benefit from one of the most amazing breakthroughs in cancer prevention - human papillomavirus (HPV) vaccines. A series of three HPV vaccinations administered over a 6 month period will protect adolescents and young adults from future exposure to HPV serotypes that cause most cervical cancers and other HPV-associated cancers (vaginal, vulvar, penile, anal, and oral), as well as genital warts. Now with over 15 years of clinical research, HPV vaccines have been proven safe, effective, and long-lasting in their protection against cancers caused by HPV.

During the past 20 years at the University of Hawaii Cancer Center, I have met and enjoyed working with many cancer survivors – brave warriors who fight the good fight and others who, sadly, lose their battle to the disease. In the US, an estimated 11,000 women will be diagnosed with cervical cancer and 4,000 women will succumb to the disease this year. Here in Hawaii, invasive cervical cancer cases have dramatically decreased over the past several decades due to widespread use of Pap screening. Despite the decreasing incidence of cervical cancer, racial/ethnic disparities remain stark with a disproportionately high cervical cancer burden in Filipinas, Native Hawaiian and Micronesian women.

In thinking about the opportunity that we have before us to potentially eliminate invasive cervical cancer as well as low grade and high grade cervical dysplasia (pre cancers), plus other HPV-associated cancers, I am seriously concerned that this cancer prevention vaccine has been forgotten as one of the most powerful tools available in our arsenal.

Hawaii's HPV vaccination coverage estimates are an appalling 38% for girls and 31% for boys ages 13-17 (NIS Teen, 2014). Interestingly, these HPV vaccination rates lag far behind coverage rates for other adolescent vaccines (82.3% Tdap and 77.7% MenACWY) and fall well below the Healthy People 2020 target of 80% vaccination coverage for both boys and girls. While there are many efforts afoot to increase HPV vaccination in Hawaii and across the nation, only compulsory vaccination will get us to our 2020 target of 80% vaccination coverage for both boys and girls. Note that in a 2015 survey conducted by the UH Cancer Center and JABSOM, 68% of health care providers (n =120) agreed that the absence of a school entry requirement is a barrier to HPV vaccination in Hawaii.

Regarding pharmacy-located HPV vaccination, I can attest that this option is certainly convenient for busy parents and students alike. Last summer, after securing a prescription from my daughter's pediatrician, I located a nearby pharmacy that stocks and administers the new HPV Gardasil 9 vaccine. After summer school let out, my daughter and I stopped in the grocery

store-based pharmacy for the last of her 3-dose HPV vaccine series. The entire visit took less than 15 minutes. There was no need to pull my daughter out of school for the vaccination, and I didn't have to take time off of work. Parking was easy too. My daughter was equally satisfied with the visit; she never doubted the skills of the pharmacist who administered the HPV vaccine. I applaud the inclusion of language in S.B. 2316, extending vaccination privileges to pharmacists for adolescents as young as 11 years of age. This provision will expand access and reduce barriers to this life-saving vaccine.

And regarding insurance coverage, all insurance plans are now required, per ACA, to cover the full cost of the HPV vaccine series. Individuals eligible for the Vaccines for Children Program (VFC) are also fully covered for the 3-dose HPV series. In my work with health care providers, however, I have learned that some "grandfathered" plans in Hawaii have limited coverage to certain age groups, thereby presenting challenges for some families of adolescents. Until all health insurance plans can guarantee coverage of cancer prevention vaccines, and without deductibles and copayments, I support the intent of language in S.B. 2316.

As a mother, I want every child to be protected against infection by the cancer-causing human papillomavirus. It still dumfounds me as to why, 15 years after the first HPV vaccine became available, many parents are uninformed and many physicians hesitate to strongly and consistently recommend this cancer prevention vaccine. Per the President's Cancer Panel Report on Accelerating HPV Vaccine Uptake (2014), "underuse of HPV vaccines is a serious but correctable threat to progress against cancer." I applaud your committees for bringing this important public health issue to light, and for leading the charge to protect Hawaii's future generations from vaccine-preventable cancers and other conditions.

Thank you for this opportunity to testify in support of S.B. 2316.

Dear Senators of the Consumer Protection and Health Committee and Senate Committee of Education,

**I urge you to OPPOSE** SB 2316 which would mandate that all students entering 7th grade in Hawaii receive at least one dose of HPV (human papillomavirus vaccine). These bills would also allow pharmacists to administer HPV Vaccines to children between the ages of 11 and 17 and require all insurance policies to cover 3 visits for HPV Vaccine. (1)

- HPV is a sexually transmitted virus and is not contagious in a school setting so a school vaccine mandate is unnecessary. The vaccine is already available to anyone who wants it so legislative requirements are not necessary; (1)
- HPV infection is experienced by the majority of sexually active women and men and is naturally cleared from the body within two years by more than 90 percent of those who become infected; (1)
- Merck studied GARDASIL for less than 3 years in about 1200 healthy girls and 1400 healthy boys under age 16; it was not tested in children with health problems or in combination with all the other vaccines routinely given to American adolescents; (1)
- Thousands of reports of unexplained collapse, seizures, muscle pain and weakness; disabling fatigue, paralysis, brain inflammation, rheumatoid arthritis, lupus, blood clots, multiple sclerosis, strokes, heart and other serious health problems, including death, have been reported after GARDASIL shots; (1)
- CERVARIX was studied for less than 6 years in fewer than 1200 healthy girls under age 15; it was not tested in children with health problems or when given simultaneously with other childhood vaccines; (1)
- Unexplained collapse, muscle and joint pain and weakness; fatigue; brain inflammation, reactive and rheumatoid arthritis, lupus, scleroderma, hypothyroidism; multiple sclerosis, optic neuritis, spontaneous abortions, heart and other serious health problems, including death, have been reported after CERVARIX shots; (1)
- The FDA asserts that the foreign DNA fragments found in Gardasil pose no risk. In contrast, Dr. Hanan Polansky, PhD, Managing Director from the Center for the Biology of Chronic Disease states that these DNA fragments at high concentrations can cause major diseases such as, cancer, heart disease, diabetes, autoimmune diseases, and even obesity even when the DNA is broken and not functioning; (2)
- Gardasil is the FDA approved HPV vaccine. As of September 15, 2011, the Centers for Disease Control (CDC) received a total of 20,096 reports of adverse events in relation to Gardasil vaccination; (3)
- The HPV recombinant vaccine has been found to be contaminated with a genetically engineered form of rDNA that does not naturally come from the HPV virus but was added during their manufacture. As a recombinant rDNA, it can

insert itself into human DNA which may stay there forever or can mutate resulting in a chronic inflammatory disease. (4)

- The early polio vaccine was contaminated with the cancer-causing SV-40 virus, which came from Simians (apes). As a result the CDC admits that over 30 million Americans are at risk of cancer which is more likely up towards 100 million since many had multiple doses of this vaccination between the 1955-1963. As a recombinant vaccine, HPV has the potential to be just as harmful. (5)

- Yearly pap smears can prevent 80 percent or more of all cervical cancers; (6)
- A young girl's risk of developing cervical cancer, excluding the Gardasil vaccine, is less than 0.00002 percent. (6)

This vaccine does not serve the children. It is honorable that your committees wish to preserve the well-being of the children, however, this is NOT the right way to accomplish this goal.

Aside from the health implications, by forcing this vaccination on our young children, you are assuming that we as parents have no influence on the behavior of our children. You are assuming that we parents do not know how to raise our children and that we do not know how to take care of our children and worse, we don't know what's best for our children. You are also assuming that our children are going to be sexually active at 11 years old and promiscuous. I am not only highly offended but horrified that a group of strangers feel as though they know what is better for my child than I do. I am well educated, with several degrees. I daresay, I am more knowledgeable than perhaps most if not all of the committee members, on the issue of vaccinations and their side effects. I know what is best for my child.

Vaccinations can be valuable if used in a methodical, individualized, non-cookie cutter approach. However, all children are not created equally in terms of their health and genetic make-up and predisposition. Some children are extremely sensitive to the exposures to environmental toxins including glyphosates found in Round Up, a toxic, carcinogenic pesticide sprayed on our food supply and VOG, both of which heavily affect the children living in the islands

As a pharmacist, I have talked to thousands of parents, many of whom wonder why their child has asthma, severe allergies, severe eczema or psoriasis, constant ear infections, constant illnesses and such throughout their childhood, which in most cases, become chronic and stay with them throughout adulthood.

The demanding immunization schedule is mostly at fault, not that it causes disease per se but it is due to a stressful event such as a vaccination that can result in the development of a host of chronic diseases. In general, a healthy immune system is capable of naturally suppressing the expression of a virus, however, it is the sudden introduction of antigens from a vaccination that tilts the immune system into an extreme imbalance where now the immune system becomes overwhelmed. The combination of an HPV vaccine as recombinant DNA and retroviruses contaminating some 30 percent of today's vaccines, it is no wonder why a child can suddenly develop an autoimmune reaction, convulsions, paresthesia, paralysis, Guillain-Barre Syndrome, transverse myelitis, facial palsy, chronic fatigue syndrome, anaphylaxis and DEATH.



I guarantee you that if any committee member has a young child or grandchild with some kind of medical diagnosis, especially one that is related to the immune system such as allergies, eczema, psoriasis, or some chronic disease state where the immune system trying to rebalance itself, chances are your precious loved one will have a more severe chronic disease as a child or adult. Living in Hawaii, VOG is constantly causing children to be continuously sick, on antibiotics for bronchitis, albuterol, and worse, prednisone. Although prednisone helps to decrease inflammation, it also decreases your natural immunity at the same time. These are some of the very children who will not tolerate an HPV vaccine well.

This is not a matter of maybe, but a matter of when. I urge you, Senators, if you have any concern for your own children or grandchildren, YOU must OPPOSE this bill. The herpes papilloma virus is not a threat to the children but the HPV vaccine is. As parents, we do not raise our children to be promiscuous with wild sexual behaviors. Our society is not made up of barbarians. We are civilized. This vaccine requirement crosses the most basic rights of being a parent and a citizen. At the same time, the HPV vaccine cannot guarantee that a child will not develop anything by getting it. What is more likely is that your loved one will develop a long term adverse reaction from getting it.

Please do not chance the health of our children and your very own children and grandchildren through this mandate. It is a bad decision for all of us.

- It is NOT KNOWN whether GARDASIL or CERVARIX can damage genes or cause infertility or cancer

Vaccines are pharmaceutical products that carry a risk of injury and death. The Institute of Medicine, in a series of reports on vaccine safety spanning 25 years, has acknowledged that there is individual susceptibility to vaccine reactions for genetic, biological, and environmental reasons that have not been fully defined by science. Doctors cannot predict ahead of time which individual will be harmed.

Since 1988, federal vaccine injury compensation program, which was created under the National Childhood Vaccine Injury Act of 1986, has awarded more than \$3 billion to children and adults injured by vaccines or to families of those who died from vaccine reactions. It has been estimated that less than ten percent of adverse reactions are reported.

In 2011, the U.S. Supreme Court completely shielded vaccine manufacturers from liability for FDA licensed and CDC recommended vaccines, which resulted in no product liability or accountability in the event of injury or death.

When there is a risk of harm from a pharmaceutical product, especially a product that is marketed by companies completely shielded from civil liability, the parent's or individual's right to exercise informed consent on behalf of a minor child or themselves must be legally protected. In light of the fact that vaccine risks are not borne equally by all due to known or unknown individual genetic and other biological or environmental susceptibilities, the right to exercise informed consent is imperative in order to protect a minor child or oneself from vaccine injury and death.

There is no public health emergency in Hawaii or compelling state interest that justifies the passage of a bill that violates human, civil, and parental rights. SB2316 puts the children of Hawaii at unnecessary risk.

It is your responsibility to preserve the rights of Hawaii's citizens in health policies and laws. Please oppose SB2316.

My name is Alohi Ae'a and I am writing in opposition to SB2316. I oppose mandating the administration of the HP Vaccine for these reasons:

1. As a patient, I have the right to informed consent, which also means that I have the right to agree to or refuse any medical treatment. A vaccine is no different. The state does not and should not have the right to tell me what I must do with my body nor should it have the right to tell me what I must do to my children.
2. The HP Vaccine has not been well studied, and there are numerous issues with risks and side effects that make the vaccine a concern.
3. I have seen first hand the result of negative vaccine side effects. My 34 year old brother, who was born completely normal, today needs 24-hour care, has seizures, and is wheelchair bound as a result of his allergic reaction to the DPT vaccine which he received in the 80's. My 32 year old brother also demonstrated the same allergic reactions until he was discontinued from receiving the vaccine. I have memories of excruciating pain and an inability to walk after receiving shots as a child. Comments: My name is Alison Watts. I am a graduate of The University of Hawaii at Hilo. I wanted to submit a personal written testimony stating that I am strongly opposed to the HPV mandate SB 2316. I have actually had the Gardasil vaccination myself which was designed to prevent HPV and cervical cancer. I want to tell you firsthand from my own personal experience that there is much cause for alarm!!! I had never had an abnormal pap smear and I was a very conservative girl that took my sexual health seriously and did not engage in risky behaviors. I had always had a clean bill of health and went to my OBGYN normally for annual checkups. I got the Gardasil vaccination while I was still a junior in high school because I was told by my doctor and the media that it would prevent HPV, the virus that causes cervical cancer. A few years after graduating high school I was told that I had HPV and it was in the early phases of cervical cancer. This was not long after my vaccination and now I was in my early twenties being told by my doctor that I should have a procedure done called a "leap" that would remove a small portion of my cervix. I was absolutely devastated and opted to have another less invasive form of treatment. Ironically the HPV vaccination that was supposed to actually prevent this on the contrary seemed to somehow be linked to the very condition it was trying to prevent. If I had known then what I know now, I would have NEVER NEVER opted to take the HPV vaccination. It is one thing to have a choice but another thing to make something that carries so much potential health threats mandatory. This particular vaccination has a poor reputation linked to civil lawsuits and adverse side effects. Do we really want to make this mandatory for Hawaii Public School Systems? I know there are many parents with health conscious lifestyles who are going to be opposed to this. If I had to make the choice between either this vaccination or my child not receiving a proper education I would regrettably choose to not formally educate them rather than to risk their life and health. If health conscious mothers opt out of this and can't homeschool their children properly, then we are going to have a new generation of uneducated keiki that the public welfare system will ultimately be responsible for. This is an inherent reality that we are not even considering. If this bill passes I adamantly feel that we will be largely using our children as a science experiment for the pharmaceutical companies to push something that carries serious health risks. As someone who has been directly impacted emotionally and physically by this particular vaccination, I must say I am appalled at the state of Hawaii for even considering making such a practice mandatory! Comments: Please OPPOSE this bill SB 2316 to force vaccination on any family. The American College of Pediatrics has released a study in January of 2016 regarding the HPV vaccination. Here is one example of problems that have been associated with this vaccine. "Many adolescent females are vaccinated with influenza, meningococcal, and tetanus vaccines without getting Gardasil®, and yet only 5.6% of reports related to ovarian dysfunction since 2006 are associated with such vaccines in the absence of simultaneous Gardasil administration. The overwhelming majority (76%) of VAERS reports since 2006 with ovarian failure, premature menopause, and/or amenorrhea are associated solely with Gardasil®. When VAERS reports since 2006 are restricted to cases in which amenorrhea occurred for at least 4 months and is not associated with other known causes like polycystic ovary syndrome or pregnancy, 86/89 cases are associated with Gardasil, 3/89 with Cervarix™, and 0/89 with other vaccines administered independently of an HPV vaccine.<sup>5</sup> Using the same criteria, there are only 7 reports of amenorrhea from 1990 through 2005 and no more than 2 of those associated with any one vaccine type. It is alarming that the state of Hawaii would force vaccination on all of the youth of Hawaii, when the Vaccine Adverse Event Reporting System is rich with many examples of problematic reactions on almost all vaccines. The American Legislative Exchange Council (ALEC) is a right-wing lobbyist group that is pushing this nationwide effort to force vaccination after the success in California. This is Big-Pharma forcing what can be their sale-rack of vaccinations upon our children. The state of Hawaii has bought flu-shots on sale in the past and inoculated our school children with these. I oppose any and all of the forced vaccination bills. While it may be rooted in good intentions, it is a slippery slope toward personal tragedy for a small segments of our population. 

I urge you to also OPPOSE HB 1722, which would eliminate the religious belief exemption to vaccination for public school students. This bill prohibits a parent from exercising their freedom of conscience that applies to their religious beliefs and obtaining a religious exemption for their child for one or more state required vaccinations. There is No Compelling State Interest. There is no public health emergency or compelling state interest that justifies forcing vaccination by violating the right to freedom of conscience and personally held sincere religious beliefs. Vaccines are pharmaceutical products that carry a risk of injury or death, a fact that was acknowledged by the U.S. Congress in 1986 when it passed the National Childhood Vaccine Injury Act. Since 1988, the federal vaccine injury compensation program created under that law has awarded more than \$3 billion to children and adults injured by vaccines or to families whose loved ones died from vaccine reactions, although two out of three who apply are denied compensation. The Institute of Medicine in a series of reports on vaccine safety spanning 25 years has acknowledged there is individual susceptibility to vaccine reactions for genetic, biological and environmental reasons that have not been fully defined by science, and doctors often cannot predict ahead of time who will be harmed. Current law §325-34 only allows medical exemptions for 3 months after a duly licensed physician, physician assistant, or an authorized representative of the department of health has signed two copies of a certificate stating the name and address of the person and that because of a stated cause the health of the person would be endangered by the vaccination or immunization. This is too short a period of time for the medical exemption to apply for children with long term health problems or with a history of vaccine reactions. If the religious exemption is removed, this medical exemption is the only exemption that is available

for school children. Physicians should not be time restricted by the legislature in exercising their professional judgement about medical exemptions for vaccination. When there is risk of harm from a pharmaceutical product, especially a product that is marketed by companies completely shielded from civil liability, the parent's or individual's right to exercise conscience, religious belief and informed consent on behalf of a minor child or themselves must be legally protected. In light of the fact that vaccine risks are not borne equally by all due to known and unknown individual genetic and other biological or environmental susceptibilities, parental rights, individual informed consent rights, as well as those of a state licensed physician or designated vaccine provider to exercise professional judgment in protecting a child from vaccine injury and death, must be preserved in health policies and laws. The least restrictive means for ensuring the public health and safety should be employed by the legislature to protect public trust in the wisdom and fairness of government policy and law. There is no public health emergency in Hawaii or compelling state interest that justifies the passage of these bills which would violate human, civil and parental rights. **FLU SHOT MANDATES FOR HEALTH CARE WORKERS** I urge you to also **OPPOSE HB 1945 and SB 2394** which would mandate health care workers receive a yearly flu vaccine. "Health care worker" means all persons, whether paid or unpaid, working or delivering services in a health care facility, including contractors and their employees whose occupational activities involve direct or indirect contact with patients or contaminated material in a health care, hospital, or clinical laboratory setting. SB 2394 is scheduled for a hearing Feb. 4, 2016 at 9:00 AM in the Senate Committee on Commerce, Consumer Protection, and Health in conference room 229. · The flu shot is the most compensated vaccine for vaccine injuries and deaths in the National Vaccine Injury Compensation Program. · According to the CDC, the 2014-15 flu shot was only approximately 19% effective. · Multi-dose influenza vaccines contain thimerosal, a mercury derivative and known neurotoxin. · Flu shots are invasive medical procedures and can induce a range of symptoms including Guillain-Barre Syndrome and anaphylactic reactions. · Many labor unions opposed mandatory flu vaccination for health care workers. · The Cochrane Collaboration concluded, "There is no evidence that only vaccinating healthcare workers prevents laboratory-proven influenza or its complications (lower respiratory tract infection, hospitalisation or death due to lower respiratory tract infection) in individuals aged 60 or over in LTCIs and thus no evidence to mandate compulsory vaccination of healthcare workers". · Physicians, in the American Medical Association Code of Ethics, affirm philosophical and religious exemptions for themselves. Employees should not be discriminated against for choosing not to take a flu vaccine. · Nobody should be forced to have to choose between a flu shot and their job. Comments: Please OPPOSE this bill SB 2316 to force vaccination on any family. The American College of Pediatrics has released a study in January of 2016 regarding the HPV vaccination. Here is one example of problems that have been associated with this vaccine. "Many adolescent females are vaccinated with influenza, meningococcal, and tetanus vaccines without getting Gardasil®, and yet only 5.6% of reports related to ovarian dysfunction since 2006 are associated with such vaccines in the absence of simultaneous Gardasil administration. The overwhelming majority (76%) of VAERS reports since 2006 with ovarian failure, premature menopause, and/or amenorrhea are associated solely with Gardasil®. When VAERS reports since 2006 are restricted to cases in which amenorrhea occurred for at least 4 months and is not associated with other known causes like polycystic ovary syndrome or pregnancy, 86/89 cases are associated with Gardasil, 3/89 with Cervarix™, and 0/89 with other vaccines administered independently of an HPV vaccine.5 Using the same criteria, there are only 7 reports of amenorrhea from 1990 through 2005 and no more than 2 of those associated with any one vaccine type. It is alarming that the state of Hawaii would force vaccination on all of the youth of Hawaii, when the Vaccine Adverse Event Reporting System is rich with many examples of problematic reactions on almost all vaccines. The American Legislative Exchange Council (ALEC) is a right-wing lobbyist group that is pushing this nationwide effort to force vaccination after the success in California. This is Big-Pharma forcing what can be their sale-rack of vaccinations upon our children. The state of Hawaii has bought flu-shots on sale in the past and inoculated our school children with these. I oppose any and all of the forced vaccination bills. While it may be rooted in good intentions, it is a slippery slope toward personal tragedy for a small segments of our population.
