To: The Senate Committee on Commerce, Consumer Protection and Health:

**I urge you to OPPOSE SB 2393.** As a pharmacist, I am highly disturbed that any person can walk up to the pharmacy window and "order" a vaccine--a highly regulated, pharmaceutical, medication, WITHOUT a prescription. Unlike other medications, vaccines do not require the formal process of a doctor's evaluation, a prescription, dispensation from a pharmacy, and a bill to the insurance company. Rather, getting a vaccination can be a personal choice, where a person can independently decide to get almost any vaccine, without following the same protocol as required to get prescriptive medication. The individual can just come up to the pharmacy window and "order" it, almost as easily as a Happy Meal.

Given the heavy regulation on typical FDA approved prescription medications, why is it so easy to get a vaccination when questions regarding efficacy, adverse reactions, and harm have been documented to be far more severe than the tightly regulated prescriptive medications? The most likely answer is that the government, pharmaceutical companies, legislators, individual states, and doctors and anyone who mandates these laws are NOT LIABLE or made accountable for vaccine injuries.

Further, by mandating vaccines and allowing patients to direct their own care, in many cases, it is not good medicine and it can be very dangerous. Of course the pharmacy profession is glad to offer this service, not because it benefits the patient's health and wellness but because vaccines are HIGHLY PROFITABLE. It is always about the bottom line in business, including hospitals, doctor's offices, and pharmacies.

According to the National Vaccine Information Center, the 2015 pediatric vaccine schedule is the following:

- In 1983, there were 23 doses of 7 vaccines required by age 6. In 2015, there are 49 doses of 14 vaccines required by age 6. What will it be in 2020, 55, 60, 65 vaccines before age 6? A baby's immune system is not at full "strength" at birth and continues to develop through childhood. An onslaught of vaccines during this critical time of development is not healthy or necessary. The immune system will eventually break down resulting in autoimmune diseases and chronic inflammation that can last throughout a lifetime.
- Vaccines Carry a Risk of Harm. This is the reason why U.S. Congress passed the National Childhood Vaccine Injury Act in 1986. Since 1988, over \$3 billion dollars has been paid out to vaccine injured individuals or families who lost a child due to an adverse reaction from a



vaccine. In reality, most families do not win compensation even though they experienced a vaccine injury.

- Vaccine Manufacturers Have No Civil Liability. The 1986 law partially shielded drug companies selling vaccines in the U.S. from civil liability and, in 2011, the US Supreme Court completely shielded vaccine manufacturers from liability for FDA licensed and CDC recommended vaccines.
- There is no product liability or accountability for pharmaceutical companies marketing federally recommended and state mandated vaccines that injure Americans or cause their death
- When there is risk of harm from a pharmaceutical product, especially a product that is marketed by companies completely shielded from civil liability, the parent's or individual's right to exercise conscience, religious belief and informed consent on behalf of a minor child or themselves must be legally protected.
- Parental rights, individual informed consent rights, as well as those of a state licensed physician or designated vaccine provider to exercise professional judgment in protecting a child from vaccine injury and death, must be preserved in health policies and laws.

In a more simplistic view:

The government mandates 69 vaccines to our children, while eliminating any form of liability. If the child becomes disabled, experiences lifelong seizures, convulsions, mental or physical regression, autism, or any number of the auto-immune diseases, or even DEATH from one of the vaccinations, there is little recourse. The parent may try to get compensation through the Vaccine Childhood Injury Act, but will be denied as the majority are. As a result, parents are left to take care of a once healthy but now disabled child, only vaccinated in order to protect the child from some rare disease in the first place.

If the US Government is not liable, if the Pharmaceutical companies are not liable, if compensation from the Vaccine Childhood Injury Act is nearly impossible, if Hawaii legislators are not liable, if the State of Hawaii is not liable, then WHO shall be liable for forcing a vaccination on a child who experiences an adverse side effect or some life-long chronic inflammatory illness or disease as a result of the vaccination?

If, as a legislative body, you cannot mandate a person to see the doctor to maintain health, or mandate a person to eat healthy foods or mandate a person take their medication to remain stable, then why should there be a mandate on vaccines for these very same reasons of maintaining health? Even though there are federal recommendations by ACIP, it is clearly printed atop the chart that the Immunization schedule is "**Recommended,**" the obvious reality is that vaccines are not truly recommended at all.

At least in the public sector there is a legal remedy for medical malpractice. Yet, for those few families who have the financial means and emotional strength to relive the events of their vaccine tragedy in court, they rarely win and will have to live with regret for a lifetime. SB 2393 is the first step towards eliminating the parent's rights in protecting their child.

Mandating vaccines for the sake of our health is NEVER truly about our health and safety. This is a bad decision all around. You must OPPOSE SB 2393.

I understand a set of bills have been introduced (HB 1946/SB 2393, HB 1910/SB 2316, HB 1945/SB 2394, and HB 1722) that would **severely restrict freedom of choice** when it comes to vaccination.

Specifically:

- HB 1946 and SB 2393 would require that the state director of health implement rules for vaccine requirements, as they are recommended by the Advisory Committee on Immunization Practices, but do so without any public input.
- HB 1910 and SB 2316 would mandate that all students entering 7th grade in Hawaii receive at least one dose of the HPV (human papillomavirus) vaccine.
- HB 1945 and SB 2394 would mandate health care workers receive a yearly flu vaccine.
- HB 1722 would eliminate the religious belief exemption to vaccination for public school students.

These bills raise a number of concerns for parents, children, and people in general.

Parents have a right to make their own decisions about treatments for their children based on informed consent. Limiting an individual's ability to make informed decisions about what gets put into their body **violates medical ethics and basic personal freedoms**.

I know that the vaccination question is a hotly debated topic, even in the medical community. Many parents are concerned that some vaccines are unsafe because they may contain harmful ingredients like mercury or aluminum. A study published in Current Medical Chemistry in 2011 stated that the "continued use of aluminum adjuvants in various vaccines for children as well as the general public may be of significant concern" because "aluminum presented in this form carries a risk for autoimmunity, long-term brain inflammation and associated neurological complications and may thus have profound and widespread adverse health consequences."

The pharmaceutical companies themselves have acknowledged the dangers of their products. One of the fathers of Merck's vaccine program warned the company that six month olds would suffer dangerous exposure to mercury after being vaccinated. Eli Lilly conducted studies which concluded that thimerosal, the vaccine preservative that contains mercury, was toxic in concentrations as low as one part per million, which is 100 times weaker than the concentration found in some flu vaccines.

To force **anyone** to expose themselves to such risks is unethical.

In addition, others believe the overloading of a young immune system with so many vaccines at once causes genetic changes. Some generally support vaccinations but wish there were more scientific clarity.

However, I think we all can agree that we need to keep information clear, unambiguous, and uncensored, and to **allow people to make informed choices for themselves and their families**--especially when so much information and evidence exists of the possible dangers posed by some vaccines.

Current law protects both my family's health and our right to make our own healthcare choices, and I call upon you to **oppose any legislation that would restrict my, and my family's, freedom of choice when it comes to vaccination.**

Comments: I OPPOSE SB2393 (Please read below carefully) because \*This bill removes doctors, nurses and the individual from the decision-making process. My name is Dr. Leonard G. Horowitz. I am the author of eighteen books and six documentary films dealing with drug industry secrets, bioterrorism risks, genetic engineering firms, and vaccination policies that are risking or damaging public health. I have repeatedly appraised government agents and agencies about the risks of multinational corporations effecting “regulatory capture,” central to Republican Presidential candidate Donald Trump’s concerns about children given too many vaccines; and Democratic contender, Bernie Sanders’ concerns about corporatism destroying America and our capacity to secure government operations for *We The People*. These matters relate directly to SB 2393, that would be best titled, “IMMUNIZATIONS RELATING TO GENOCIDAL IMPOSITIONS BY SPECIAL INTERESTS.”

Reckless, irresponsible, seditious, and treasonous, best describes this railroading of citizens into risky and damaging mandatory intoxications—falsely claimed “safe

and effective.” SB 2393 cedes public trust and scientific discernment to grossly untrustworthy agents and agencies with purportedly no conflicting interests. “The purpose of this Act,” it is claimed, is “the rapid adoption, amendment, or repeal of rules.”

In other words, let’s just trash civility and democracy in favor of corporate fascism, legislative indifference to corporate influence, and potentially lethal administrative processes regarding what shall be injected into citizens’ bodies. These decision shall be henceforth made rapidly, secretly, and exclusively by a handful of foreign regulators outrageously biased in favor of germ theories and genetic engineering, all germ-cult members rabidly opposed to alternative views of disease and healthcare; people who are intolerant to religious beliefs, cross cultural philosophies, conflicting science, and natural medicine. Hail the CDC and members of ACIP that sets the vaccination schedule, such as Rotavirus vaccine patent holder, Dr. Paul Offit--infamous for leveraging his conflicting interests and wildly libeling the honorable Dr. Andrew Wakefield, who Offit and the corporate-controlled media made the poster boy for vicious character assassinations against anti-vaccinationists keen on a controversial publication in the *Lancet*. Therein, Dr. Wakefield and his team simply urged more study of apparent associations between the time of MMR vaccination and groups of children suffering from brain damage and digestive disorders. 
