Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 3031. The purpose of this measure is to authorize the Director of Finance to issue general obligation bonds to finance capital improvements to various irrigation systems. The Department of Agriculture supports the intent of this bill and respectfully offers the following projects for consideration.

1. Molokai Irrigation System Improvements - \$4,000,000 (\$300,000 Design / \$3,700,000 Construction)
2. Lower Hamakua Ditch Improvements, Hawaii – \$2,000,000 (\$250,000 Design / \$1,750,000 Construction)
3. Kahuku Ag Park Improvements, Oahu - \$1,400,000 (\$250,000 Design / \$1,150,000 Construction)
4. Waimanalo Irrigation System Improvements, Oahu - \$3,700,000 (\$400,000 Design / \$3,300,000 Construction)
5. Waimea Irrigation Improvements, Hawaii - \$600,000 (\$100,000 Design / \$500,000 Construction)
6. State Irrigation Reservoir Safety Improvements, Statewide - \$1,000,000 (\$999,000 Design / \$1,000 Construction)

RELATING TO IRRIGATION

Senate Bill No. 3031 authorizes the issuance of general obligation bonds to finance capital improvements to various irrigation systems.

The Department has technical comments on this bill. Federal tax law requires, among other things, that tax-exempt general obligation bond proceeds be used to finance projects/programs that serve public purposes. As it appears that private entities may derive the benefit from this legislation, tax-exempt general obligation bonds cannot be used for this purpose. The State would need to issue taxable general obligation bonds at a higher cost in order to allow the department of agriculture to provide financing assistance to private entities.

In addition, as funding for this program is not in the proposed Executive Budget, should this bill proceed or pass the Legislature, an amount for the corresponding annual debt service will need to be included in the Legislature's version of the budget.

LURF's mission is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of SB 3031**, and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands (IAL) in Hawaii.

SB 3031. This bill authorizes the director of finance to issue general obligation bonds to finance capital improvements to various irrigation systems throughout the State to ensure a dependable supply of water for Hawaii's crops.

LURF's Position. The purpose of this measure is to provide additional funding needed for improvements to irrigation systems State-wide. Since large amounts of prime agricultural lands and irrigation systems became available for conversion to diversified agriculture as a result of the plantation closures in the 1990s, the State has had the opportunity to strengthen and expand Hawaii's diversified agriculture industry. Agricultural lands, however, require significant quantities of water to support and maintain productivity. In order to ensure that local agricultural producers may continue to receive a dependable supply of water for crops, as well as research and development operations, sufficient funding is necessary to improve, repair and maintain Hawaii's irrigation systems.

Local farmers and ranchers who rely on irrigation systems to service their agricultural lands consider such resources critical to conduct their agricultural operations and to sustain their businesses. These agricultural stakeholders believe measures such as SB 3031 will greatly assist by providing funding necessary to make improvements to irrigation systems for the long-term betterment of the State's agricultural industry, and depend on legislation such as this to help them work toward the expansion of diversified agriculture; promote the agricultural self-sufficiency of the State; and to protect water as an important resource.

For the above reasons, LURF **supports SB 3031**, and respectfully urges your favorable consideration.

Aloha Chair Gabbard, Vice Nishihara, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

The Hawaii Farm Bureau strongly supports SB3031, authorizing the director of finance to issue general obligation bonds to finance capital improvements to various irrigations systems.

Since the demise of sugar operations across the islands, we have seen the erosion of irrigation systems. Ditches that carried water fell into disrepair with major leaks in the system, and in cases such as Kau, cracks in tunnels created enough losses that there is no longer significant flow of water. The Legislature continues to advocate for increased self-sufficiency and sustainability. Agriculture must play a key role in the process and for there to be agriculture, water is important.

As time passes, these systems continue to degrade. Timely funding is needed to restore these systems to increase the opportunities for viable farm and ranch operations.

Comments: I agree with HFUU suggestions. This measure will appropriate public funds to repair many of the old "sugar irrigation systems" that dry up our rivers and streams" and move these public trust water resources from one watershed to another (inter-basin transport of water) which are causing serious ecological damage to our stream, estuarine, wetland and nearshore biota. Virtually all of the Hawaii Supreme Court Decisions and Orders regarding Waiahole, Na Wai Eha, East Maui Streams, and Waimea River, Kauai, have or will occur because of the severe dewatering of these streams and rivers. However, as long as the three conditions below are met, at least some of these irrigation systems may warrant repair. Conditions: First all appurtenant water.rights must be fulfilled; No more than 50% of the base flows can be diverted; and No inter-basin transfer of water can be allowed.
