SUBJECT: Senate Bill No. 462, Relating to Firearms Possession


I am Captain Gerald Kaneshiro of the Records and Identification Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD opposes Senate Bill No. 462, Relating to Firearms Possession. This bill requires individuals who are served with a protective order to surrender all of their firearms. Additionally, they are required to provide a sworn statement certifying the disposal of all firearms and ammunition in their possession. Section 134-7 of the Hawaii Revised Statutes currently has provisions for the court to order an individual who is served with a protective order to dispose of all firearms and ammunition within 48 hours.


The HPD is requesting to work with a committee to clarify the amendments as they are written. There are technical issues that may impact this bill due to current procedures in place.

Dear Senators:

On behalf of the Hawaii members of the National Rifle Association, I urge you to oppose Senate Bill 462.

Senate Bill 462 is a clear violation of the 5th Amendment. Citizens who have been denied a firearms permit would be forced to implicate themselves as being unfit to possess firearms and ammunition under the requirement that they provide a sworn statement saying they have surrendered any firearms and ammunition in their possession. SB 462 also takes away law enforcement discretion in determining whether firearms and ammunition should be removed. Currently, the county police “may” require individuals denied a permit to dispose of, or turn in, all firearms within thirty days of denial. This allows Hawaiians the opportunity to challenge any allegations which may be prohibiting them from receiving a firearms permit. SB 462 would change the law to say the county police “shall” collect all firearms and ammunition from individuals denied a permit, eliminating the necessary discretion currently available in cases where an individual needs the opportunity to show a disability does not exist, particularly as it pertains to medical records.

This bill will do little to improve public safety, instead creating additional hurdles for law abiding gun owners. I appreciate your time and ask that you oppose this bill.

Chair Espero and Vice Chair Baker,

Lessons in Firearms Education opposes SB 462.

Recently there have been many instances of legal, law-abiding citizens being denied a firearms permit after prior purchases proceeded normally without a denial. These have been related to medical records that had not previously been disclosed during the aforementioned prior purposes. In some cases it turned out to be old records that had no bearing on the applicant's current condition. Other times it was misinterpretation by non-medical administrative personnel, and in some cases, completely incorrect records.

SB 462 would make seizure of legally purchases and held firearms due to clerical mistakes and erroneous medical records mandatory and remove the discretion of the police when circumstances clearly indicate the applicant is not actually a prohibited person. In addition the time frame for completing the transfer of firearms is not sufficient given how slowly the bureaucratic and legal wheels turn.

We respectfully request you not pass SB 462.

Testimony – I strongly oppose SB462 first and foremost because it clearly violates a citizen's 5th Amendment right, "act of implicating oneself in a crime or exposing oneself to criminal prosecution." SB462 clearly violates the 5<sup>th</sup> Amendment by, "requiring individuals denied a firearm permit or otherwise disqualified from possessing firearms and certain defendants to provide a SWORN statement that the individual has disposed of any firearm and ammunition in the individual's possession."

I also strongly oppose SB462, Section 2. Being denied a permit for future acquisitions shall not affect past acquisitions of firearms and ammunition already in individuals possession.

SB462 should be removed or redrafted.
