In consideration of **SENATE BILL 629** RELATING TO URBAN WATER CONSERVATION

Senate Bill 629 proposes to establish a four-year pilot program under which the Department of Accounting and General Services (DAGS) would implement landscape irrigation water conservation best management practices as established by the Landscape Industry Council of Hawaii (LICH). This measure also appropriates an unspecified amount of funding to DAGS to implement this pilot program. The Department of Land and Natural Resources (Department) supports this measure since it would help preserve Hawai'i's precious fresh water resources, demonstrate government's leadership by example, and reduce water bills – provided that it does not replace or adversely impact priorities indicated in the Executive Biennium Budget.

The landscape irrigation water conservation best management practices (BMPs) established by LICH were developed in close consultation with landscape professionals across the state and are recognized nationally as landscape industry standards. These BMPs are categorized into installation and maintenance practices. The agency cost of implementing installation BMPs in new and renovation projects is not expected to increase significantly over existing practices. Implementation of maintenance BMPs should not cause a substantial increase in operation and maintenance expenses.

In order to facilitate this pilot program, the Department would like to see BMP education and training for agency landscape maintenance supervisors and staff offered by LICH (or other qualified organizations).

Dear Honorable Chair and Members of the Committee;

While I'm in support of the principles of this bill, I find it hard to comprehend that monies need to be appropriated for something that will save money for the users. It's like telling your teenager to drive slower to save gas, then paying them to drive slow, in order to reduce their gasoline bill.

All of the steps outlined in this bill <u>will</u> save money for DAGS and the State of Hawaii. Many of the basic tools that would need to be purchased, such as weather based controllers, have already been installed within the Capitol District. The only cost is to do operate the systems based upon these sound principles which have also been hyped by every water conservation group across the nation and mandated in many areas.

Instead of appropriating monies, this bill should mandate that these Best Management Practices be applied through-out system and appropriate funds only to expand these techniques to all State and Local government properties.

We're not stating every landscape needs to be retrofitted with this equipment today, but the management practices could be implemented immediately, without any cost. Yet will save the State money.

Equipment up-grades can be done as the existing equipment needs to be replaced or when other improvements require replacement.

The State of Hawaii needs to follow the example set Hawaii's Military (Navy, Army, Marines and Coast Guard) in Hawaii and implement these practices today. In the case of the Navy, they did up-grade their control systems at Joint Base Hickam Pearl Harbor, but the capital expenditure for those improvements were paid for within 2 to 3 years in water savings alone.
