SENATE CONCURRENT RESOLUTION NO. 129
ENCOURAGING THE DEPARTMENT OF AGRICULTURE TO ADOPT STANDARDS
ESTABLISHED BY THE TEA INDUSTRY TO DEFINE GEOGRAPHICAL REGION
DESIGNATIONS FOR TEA GROWN IN THE STATE

Chairperson Gabbard and Members of the Committee:

Thank for the opportunity to testify on Senate Concurrent Resolution No. 129, encouraging the department to adopt standards established by the tea industry to define geographical region designations for tea grown in the state. The department supports the intent and offers comments.

"Geographic indications" are defined by the World Trade Organization (WTO) as originating in the region or locality in that territory where a given quality, reputation or other characteristics of the good is essentially attributable to its geographic origin, such as "Idaho" for potatoes. Geographic indications can be considered as a subset of trademarks. A geographic name alone is not registerable as a trademark. However when used with an acquired distinctiveness it can be registered as a certification mark under the U.S. Patent and Trademark Office (USPTO). The certification mark is used to inform purchasers that the goods meet certain qualifications or standards. Placing of the mark on goods constitutes a certification by someone other than the producer that the prescribed characteristics or qualifications of the certified for those good have been met.

Tea is not currently defined as an agricultural commodity under Chapter 147, Hawaii Revised Statutes. If the intent is to adopt standards to define geographic region, as a certification mark, similar to Hawaii-grown coffee, the department currently does not have the authority to do so.



We applaud the legislature's efforts in assisting the tea industry. The department looks forward in working with the tea industry to achieve this goal.

Comments: Onomea Tea Company supports resolution SCR129. Tea could be an important crop for Hawaii and requiring proper labeling of geographical source is essential to the growth of the industry here. Currently, companies can buy tons of low quality tea that is grown outside of Hawaii, and very cheaply. They can blend it with fruit or fragrance (not even made in Hawaii), and maybe even throw in a handful of Hawaii Grown Tea and then call it 'Hawaiian'. This practice is not only deceitful but it also diminishes both the value and quality of the Hawaii Label. The Hawaii Tea Industry is only possible because of the advent of 'Specialty Teas', which are of higher quality than commodity teas. The consumer interest in these higher quality specialty teas is growing every year. The cost of farming in Hawaii is very high. We cannot compete in the commodity Tea Market because of labor and other costs here which are significantly higher that many other countries where tea is grown. However, Hawaii Teas have been proven, over and over, to fall into the category of Specialty, Higher Quality, Teas and we can get a higher price for them. Hawaii can compete in the Specialty Tea market. The only way for the Hawaii Tea Industry to grow is to legislate rules that require true and accurate labeling of where the Tea is grown. At the very least it must be required that if the Hawaii, or Hawaiian, label is on the packaging that the tea is, in fact, grown in Hawaii. Using 'Hawaii' or 'Hawaiian' on the label adds value in the minds of the consumer to the product. Hawaii tea Growers want to encourage this perception by actually producing high quality Tea. If we allow cheaper, 'flavored' teas, to use the Hawaii labels, then this could damage the perception not only for Hawaii Tea, but also for all Hawaii products. Please support our Hawaii Tea Farms and encourage more potential growers to be committed to producing high quality teas. The words Hawaii or Hawaiian on Tea labels should be reserved strictly for Tea that is actually grown in Hawaii. Above all it is a matter of honesty. The public is never happy about being deceived.
