## Dear Senator Gabbard:

The Hawaii State Senate has acknowledged the value of Kaanapali Beach to the Island of Maui and State of Hawaii via passage of SB 497 Relating to Beach Nourishment. SB 497 funds one half of an \$800,000 project budget for planning and permitting of a beach nourishment project to protect Kaanapali Beach.

The beach nourishment project proposes to add approximately 75,000 cubic yards of sand to Kaanapali Beach as a longer term shoreline protection action.

SCR72, SR43 & HR19 resolve to encourage the Department of Land and Natural Resources to allow for agressive, but temporary protection of the Kaanapali Beach Walk while the work planned by SB 497 can be completed.

I urge you to support the interim protection of the Kaanapali Beach Walk while the larger beach nourishment project can be completed.
