Chair Baker and Members of the Committee:

Good morning Chair Baker and members of the Committee, my name is Charlotte Carter-Yamauchi and I am the Acting Director of the Legislative Reference Bureau. Thank you for providing the opportunity to submit written comments on S.C.R. No. 74, Urging the Legislature to Convene a Working Group to Research, Discuss, and Make Recommendations Regarding Edible Medical Marijuana Products.

The purpose of this measure is to:

- (1) Urge the Legislature to convene a working group to research, discuss, and make recommendations for legislation regarding edible medical marijuana products;
- (2) Request that the working group meet a minimum of four times before January 1, 2017, to discuss:
  - (A) New medical marijuana edible products, including drinks, for patients;
  - (B) Packaging for medical marijuana edible products;
  - (C) Best practices in other states;
  - (D) Quality control and potency of medical marijuana edible products; and
  - (E) Any other pertinent issue relating to medical marijuana products that may be sold at medical marijuana dispensaries;

- (3) Request that the working group meetings be open to the public and include a segment for public comment;
- (4) Request the Legislative Reference Bureau to assist the working group with research, notetaking at meetings, provide minutes of meetings, and prepare the working group's final report; and
- (5) Request that the working group report its findings and recommendations, including any proposed legislation, to the Legislature no later than January 1, 2017;

While the Legislative Reference Bureau takes no position on the measure, we submit the following comments for your consideration.

With the enactment of the medical marijuana dispensary law just last year and the actual operation of such dispensaries still months away, it seems premature at this time to delve into expanding the scope of medical marijuana products that may be dispensed even before the actual dispensing of medical marijuana has commenced. It may be more prudent to either: delay expansion discussions until Hawaii's medical marijuana dispensing system has been operating for six months or more, to allow for the collection of actual data and information therefrom; or statutorily provide the Department of Health with rulemaking authority to expand the medical marijuana products that may be dispensed, after a series of public hearings.

In addition, with regard to the request that the Bureau assist the working group with research, take notes at meetings, provide minutes of meetings, and prepare the working group's final report, we note that, for 2014 medical marijuana dispensary task force, the nature of assistance requested of the Bureau appropriately involved only research, report writing, and bill drafting services. We further note that the complex nature, broad scope, and contentious debate on this issue in the past necessitated the assignment of two Bureau Research Attorneys to handle that heavy workload. If the Legislature deems it appropriate to require that the Bureau be responsible for these other ministerial tasks associated with this working group, the assumption of these responsibilities will most likely adversely impact the Bureau's ability to conduct other research activities for the Legislature and its members during the interim.

Dear Chair Baker, Vice Chair Kidani and Committee Members:

The Drug Policy Forum of Hawai'i (DPFHI) **strongly supports** this resolution urging the legislature to convene a working group to research, discuss and make recommendations regarding edible medical cannabis products. HRS 329D-10(7) would allow the Department of Health to permit additional types of manufactured products, but they chose not to do so when they issued their interim administrative rules in late 2015. Indeed, it fell upon the legislature to propose the addition of three new important products (“transdermal patches, marijuana cigarettes and prefilled containers” for inhaling) via HB2707 HD1 SD1, legislation that recently passed out of this committee. Accordingly, we find it more likely that the needed edibles would be added via statute, and that the proposed working group in this bill could guide the way forward.

Edibles provide long-lasting relief and are often the only alternative for those who cannot smoke or inhale their medicine. Unfortunately, there is a lot of misinformation available about medical cannabis edibles out there. The media has been quick to sell copy with [stories of Halloween cannabis candies and more, yet these have all been debunked](#). Rather than be guided by fear, we need to recognize that [this product is potent and needs safe handling](#). Simultaneously, it also demonstrably helps the very patients that the legislature targeted when it first created medical cannabis registry in 2000, and then again last year when it followed up with the medical cannabis dispensary system. As with all medication, safety goes hand in hand with regulation.

We would be honored to be part of this working group, but humbly suggest the addition of the Hawai'i Dispensary Alliance (a trade association) and the Medical Cannabis Coalition of Hawai'i (a patient support network).

Kush Bottles Hawai'i (KBH) **strongly supports** this measure (SCR 74) to urge the legislature to convene a working group to research, discuss, and make recommendations regarding edible medical marijuana products.

As the consumption of edible products surpasses the smoking of dried flowers as a preferred or healthier method of medication, dispensaries in other states are accommodating these patient demands. This working group will research and discuss the following:

**1. List of medical marijuana edible products, including drinks, for patients:**

Rice Crispy Treats, Lollipops, Hubby Bars (Chocolate and Hash Oil), Caramels, Fudge, Butter, Lemonade, Peanut Butter, Chocolate Bars, Chocolate-Covered Pretzels, Brownies, Chocolate Truffles, Cinnamon-Blueberry Muffins, Peanuts, Agave Nectar, Sugar-Free Hard Candy, Lozenges, Coffee, Oatmeal Raisin Cookies, Taffy, Hard Candy, Vegan Peanut Butter Cups, Ice Cream, Olive Oil, 'Bop Bop' Ice Cream Sandwiches, Bacon Cheddar Biscuit, Savory Pretzels, Chocolate-Hazelnut Spread, and many more...

**2. Packaging for medical marijuana edible products:**

“Colorado’s Packaging and Labeling Requirements for Retail Marijuana for Consumer Protection and Child Safety”

Colorado has regulations for medical marijuana and now for retail marijuana. Colorado’s new Retail Marijuana Code covers three types of products: Marijuana, marijuana products including edible products, and marijuana concentrates. Before sale to a consumer, a retail marijuana store must place any of these products in a container that is child-resistant or place the container in an “exit package” that is child resistant. “Child resistant” packaging must conform to federal consumer product safety regulations and an ASTM standard; be opaque so the product cannot be seen; be closable if not intended for single use; and be properly labeled pursuant to the Retail Code. Proper labeling includes specific warning statements for each of



the three product types; Colorado's Universal Symbol indicating the container holds marijuana; a list of all nonorganic pesticides, fungicides and herbicides used to produce the marijuana; and a list of solvents and chemicals used to produce marijuana concentrate. Use of certain pesticides and chemicals is prohibited. Containers for edible marijuana products must be labeled with all ingredients, if refrigeration is required, standard serving limit and expiration date. Other statements are required if testing was performed for potency or contaminants. Keep all marijuana products away from children, especially if they are edible and look like candy or snacks!!

### **3. Best practices in other states:**

As a comparative policy analysis in reference to the twenty-three states (and the District of Columbia) that currently allow access to medical marijuana (Alaska, Arizona, California, Colorado, Connecticut, Delaware, Hawaii, Illinois, Maine, Maryland, Massachusetts, Michigan, Minnesota, Montana, Nevada, New Hampshire, New Jersey, New Mexico, New York, Oregon, Rhode Island, Vermont, Washington), selected specific language is available pertaining to edible/manufactured products, packaging/labeling, and quality control/potency.

### **4. Quality control and potency of medical marijuana products:**

Based on this current vertically integrated market, various solutions exist to create oversight that can virtually guarantee superior quality and potency of medical marijuana products. These solutions can be discussed and researched within this working group.

### **5. Any other pertinent issues relating to medical marijuana products that may be sold at medical marijuana dispensaries:**

As technology and patient preferences shift toward personal electronic vaporizing devices, the medical cannabis industry will face similar packaging and safety issues concerning the electronic cigarette industry.

“Kush Bottles Becomes First in Nation to Offer CPSC Certified Packaging for the Electronic Cigarette Industry”

President Obama recently signed into law new regulations that require child-proof packaging for e-cigs. Manufacturers and sellers of electronic cigarettes will be required to use child-resistant packaging for liquid nicotine containers.

The Child Nicotine Poisoning Prevention Act, which was sponsored by Sen. Bill Nelson (D-Fla.), requires that liquid nicotine must be sold in child-proof bottles. The Act expands a patchwork of laws in an effort to protect children from this serious poisoning threat.

"A few drops of this stuff can cause a child to become extremely ill," said Sen. Nelson. "Requiring child-proof caps on these bottles is just common sense."

The number of child poisonings from nicotine has climbed dramatically in recent years, from 271 cases in 2011, to 3,783 cases in 2014, according to the American Association of Poison Control Centers.

Comments: After sixteen years of opposition, fear-mongering, and delay, it's beginning to seem more likely that safe access to medical marijuana may finally become a reality for patients in Hawaii. Forty states across the country now allow some form of legal marijuana, so it's about time! Considering the state's unreasonably slow and overly cautious approach, it wasn't a surprise to learn that the scope of products permitted in Hawaii's medical marijuana dispensaries, when they eventually begin operating, is extremely limited. A good dispensary should provide a wide variety and good selection of medicine ... for smoking, vaporizing, topical application, and ingesting. Each product has its own specific advantages. Edible marijuana products may be a healthier alternative to inhaling smoke. For some patients, such as those using supplemental oxygen, smoking is not an option. For others, the fast-acting effects of smoking or vaporizing (which is absorbed directly into the bloodstream via the lungs) may wear off too quickly and they might need repeated doses to manage symptoms, while an edible product (processed via the digestive system) can provide more gradual onset but longer-lasting relief. The state should not dictate how a patient takes their medicine. I strongly support SCR 74 / SR 45 - the Senate Resolution urging the Legislature to convene a working group to research, discuss, and make recommendations regarding edible medical marijuana products.
