Mahalo for the opportunity to testify. I am Walter Yoshimitsu, the executive director of the Hawaii Catholic Conference which is the public policy voice of the Roman Catholic Church in the State of Hawaii. Given the scientific fact that a human life begins at conception, the only moral norm needed to understand the Church's opposition to abortion is the principle that each and every human life has inherent dignity, and thus must be treated with the respect due to a human person. We simply cannot celebrate an organization that promotes and profits from the taking of an innocent life.

In 2010, Planned Parenthood Federation of American (PPFA) announced that by 2013 every affiliate must have one or more clinics that perform abortions on-site. Planned Parenthood provides 16 times more abortions than birth-oriented services.

While PPFA says abortions make up only 3% of its services, this is misleading. PPFA's annual report for 2014-2015 indicates that it served 2.7 million patients (women and men) and performed 327,653 abortions, indicating that 12% of everyone entering a Planned Parenthood clinic receives an abortion. And PPFA provided only 18,684 "prenatal services" and 1,880 referrals for adoptions at other agencies. So 94% of its services for pregnant women are abortions, outnumbering other options 16 to 1%.

Promoting life from conception until natural death is the foundation for the Church's social doctrine, including its teachings on war, the use of capital punishment, euthanasia, health care, poverty and immigration. Please defer these resolutions. Mahalo for the opportunity to testify.

Recognizing that having a trusted adult with whom to discuss sexual health issues is a strong protective factor against unplanned pregnancy and STIs, Planned Parenthood conducts training for parents that empowers them to discuss these important issues with their children. Most parents believe it is important to discuss sexual health with their children, but many feel unprepared to do it. These workshops help parents share their values and beliefs with their children and improve family communication.

Thank you for the opportunity to share my concerns about SR56. I oppose this measure and encourage you to do the same.

- 1. Do you realize that if your parents would have bought into the Planned Parenthood message that you would likely not be reading this right now? This measure speaks a lot about health care, but the reality is that Planned Parenthood is the leader in abortions every year in our country. An abortion destroys (sadly and quite literally) a child, and hurts the mother and the father. This is "health care" our great State should not affirm.
- 2. The measure states, "WHEREAS, since 1993, there have been eleven murders of individuals associated with abortion care. . ." 3. The measure states, "WHEREAS, Planned Parenthood offers cancer screenings, pregnancy testing and counseling, testing and treatment for sexually transmitted infections, comprehensive sexual health education, preventive health care services, birth control for men and women, emergency contraception, and abortion services; and..." I am thankful for any care that Planned Parenthood does provide. When you take time to research Planned Parenthood what you largely find, is the opposite. Planned Parenthood is driven by the multibillion dollar abortion industry. The services they provide are paid for in dollars, either from the government or payment for the service itself. Abby Johnson, who used to work for Planned Parenthood and even was named the Planned Parenthood worker of the year, validates what I am saying here. Read any of her material online.

Comprehensive Sex Education (CSE) is what Planned Parenthood has pushed into our Hawai'i D.O.E. schools. Four of the five sex ed curriculums are CSE based. CSE has proven to sexualize our keiki, encourage them to become more sexually active, begin experiencing sex at an earlier age and more. All of these consequences put our keiki at greater physical, mental, emotional, and spiritual risk. This is "sexual health education" that our great State should not affirm. We need to recognize that Planned Parenthood pushes CSE because it will fuel their "services" and make them more money.

I strongly oppose SCR 85 and SR 56. These resolutions appear to misrepresent Planned Parenthood as a "trusted health care provider". Planned Parenthood is the nation's largest abortion provider and has been plagued by scandal and abuse. Although it advertises itself as an organization promoting health for women and families, this politically well-connected abortion industry invests much of its resources in obtaining tax dollars to support their number one product: abortion, not health services. SCR 85 and SR 56 denounce the violence towards abortion providers, but fail to mention the atrocity of a death toll of over 3,000 babies killed daily by abortion and over 57 million since 1973.

SCR 85 and SR 56 suggests that the "series of manipulated and misleading videos" along with "politically motivated and misguided investigations have failed to reveal any wrongdoing by Planned Parenthood". Yet, a diligent review of these investigations have revealed several human rights violations that surfaced uncovering Planned Parenthood's baby body parts trafficking. It has been well known over the years that a standard practice of this worldwide abortion industry is harvesting of baby body parts because of the demand for fetal tissue for research, for cosmetics and beauty treatments and even harvesting fetal cells for vaccines. - In the seventh and perhaps most disturbing video: Holly O'Donnell described the harvesting, or "procurement," of organs from a nearly intact late-term fetus aborted at Planned Parenthood Mar Monte's Alameda clinic in San Jose, CA. "'You want to see something kind of cool," O'Donnell says her supervisor asked her. "And she just taps the heart, and it starts beating. And I'm sitting here and I'm looking at this fetus, and its heart is beating, and I don't know what to think."
- In the eighth video: StemExpress CEO Cate Dyer admits Planned Parenthood sells "a lot of" fully intact aborted babies.
- The ninth video: catches a Planned Parenthood medical director discussing how the abortion company sells fully intact aborted babies — including one who "just fell out" of the womb.
- The 10th video: catches the nation's biggest abortion business selling specific body parts including the heart, eyes and "gonads" of unborn babies. The video also shows the shocking ways in which Planned Parenthood officials admit that they are breaking federal law by selling aborted baby body parts for profit.
- The 11th video catches a Texas Planned Parenthood abortionist planning to sell the intact
 heads of aborted babies for research. Amna Dermish is caught on tape describing an
 illegal partial-birth abortion procedure to terminate living, late-term unborn babies
 which she hopes will yield intact fetal heads for brain harvesting.
- Unreleased Videos: Unreleased videos from CMP show Deb Vanderhei of Planned
 Parenthood caught on tape talking about how Planned Parenthood abortion business
 affiliates may "want to increase revenue [from selling baby parts] but we can't stop
 them..." Another video has a woman talking about the "financial incentives" of selling
 aborted baby body parts.

These videos show a despicable, callous disregard for the law, human life and women. The selling of baby body parts is against the law and Planned Parenthood knows it which is why they have filed huge expensive lawsuits to silence the undercover videographers. Planned Parenthood also knows that it has a public relations nightmare on its hands and it is doing its utmost to try to preserve what had been its carefully crafted public image. Planned Parenthood likes to claim that these horrific videos have all been "edited" however, you should know that all of them have been released in unedited form. There is no getting around the things that have actually been said by multiple Planned Parenthood executives.

In fact, "the full, unedited videos have confirmed that revelations that some aborted baby remains sold by Planned Parenthood go to biotech companies for the purpose of creating "humanized" mice." It has also been reported that "Planned Parenthood has been exposed as having sold body parts from aborted babies for as much as 15 years."

Though they continue to deny any wrong-doing and many in the media echo the abortion group's talking points, the truth is that since the release of the Center for Medical Progress videos, Planned Parenthood has been under increased scrutiny by state and federal authorities. There are at <u>least eight states</u> where Planned Parenthood has been held accountable for violations of the law. Instead of affirming and supporting this organization, there should be legislation to redirect taxpayer funds to health care groups that provide comprehensive care to families. American taxpayers must not be forced to fund Planned Parenthood's abortion empire and is many abuses, including the illegal profiting from the sale of baby body parts and the horrific practice of allowing infants that are born alive to die so that their organs can be harvested.
