The Department of Education (Department) supports community engagement in our schools and welcomes the opportunity for our schools to be community centers. When it comes to School Food Services, the Department's main focus is to serve nutritious meals at the lowest cost to our school families. The Department's ability to maximize its facilities, equipment, and personnel allow the Department to keep meal costs down. Turning Keaukaha Elementary School's kitchen back to a full service site will increase costs in both staffing and equipment. This is at a time when the Department has been asked to look for efficiencies and reduce costs. Additionally, there are new food regulations that if breached can jeopardize the placard status of a kitchen, potentially leading to its closure. The Department is currently working on a policy that will require certified food service workers present during off-hours operations. Therefore, while we understand and are looking for ways to meet community requests, we are concerned that the increase in costs associated with opening an additional preparation site would impact the overall costs associated with meal prices.

I respectfully submit testimony relating to

**SR105 and SCR143: REQUESTING THE DEPARTMENT OF EDUCATION TO PROVIDE EQUIPMENT NECESSARY FOR A FULL-SERVICE CONVENTIONAL KITCHEN AT KEAUKAHA ELEMENTARY SCHOOL AND TO PROVIDE NECESSARY POSITIONS TO OPERATE THE KITCHEN**

In 2010, I joined a group of Keaukaha Community leaders and stakeholders to lobby the Abercrombie administration for a new cafeteria when it became evident that our 60+ year old kitchen could no longer accommodate our school's growing population. During the interim, the DOE reallocated our Food Service positions to other Hilo area schools and our keiki's meals were delivered in from Hilo Intermediate School. Needless to say, this was an unacceptable alternative for us; meal delivery was challenged during sewer repairs and Hilo Harbor construction along the main thoroughfare to Keaukaha causing frequent traffic delays with the food arriving late and cold.

When our beautiful new facility opened last summer, our elation was dampened by the news that our keiki's meals would still be delivered because there were no funds to properly equip and staff the new cafeteria. I fail to see the irony in this; most of the equipment were either initially installed or the necessary "tie-ins" for other anticipated equipment were completed. But, more importantly, we seek your assistance in helping us recoup the Meal Service positions and return them to Keaukaha Elementary School so that our children's meals no longer need to be delivered in.

Good Afternoon,

My name is Andrea Aguiar. I am a teacher at Keaukaha Elementary School. Thank you for the opportunity to share my testimony. I am in favor of SCR 143/SR105, which requests the DOE provide the equipment necessary for a full-service kitchen at our school and positions necessary to operate the kitchen. As I continue, I will share with you my reasons for supporting this resolution.

Students at our school are served twice a day for breakfast and lunch. 82.8 percent of our students receive free and reduced lunch. For most of the students at our school these are the only meals that they eat daily. As it stands our school gets our meals from Hilo High School. The challenges have really affected our students during their school day. Students have had to wait in some circumstances to eat lunch because lunch has been delayed in traffic or accidents, or items were forgotten and the lunch van needed to go back to get it. In these cases, students were very hungry and were left with empty stomachs until the food arrived. It saddens me to see this continue to occur.

If the kitchen is made into a full-service kitchen these situations will not happen, the kitchen could also be rented out to the community to be used for many functions to support the keiki of our community. It could also be used to teach students life skills such as the real-life (hands-on experiences) of how to cook and how our food is made and allow them to be more involved in the process.

All things considered, why would we have a beautiful new facility that we will not be able to fully use?

SR105 / SCR 143 – Requesting the Department of Education to Provide Equipment Necessary for a Full-Service Conventional Kitchen at Keaukaha Elementary School and to Provide Necessary Positions to Operate the Kitchen

Aloha! Senator Kidani, Senator Harimoto, and Education Committee members. My name is Debbie Coloma, and I am the School Administrative Services Assistant at Keaukaha Elementary School. I have been in this position since 1999. During my continuous tenure here at Keaukaha Elementary, we had a Full-Service Conventional kitchen at our school from the day it opened in September, 1930, up until July, 2010 when School Food Services made a decision as a Cost Savings to the department, to consolidate its operations in the Hilo-Laupahoehoe-Waiakea Complex Area (now known as Hilo-Waiakea Complex).

At that time, Keaukaha Elementary cafeteria was converted from a full-service preparation kitchen into a serving kitchen. The cafeteria staff of our Keaukaha Elementary ohana, were reassigned under the consolidation with Hilo Intermediate School. All food preparation took place at Hilo Intermediate with meal delivery to Keaukaha Elementary. My testimony is in Full Support of SR105 and SCR143.

1. The cost savings to the department was warranted however, within the Hilo-Waiakea Complex, Hilo Intermediate School is in close proximity of two other schools, Hilo High and Hilo Union. The distance from Hilo Union to Hilo Intermediate is 0.1 miles. The distance between Hilo High and Hilo Intermediate is 69 feet. The distance between Keaukaha Elementary and Hilo Intermediate School is approximately 3.8 miles.
2. Mathematically speaking, the consolidation should have been a simple solution to consolidate schools that were in close proximity of each other rather than an “outerlying” school. These three schools, Hilo High, Hilo Intermediate, and Hilo Union all have Full-Service Conventional Kitchens. Is this a cost savings?

3. In July, 2015, Keaukaha Elementary celebrated the opening of the newly built Keaukaha Elementary cafeteria which is a state-of-the-art facility with the infrastructure already built-in to accommodate the transition from a serving kitchen to a full-service conventional kitchen. We need your support to make this transition into a reality by purchasing the equipment necessary to complete our kitchen.
4. Not only will we need the equipment, we will also need the personnel to utilize the equipment and operate our cafeteria to prepare fresh meals for our keiki. The positions that are necessary, at minimum to run a full-service kitchen are a School Food Service Manager, a Cook, a Baker, and Cafeteria Helpers. We historically have had a total of five cafeteria positions based upon our student population thus; due to the increases in student enrollment, we may need additional support however, we will graciously accept your offers.
5. It is my firm belief that bringing Keaukaha Elementary School Cafeteria to its fullest potential in making it a Full-Service Conventional kitchen will not only be an asset to our keiki, but to our entire Keaukaha and extended community as our school is the piko or center of Keaukaha.

I passionately and full heartedly express my unending support of this resolution and concurrent resolution for it is said, "It takes a village to raise a child." What better way to nurture our children with fresh wholesome cooked food? I thank you for this opportunity to express my support of SR105 and SCR143. Mahalo!

Chair Kidani, Vice Chair Harimoto and members of the Senate Committee on Education,

Thank you for the opportunity to testify, as a member of the community, in support of SCR 143 and HR 105. My name is Dwight Takamine and I was fortunate to have been a member of the Legislature when funding for the new Keaukaha Elementary School Cafeteria was added to the State Budget. At that time, Keaukaha was part of the Senate District that I represented.

After the funding had been approved, a question arose over whether the Cafeteria would be a **“full service”** cafeteria where food would be **“both prepared and served”**. The Department of Education had, on its own, decided that food would be prepared at another school in Hilo and then would be trucked to Keaukaha, as part of a plan to save money.

This became an important issue because Keaukaha Elementary School is the “heart” of the Keaukaha community. Many programs like their Keaukaha reunions would be held at the school, and all of their community meetings would be held at the school cafeteria. As a rural community there were few resources available, and therefore, the importance of the school cafeteria’s ability to prepare food and other refreshments took on greater meaning in supporting community events.

This was the “legislative intent” when the funding was included in the state budget – that the new Keaukaha Elementary School Cafeteria would continue to play the role of supporting both the school and community by continuing to be a “full service” cafeteria.

In light of the ongoing dispute between the Keaukaha community and the State Department of Education, the Legislature’s support was sought in 2011. At that time, the State Legislature passed what became Act 164, which made explicitly clear that funding for the new Keaukaha Elementary School Cafeteria would include,

**“a full service , conventional kitchen to both prepare and serve food”** (Act 164 Session Laws

of Hawaii 2011, Part V. Capitol Improvement Provisos, Section 65)

Common sense dictates that this would include the staffing positions and equipment necessary to “prepare and serve food”.

Therefore, your support of these resolutions and any other steps that may be consistent with implementing the full measure of “**legislative intent**” (in this instance) would be appreciated.

Aloha! Senator Kidani, Senator Harimoto, and Education Committee members. My name is Patrick L Kahawaiolaa and I am the current president of the Keukaha Elementary School SCC and the president of the Keukaha Community Association. I have been in this position at KCA since 1999 and the SCC since 2013. We had a Full-Service Conventional kitchen at our school from the day it opened in September, 1930, up until July, 2010 when School Food Services made a decision as a Cost Savings to the department, to consolidate its operations in the Hilo-Laupahoehoe-Waiakea Complex Area (now known as Hilo-Waiakea Complex) while a new cafeteria was being rebuilt.

At that time, Keukaha Elementary cafeteria was converted from a full-service preparation kitchen into a serving kitchen. The cafeteria staff of our Keukaha Elementary ohana, were reassigned while a new cafeteria was under construction is when the consolidation with Hilo Intermediate School began. All food preparation took place at Hilo Intermediate with meal delivery to Keukaha Elementary. Our testimony is in Full Support of SR105 and SCR143.

1. The cost savings to the department was warranted however, within the Hilo-Waiakea Complex, Hilo Intermediate School is in close proximity of two other schools, Hilo High and Hilo Union. The distance from Hilo Union to Hilo Intermediate is 0.1 miles. The distance between Hilo High and Hilo Intermediate is 69 feet. The distance between Keukaha Elementary and Hilo Intermediate School is approximately 3.8 miles.
2. Mathematically speaking, the consolidation should have been a simple solution to consolidate schools that were in close proximity of each other rather than an “outerlying” school. These three schools, Hilo High, Hilo Intermediate, and Hilo Union all have Full-Service Conventional Kitchens. Is this a cost savings?

3. In July, 2015, Keaukaha Elementary celebrated the opening of the newly built Keaukaha Elementary cafeteria which is a state-of-the-art facility with the infrastructure already built-in to accommodate the transition from a serving kitchen to a full-service conventional kitchen. We need your support to make this transition into a reality by purchasing the equipment necessary to complete our kitchen.
4. Not only will we need the equipment, we will also need the personnel to utilize the equipment and operate our cafeteria to prepare fresh meals for our keiki. The positions that are necessary, at minimum to run a full-service kitchen are a School Food Service Manager, a Cook, a Baker, and Cafeteria Helpers. We historically have had a total of five cafeteria positions based upon our student population thus; due to the increases in student enrollment (420+), we may need additional support however, we will graciously accept your offers.
5. It is my firm belief that bringing Keaukaha Elementary School Cafeteria to its fullest potential in making it a Full-Service Conventional kitchen will not only be an asset to our keiki, but we may be able to accommodate our culturally based public charter school Ke Ana Laahana of an additional 50 students, but to our entire Keaukaha and extended community as our school is the piko or center of Keaukaha.

We passionately and full heartedly express my Strong support of this resolution and concurrent resolution for it is said, "It takes a village to raise a child." 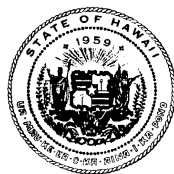

My name is Stacey Bello and I am the principal of Keaukaha Elementary School, located on the Big Island.

I am writing to you in full support of both resolutions presented to the Senate Committee of Education on behalf of my school. In 2015, Keaukaha Elementary opened an eight million dollar cafeteria, which currently serves as a dining room. The entire cafeteria is not yet complete since our kitchen requires additional equipment to be fully functional. The new facility already has the infrastructure built-in to accommodate a full service conventional kitchen. We are looking to finish what was started.

At the present time, meals are delivered to our school for breakfast and lunch. There were several times, during this school year alone, when we didn't have enough food to feed our students. As a result, students needed to wait for additional food to be delivered. This shortage caused students to miss their recess times and most importantly, valuable instructional time that ranged between 10-40 minutes.

In addition to completing the kitchen, we will also need the cafeteria positions returned to our school since these positions were removed from our school about five years ago. This cafeteria staff would fall under my direct supervision. A fully functional kitchen and staff will allow us the opportunity to provide meals for our neighboring schools and avoid food shortages that have impacted student learning time.
