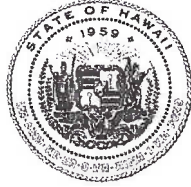

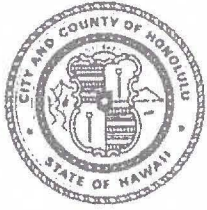

The Department of Transportation (DOT) **opposes** these resolutions which requests the DOT to work with the City and County of Honolulu, Department of Transportation Services to develop and implement a traffic mitigation plan to address the current Aiea-Red Hill-Moanalua-Salt Lake congestion as well as additional future congestion after the completion of the Moanalua Hillside Development.

The DOT is currently developing a H-1 Corridor Study, which will be completed by the end of summer. The H-1 Corridor Study would provide the information requested by this resolution and can be shared once the study is complete.

Additionally, since this effort would include both State and City involvement, the DOT is not the appropriate lead agency. Should an additional study be pursued, the DOT recommends that it be done by the Oahu Metropolitan Planning Organization (OahuMPO) in accordance with the transportation planning process. It is the role and responsibility of the OahuMPO to develop transportation studies that include both State and City roads and as such they would facilitate participation between the various jurisdictions involved.

Dear Chairs Inouye and Nishihara, and Committee Members,

Thank you for the opportunity to submit testimony in support of Senate Concurrent Resolution ("SCR") 94 and Senate Resolution ("SR") 61, requesting that the Department of Transportation work with the Department of Transportation Services to develop a traffic mitigation plan to address the current Aiea-Red Hill-Moanalua-Salt Lake congestion, and additional future congestion after the completion of the Moanalua Hillside Development, and to enable timely funding for the implementation of that plan, respectively.

As the Honolulu City Councilmember representing this gridlocked area delineated in these resolutions, I can attest that traffic congestion is the most burdensome problems our constituents face in this area. It subjects residents to increased travel time, increased fuel costs, and a significant loss of quality of life. The inadequate infrastructure of the H-1 in this area is specifically highlighted in the 2015 American Highway Users Alliance's Report, which indicates that the Moanalua Freeway (at Ala Kapuna Street) has one of the greatest amounts of congestion in the State, with annual delays totaling 607,100 hours. The Aiea-Red Hill-Moanalua-Salt Lake area hosts thousands of Central and Leeward Oahu commuters, as well as those traveling in from Windward Oahu, demonstrating the significant and disproportionate burden the area shoulders and the crucial need for infrastructure improvements.

I encourage the Senate Committees on Transportation and on Public Safety, Intergovernmental, and Military Affairs to act favorably on SCR 94 and SR 61, respectively; and to support any additional measures addressing similar issues during this year's legislative session. Mahalo for your consideration.

Chairs Inouye and Nishihara, Vice Chairs Gabbard and Espero, and Members of the Committees:

The Chamber of Commerce Hawaii ("The Chamber") **strongly supports** SCR 94/SR 61, which requests the Department of Transportation to work with the Department of Transportation Services for the City and County of Honolulu to develop a traffic mitigation plan to address the current Aiea-Red Hill-Moanalua-Salt Lake congestion as well as additional future congestion after the completion of the Moanalua Hillside Development, and to enable timely funding for the implementation of that plan.

Comments: We oppose this resolution on the basis of Mr. Ed Sniffen's remarks to the media m, on 3-23-16 (Hawaii News Now), following the deferment of their bill to subject the Hawaii Tax Payers to a triple tax increase on gas, vehicle registration & vehicle weight. Mr. Sniffen has already stated that because DOT cannot get the tax increases that his focus will only be on "preservation and safety" & that if he can't maintain the new roads he won't build it. This resolution goes against what Mr. Sniffen has stated publicly and we'll be monitoring Mr. Sniffen's threat to cancel the extra lane expansion for the Wai'anae district.
