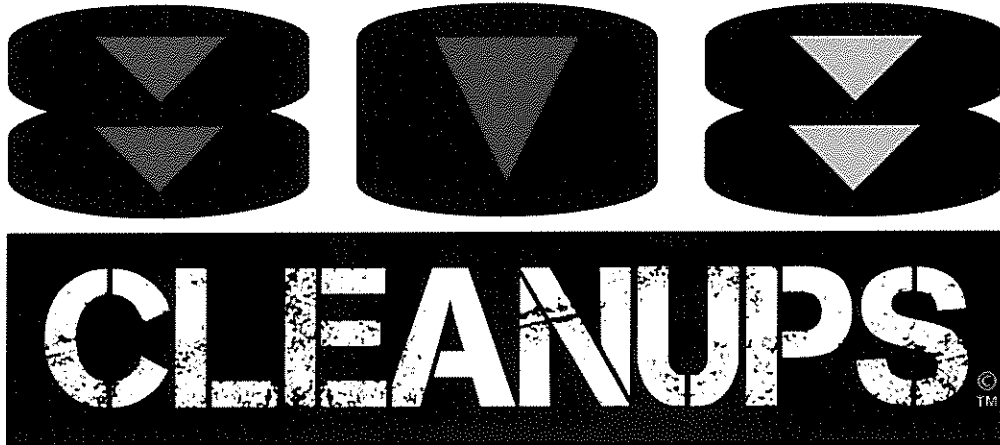

I. Background and Summary

We created 808 Cleanups in 2014 to stand up, take action, and make Hawai'i cleaner, safer, and stronger against environmental hazards. We seized the opportunity to create a volunteer support network and provide community support for comprehensive stewardship activities including removing litter and illegal dumpsites, marine debris, graffiti tags, and invasive plants.

2. The goals and objectives related to the request;

Our goal is to sustain and grow our stewardship and public lands enhancement. We have been doing steady and progressive work to reduce negative impacts on the land while beginning enhancement activities to restore native plants. We also seek to grow our ability to provide stewardship opportunities to all volunteers, students and community supporters.

3. The public purpose and need to be served;

Our mission is to make Hawaii cleaner, safer and stronger through daily cleanup events that enhance the public lands. The local communities and tourists expect and deserve to enjoy the natural beauty of the environment without safety hazards, such as drug needles, bonfire nails hidden in the sand, or used sanitary products polluting the parks and beaches. We will continue to make these places cleaner and safer for people to enjoy as well as enhance the land through invasive species control and elimination, followed by native plant restoration. We will also build upon our new alliance of non-profit organizations, to collaborate and help even more at all these locations.

4. Describe the target population to be served; and

We serve all of Hawai'i's communities and visitors. We do not discriminate against any community or demographic. We may have different background stories and interests, but we unite under the common cause of a cleaner, safer, and stronger Hawai'i. We will put special emphasis on school age groups as well as building a program to provide day-work opportunities for the homeless populations.

5. Describe the geographic coverage.

Our Geographic coverage will be the entirety of Oahu with the additional goal of expanding support to all the neighbor islands.

II. Service Summary and Outcomes

Our proposed scope of work falls under three main categories for this grant application. 1) Increase State volunteer turnout; 2) Increase scope of 808 Cleanups projects 3) Expand State enforcement capabilities.

- 1) **INCREASE STATE VOLUNTEER TURNOUT.** Expand social media outreach and community connection to get volunteers to help State Agencies with stewardship events. We have already come to the assistance of the State in many ways. These services have included graffiti removal on State Lands, graffiti removal training to State employees, additional volunteer hands for State stewardship events, public outreach for State initiatives on our social media and the addition of State stewardship events on our calendar at www.808cleanups.org. Our website is the first link when you Google "Hawai'i beach clean ups".



Our goals for this grant initiative:

- 1) Work with a State volunteer coordinator to get all State volunteer events shared on the calendar at www.808cleanups.org**
- 2) Provide 808 Cleanups website and social media as an additional extension for State outreach for volunteer events and announcements.**
- 3) Continue joint stewardship cleanups on an as-needed basis. For example, clearing an illegal dumpsite or marine debris that requires many additional hands, sometimes within 24 hours' notice.**

2) INCREASE SCOPE OF 808 CLEANUPS PROJECTS. Empower volunteers to steward and enhance State Lands through weekly and monthly projects, every day of the year. Our non-profit is active all year round and has a sustained energy as well as quick response time to events. In 2016 alone, we facilitated over 1,600 cleanups, an average of 4.5 per day, resulting in 83,299 lbs. of rubbish removed from trails, parks, beaches, urban areas and underwater. We aim to expand and deepen our coordination with the State to increase their participation rates even higher.



Our goals for this grant initiative:

- 1) Grow our existing Adopt a Site program so that currently covered State Land sites include a comprehensive approach of litter removal and site enhancement (invasive plants removal and native plant restoration).
- 2) Expand the number of sites in the Adopt a Site program to cover more State Lands, including beaches and trails.
- 3) Assist the State in its ongoing stewardship, enhancement, and scientific projects, continuing to build on coordination efforts.
- 4) Facilitate other non-profits in getting involved in State Land projects.
- 5) Provide monthly reports and photos to the State for data gathering and public outreach.

3) EXPAND STATE ENFORCEMENT CAPABILITIES. In coordination with State and Local law enforcement, expand State enforcement through volunteer night patrols (extra eyes, non-confrontational approach) and outreach to reduce or eliminate harmful practices on State Land. Pallet bonfires leave sharp nails in the sand that have long plagued one of our weekly stewardship sites, Kaiwi Scenic Shoreline. Through a combination of regular stewardship, community outreach, and night patrols, we have seen a dramatic reduction in illegal and destructive practices here. We want to expand this night patrol coverage and

get more community groups involved, coordinate with DOCARE, and eliminate this problem even faster so we can focus on other priorities.



Our goals with this grant initiative:

- 1) Provide weekly or monthly night patrols to State Lands impacted by pallet bonfires.**
- 2) Coordinate with community members to monitor areas island-wide in simultaneous night patrols at State Lands most affected.**
- 3) Report all findings immediately to DOCARE for further action and data gathering.**
- 4) Develop, with input from State and Local agencies, clear and agreed-to protocols for safe citizen engagement and outreach.**

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Our services listed above have already been in effect for three years. In that time we have increased the number of volunteers involved as well as improved the conditions of sites we have maintained with weekly and monthly cleanups. Should we receive your financial

support, we will further expand our stewardship and enhancement works as outlined above, effective immediately.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

We compile data on every cleanup that is reported through 808 Cleanups: location, number of volunteers, amount collected (weighed with luggage scales) etc. This data is contained in a spreadsheet available to the public in monthly reports. We also have daily updates from cleanups in the field on our social media, with pictures and reports so we can target areas in need and share knowledge. We can provide any knowledge the State needs to help enhance its mission.



The photo collage above shows the condition of Ka‘iwi Scenic Shoreline in December 2015 (Top Left/Bottom Left) and the condition in January 2017 (Top Right/Bottom Right). Pallet bonfire activity has reduced, allowing the sand to clean itself through natural processes. In 2015, we would pick up over 200 lbs. every single week of pallet debris including nails, broken glass and coals. At the end of 2016, we were picking up less than 50 lbs. every week on average. We clean up weekly as well as educate through social media, on-site briefings, classroom engagements, and community forums to educate and prevent reoccurrences. Today, we have much more time to devote to invasive plant removals.

Through the tracking data above, our goal with every site is to render big cleanups obsolete, thus moving resources to the next area in need while simultaneously maintaining stewardship at a site so it does not revert to a neglected state. Through our tracking, we have shown sites to improve relatively quickly, with reduced negative impacts through a combination of consistent weekly/monthly cleanups (all documented with data and photos) and outreach in person and through social media. The specific measures will be 1) Trash collected, and changes through stewardship 2) Number of volunteers engaged 3) Illegal practices reported to DOCARE or HPD.

We created and built this non-profit from grassroots community efforts to the level it is today. All of the services listed for Grants in Aid in this document have already been in effect since March 2014, and are all documented with data and photo evidence. Furthermore, we directly lead our cleanup events in the field, foster new volunteers to become leaders, provide support seven days a week to all volunteers, and work with many State, City, non-profit and community partners during this time. Due to our diligent work ethic, we have accomplished much with little funding, and that mindset has not changed with our recent grants we earned.

We are not in need of facilities, as our cleanups take place in the outdoor environment, and we will conduct management at any location.

V. Personnel: Project Organization and Staffing

We do cleanup work directly in the field alongside volunteers with a top priority on safety and efficient time management for a safe and enjoyable event for everyone. Prior to 808 Cleanups, Mr. Loftin has four years leading a solar installation crew, and two years as a scuba dive master. Jobs that require effective management in the field, working with people of different needs and skill sets, and responding to issues that crop up quickly. Ms. Liebengood is a MBA Nonprofit graduate with over ten years of statistics experience, and two years experience as a volunteer coordinator for the U.S. Marine Corps.
