I. Background and Summary

1. A brief description of the applicant's background;

After-School All-Stars Hawaii (ASAS Hawaii) provides after-school and summer programs that keep children safe and help them achieve in school and in life. ASAS Hawaii provides structured after school programming which includes academics, enrichment and health/fitness activities, targeting Hawaii's middle /intermediate school youth. ASAS Hawaii partners with seven schools on Oʻahu and three schools on Hawaii Island, and served 2,036 children last year.

ASAS Hawaii works in Title I schools, providing a structured curriculum that supports the social and intellectual development of low-income students through extra-curricular opportunities that are more widely available to middle- and upper-class children. Across ten school sites, about 83% of ASAS Hawaii participants qualify for free or reduced school lunch. This is the only free after-school program with a comprehensive curriculum in Hawaii. In addition to academic support, students are introduced to high school transition, service learning, career exploration and sports-based youth development initiatives.

The key success factor of ASAS Hawaii is that programs operate at partner school sites, with a full-time staff member located at each school. This enables program staff members to get to know students and parents, while working closely with school faculty and administration. ASAS Hawaii staff members have familiarity and experience with the diverse population of Hawaii and a passion for working with low-income and at-risk youth.

2. The goals and objectives related to the request;

The goal of this request is to provide free, daily after-school programs to 2,000 middle school students in ten Title I schools for 2017-18 school year.

Through a partnership with the Hawai'i State Department of Education, ASAS Hawai'i will track the following measurable objectives for all school sites.

- 1. ASAS participants will perform better academically than the general school population.
- 2. ASAS participants will have better attendance records than the general school population.
- 3. ASAS participants will have better behavioral records than the general school population.

3. The public purpose and need to be served;

The weekday hours of 3 p.m. to 6 p.m. represent an enormous challenge as well as a huge opportunity. More than 70% of children in the U.S. have parents who work outside the home, leaving three to four million youth unsupervised by adults every day. Rigorous research has demonstrated that after-school programs can reduce violence and dropout rates while improving behavior, academic performance, and the likelihood of education after high school.

ASAS provides free after-school programming for public middle students, but there are insufficient financial resources available to meet this need. The primary source of public funding is the federal 21st Century Community Learning Center program (21CCLC), which currently supports six out of ten ASAS programs. This leaves four ASAS programs without dedicated funding and the Hawai'i State Department of Education (HIDOE) did not release a 21CCLC request for proposals this year. Thus, ASAS is seeking a Grant-in-Aid to ensure these essential programs continue despite gaps in federal funding.

4. Describe the target population to be served; and

ASAS targets middle school students who face one or more challenges indicating they are "atrisk," such as low household income, poor academic performance, poor attendance record, and lack of access to after-school alternatives. ASAS Hawaii serves middle school children because this age is a pivotal point in young people's lives. Middle school students are going through academic, social and developmental changes and developing habits that can profoundly affect their futures. Students who develop good academic and lifestyle habits will be well prepared for success in high school, college and beyond.

For the proposed ten school sites, about 2,000 students will be involved in the project. Across ten schools about 83% of participants qualify for free or reduced school lunch. An estimated 40% of participants are Native Hawaiian and 40% are of another ethnic minority.

ASAS Hawaii works in ten public middle schools in nine different complexes. The following schools, complexes and geographic areas will be served through this project:

II. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities;

The proposed work is to provide free after-school programs for 2,000 children in ten Title I middle schools for the 2017-18 academic year. Programs take place for three hours per day, five days a week during the school year. Each day, students receive tutoring and do homework and then go on to athletics and enrichment activities. Students are also introduced to high school transition, service learning, career exploration and sports-based youth development initiatives.

The key success factor is that ASAS Hawaii programs operate on school campus with a site coordinator who works full-time at the school. By locating programs at schools, ASAS Hawaii is able to increase the likelihood of attendance, link after-school instruction to the school day, take advantage of existing infrastructure, and reduce transportation costs. Being at the school opens up access to children of working parents, for whom lack of transportation to off-campus activities is a barrier to participation.

As HIDOE implements Common Core State Standards, ASAS Hawaii is a valued partner, providing supplemental learning experiences that link directly to in-school academics. ASAS Hawaii programs provide professional development and incorporate activities that enrich and extend the academic learning that occurs in the classroom. Further, ASAS supports and encourages parental involvement by providing interactive family events at each school. ASAS engages numerous nonprofit partners, which enables a true community solution to the issue of after-school.

In addition to the after-school program, ASAS Hawaii offers a three-day/two-night summer camp for outgoing eighth grade students, called CampUs. Provided in partnership with University of Hawaii at Mānoa, CampUs seeks to: 1) prepare at-risk students for academic and social success in 9th grade; 2) clearly connect student interests with their high school, college and career options; 3) build relationships between campers and role model-mentors from their communities; and 4) teach students important study, leadership and college application skills. About seventy students participate in CampUs each summer.

ASAS programs follows a similar timeline, with activities aligning with the academic school year. The basic timeline is as follows:

ASAS Hawaii uses iResult to monitor behavioral, social and academic progress. iResult is a technology platform designed to help educational leaders collect data, evaluate programs, and make decisions based on performance and outcomes. iResult pulls data from multiple systems and transforms data into a standard format. Participating ASAS students are "grouped" in order to analyze the influence of the participation based on data. iResult also supports participant applications, which enables ASAS to maintain individual records and manage data efficiently.

Program quality assurance is supported through oversight by our parent organization, After-School All-Stars National. ASAS Hawaii is part of a national organization that provides a structured framework and program support. Our local chapter must meet standards related to program quality, reach and outcomes, organizational governance, and financial sustainability. Thus, program processes are consistent across all sites, while being tailored locally to meet needs and access available resources.

ASAS Hawaii has demonstrated success in providing after-school programs across multiple sites. The program meets the needs of students with mulitple barriers to academic success. Our strengths include: 1) site coordinators who work full-time at the school; 2) access to student behavioral, attendance and academic data, which helps us identify and address problems collaboratively with parents and teachers; and 3) relationships with dozens of community partners who bring experiential learning opportunities in a range of disciplines; 4) a strong relationship with Hawaii Department of Education since 2009, which has benefitted programs and students. A list of current, verifiable contracts is provided in the previous section.

Further, ASAS Hawaii participates in several policy groups, including the Hawaii Afterschool Alliance and the Hawaii State Legislature Keiki Caucus to provide input on legislative priorities related to children and youth. ASAS Hawaii served as an advisor to the Office of Lt. Governor to support its recent efforts in afterschool through his REACH initiative. As an established leader in the field of afterschool, ASAS Hawaii is often approached to partner with schools and community organizations. Partnerships flourish organically through ongoing relationships and trust in the community.

B. Facilities

ASAS Hawaii programs operate at their respective school campuses. This facility usage is Type II usage of public schools, which is designated for governmental agencies, not for profit community educational or recreational activities, youth clubs, athletic teams, labor organizations or service clubs conducting general recreational activities, community affairs, or public hearings for which there is no admission charge, collection taken or offering received during the use of school facilities.

Accordingly, the facilities meet ADA requirements for public schools under Title II of the ADA, which covers "public entities." The leadership team and organizational structure will contribute to success of this project. Leading our team is Dawn Dunbar, CEO, who founded ASAS Hawaii in 2009. Dawn has built relationships with schools, partners, funders and public officials, which have been critical to our success. Dawn has a Master's Degree in Business Administration from Graziadio School of Business at Pepperdine University, and a Bachelors Degree in English from Loyola Marymount University.

Paula Fitzell, COO, oversees the administrative functions and daily operations for ASAS Hawaii. Paula has a Master's Degree in Education from Trinity College in Dublin, Ireland. She previously worked for KCAA Preschools, overseeing administration of the organization with an annual operating budget of approximately \$7 million.

David Asato, Director of Programs, oversees programs on two islands, managing program staff and coordinating efforts with partner agencies. David was previously a teacher for Olomana High and Intermediate and a consultant for Hawai'i Department of Education. He was also executive director of VSA arts of Hawaii-Pacific, a statewide non-profit organization committed to helping at-risk adults and youth with developmental and other lifelong disabilities prepare to enter the workforce or continue their education. Program operations and evaluation are supported by a full-time Program Coordinator who works closely with the Director of Programs.

ASAS Hawaii Site Coordinators are responsible for daily operations of ASAS Hawaii programs at each school. They work on-site and are directly involved with students, teachers and administrators every day. Site coordinators have one or more years experience working in a leadership or supervisory capacity in an after-school, day-camp or community youth outreach setting.

Program Leaders teach classes, run activities, assist with homework, chaperone field trips and collaborate with partner instructors. We maintain a 20:1 leader to student ratio to ensure adequate supervision and individual attention. Program leaders must have a year or more of non-profit or related experience in youth development. Our staff members have familiarity and experience with the Hawaii's diverse population, and a passion for working with low-income or at-risk youth.

We will apply for additional 21st Century Community Learning Center contracts for the following cycle, FY2019, although this federal funding is never guaranteed. If funding is not received from the Hawai'i State Legislature thereafter, ASAS will continue to pursue diversified funding through local public and private sources.

Sustaining these programs is always a challenge because there is insufficient federal and state funding to meet the demand for after-school programs in middle school. Each year, ASAS Hawaii pursues diverse revenue sources to ensure programs operate uninterrupted despite fluctuations in public funding. Numerous resources support programs each year, including HIDOE, Kamehameha Schools, Office of Hawaiian Affairs, Hawaii Community Foundation, Hawaii P-20 and various private foundation grants. ASAS Hawaii also has loyal individual and corporate supporters providing funding each year.

Also contributing to sustainability, ASAS Hawaii maintains low overhead by using minimal office space and relying on in-kind administrative and program space at school sites. There is no charge to students to attend ASAS Hawaii programs.

In spite of funding challenges, it is clear that the investment in quality after-school programs for this age group clearly outweighs the huge cost of juvenile detention, teen pregnancy, and drug abuse – vices of unsupervised time during the danger zone hours. Another way to look at the benefits is that it costs approximately \$10,000 per student for six hours of school, and \$1,000 for three hours after school. ASAS participants receive 15% more time in school each day at 10% of the cost, and they are engaging in academic and extracurricular activities that help promote self-confidence and a positive attitude towards their futures. In other words, the return on investment

are dollars well spent when kids have somewhere to go, something to do, and someone to believe in them.

The undersigned authorized representative of the applicant certifies the following:


- 1) The applicant meets and will comply with all of the following standards for the award of grants pursuant to Section 42F-103, Hawai'i Revised Statutes:
  - a) Is licensed or accredited, in accordance with federal, state, or county statutes, rules, or ordinances, to conduct the activities or provide the services for which a grant is awarded;
  - b) Complies with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, or disability;
  - c) Agrees not to use state funds for entertainment or lobbying activities; and
  - d) Allows the state agency to which funds for the grant were appropriated for expenditure, legislative committees and their staff, and the auditor full access to their records, reports, files, and other related documents and information for purposes of monitoring, measuring the effectiveness, and ensuring the proper expenditure of the grant.

  - b) Has a governing board whose members have no material conflict of interest and serve without compensation.


