## I. Background and Summary

1.A brief description of the applicant's background

- 1. Formed in 2012, the *Mission of Friends of King Kaumuali'i* is to honor the last and Great King Kaumuali'i of Kaua'i by:
  - -Creating awareness of his reign & role in Kaua'i/Hawai'i history;
  - -Creating educational and cultural programs for local and tourist communities;
  - -Erecting a life-size bronze statue of the King at Pā'ula'ula/Russian Fort where he lived, reigned, and interacted with the world as they came to our shores.

Since 2112, we have been actively engaged in our mission with West Kauai Visitors Center and West Kauai Business & Professional Association presenting and participating in several local festivals and events annually, particularly, hosting Na Mele O Kaumuali'i, composers' contest with original mele written to honor the King. We also have provided art work and educational resources directly to all island schools.

In 2013, world-renowned artist & sculptor, Saim Caglayan joined "*Friends*" and was commissioned to begin working on the statue, using Kauaian, Dr Ke'ao NeSmith as his model. Thus far, through various events and donations large and small, we have accomplished the statue in clay, then completed to a half-size, 3ft. bronze maquette. It was created to be able to travel around the island and inspire residents and visitors to envision the possibilities of the full-scale model.

- 2. The goals and objectives related to the request;
- 2. We are requesting a state legislative grant of \$150,000 for the completion of an 8 ft Bronze statue to be mounted on a lava rock pedestal on a prepared site at Pa'ula'ula /Russian Fort above Waimea Bay and Town on the west side of Kaua'i. NOW, In the middle of Phase Two of Four phases we need \$150,000 to complete the full-size bronze statue and the site on which it sits. We are seeking grants, soliciting corporate, group, and individual donations and other ongoing fundraisers to accomplish this goal.
  - 3. Describe the public purpose & need to be served
- 3. When the statue is complete it will serve to remind locals to take pride and a deeper interest in our unique island history and beloved king who then, as now welcomed visitors with open arms to share and exchange cultures. Always considered something of a "separate kingdom," King Kaumuali'i joined peacefully in 1810 with Kamehameha. Kauai has a unique spirit that in many ways reach back to the forward thinking, interest in the world first demonstrated by the last King of Kaua'i -Kaumuali'i.

4. Describe the target population to be served;

- 4. Pa'ula'ula/Russian Fort is one of the most highly visited visitor attractions. The current site is cleared with dirt walkways and has historical story boards. We believe that it as yet is under developed as significant historical site with onsite visitor amenities which have been suggested but not yet implemented in the master plan. A popular historical walk is offered weekly through historic Waimea town by Kupuna Aletha Kaohi, from the West Kauai Visitors' Center a mile away. At this Center in the West Kaua'i Tech Building, more history and artifacts, as well as the bronze maquette are on display, with a gift shop for purchases of local books items.
  - 5. Describe the geographic coverage
- 5. The visible presence of the bronze statue of *King Kaumuali'i at Pa'ula'ula/Russian Fort*, overlooking Waimea and Ni'ihau would greatly enhance the experience and appreciation of this site for both visitors and residents. One of the most visited archaeological, historical sites on the Kaua'i, visitors may find a connection here to their own cultural history. *King Kaumuali'i* literally and figuratively, stands at the crossroads of time between pre-contact and modern history; between Hawaii and the Western world. People come from Europe, Russian, US, Canada Orient, searching for personal and political thread that binds. We believe the King should be there to receive his guests in the present as he did in the past.

## II. Service Summary and Outcomes

- 1. In addition to funds requested from this grant, *Friends of King Kaumuali'i Board* will continue with additional fundraising planned for 2017-18. *February 14th is the initiation of our three month long Capital Solicitation Drive for the Bronze Kaumuali'i Fund*. This will be led by *President, Aletha Kaohi*, with assistance from *Maureen Fodale*, *Board Secretary*. All board members, with the help of other *Friends* will contribute many hours of in-kind service to accomplish this task. Hundreds of direct mail and personal contact will be made with local island businesses, church, civic, halau and other groups & individuals on Kauai as well as other inter-island groups who would support our goal. We have planned visits to school May Days and other local events, and will add more venues to our calendar as we receive requests through donor solicitation letter.
  - 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;
- 2. The Life-size Kaumuali'i Bronze statue project is divided into **four distinct phases**. We have **completed Phase 1 with the completion of the bronze maquette, and have begun Phase 2-** where artist, Saim Caglayan worked to size up, scan, remove distortions and fine-tune to make 5 large section molds for the 8ft. model with *Cyber FX* in California. Phase 3 is the creation of the 8 ft statue from molds, to clay through to the final bronze and patina; and shipping the statue home to Kauai. Phase 4 is everything to do with site planning, permitting, preparation and ultimate erection of statue and dedication.

Below is a more thorough description of each phase. Assuming grant is awarded and funds are made available quarterly, we will progress through phases steadily towards completion. For grant funding purpose, we could complete Phases 2 & 3 in 6-9 months from July 2017 to spring 2018. Phase 4 which centers around site plan and development would begin with design and plan in quarter 1, July 2017 through to bronze statue dedication in summer 2018. Should funds become available sooner through Solicitation Drive or other means we would proceed chronologically through phases; i.e.

finishing Phase 2, beginning site plan development. Since Phase 4 costs are only estimates at this time, we would be update specific data as it becomes available. Surplus costs at the end of the project would be used to create a garden, reflection bench, Kaumuali'i Ohana wall and other site enhancement, moving into a separate project.

3./4Describe quality assurance and evaluation plans. 3. & 4. We have confidence in Saim Caglayan to hold the artistic side of the project to the highest standard as demonstrated in his professional resume with work photos (attached), and most especially in the bronze maquette model we already have. We would be eager to share photo and written summaries of the process with you, in whatever timeline you prefer. As to the Phase 4-- Site; working with a licensed professional landscape architect (name not yet confirmed), we expect this would give us and you parameters to evaluate quality and effectiveness which would be professionally recommended, easily understandable and with reliable updates as we progress through phase 4. Of course, funding will impact progress, but I have used your quarterly budget template to pace continuous results. While Aletha Kaohi will take the lead, each board member will be responsible to support progress & implementation of all aspects within phases according to their professional expertise.

1-4Describe the scope of work, tasks and responsibilities;

## Phase 1-Complete

From the original clay model, and subsequent molds, a 3 ft bronze maquette was created in bronze by Saim Caglayan at a foundry in California with whom he works regularly. It was decided by the *Friends of King Kaumuali'i* Board and the artist that a smaller maquette would be initially more affordable, and especially more portable to visiting various island location to engage and inspire the local community to our ultimate goal of placing a life-size monument at *Pa'ula'ula /Russian Fort*. The unveiling of the small bronze maquette was done ceremoniously with a Lu'au for locals and visitors at *Smith's Tropical Paradise*, near his birthplace of *Holoholoku* in Wailua.

The **cost of Phase 1 was approximately \$20,000**. It was paid for by a sizable, in kind artist donation (Saim Caglayan); large donations from Mr. & Mrs Pierce Bronsnan and Mr. & Mrs. Wm Cvengros; and other *many* smaller individual donations, profits from fundraising initiatives, and enormous amount of in kind work of time, service and skills not reflected in above cost.

## Phase Two

This phase represents the scanning/sizing and enlargement of the maquette to 8 feet, with fine tune of distortions which naturally occurs through scanning process. It currently exists in five large mold pieces, created by the artist, Saim Caglayan which together comprise the full size 8 foot model made into Urethane Foam done by Cyber FX. The mold pieces have currently been shipped back to artist's studios in Kalihiwai, Kauai. All of the work in Phase 2 was completed by Saim in California at his time and expense for which he has not yet been compensated. **\$15000 is due on Phase 2** so work may continue.

## **Phase Three**

Phase 3 is the most costly, labor intensive and spans <u>three</u> quarters: 1-July, 2-October, 3-Jan. '18. It will require \$85,000 to insure continuity and completion of this phase. It represents the artist's design, work, materials for the 6 months, foundry costs and shipping of the finished statue home to

Kauai. This is expressed in the grant budget quarterly format on a subsequent page. The total time needed working steadily and continuously is approx 6 months to complete Phase 3. This includes months to sculpt pieces and assembly of sections; and the time to cast at the foundry. Depending on how busy the foundry is, this given time frame may increase.

This phase 3 consists primarily of artist, S Caglayan's time to sculpt the five large pieces in clay, which has an enormous amount of detail (see photos of maquette at this phase). It represents artist design of the original sculpture; materials and supplies for sculpting the 8 feet enlargement with clay and delivery to the foundry; Time needed for his work on the five pieces is approximately 12 weeks working continuously. Beyond 12 weeks to the approximate finish of 6 months, more time given to final work on the wax cast prior to casting in bronze and final step of supervising the patina work. Additionally, Caglayan will need a minimum of 6 delivery and pick up trips between Cyber FX, Burbank, California and Heritage Foundry in Hesperian, California.

Caglayan has indicated a willingness to work mores slowly as funds are made available over 2-3 quarters as his molds, -enlarged foam sculptures scanned and made in Phase 2 are in 5 pieces. As funds are available to him, he can start working on each section slowly, as the clay I will use is oil based will not dry. You can see from photos that the head with mahiole and hair will be the most detailed sectionand take the longest. After all the sections are completed he will assemble it at the foundry.

## Phase Four

<u>Phase 4 is Erection-Dedication</u> and is more estimated costs as we are still in the planning, permitting, estimating phase for erection. We estimate costs at \$50,000 in this final Phase 4 includes permits, site plan development and final payment to artist Saim Caglayan. The specific categories we do know include, but are not limited to:

- A. Final agreement & permit from DLNR; this includes details such as location, security and maintenance. (See details in working plan below.)
- B. Professional design plan of a local landscape architect who will design as needed for specifics of geographic conditions as well as platform specifications and qualified contractors to full plan details. We imagine doing some planting in the immediate area of native and drought tolerant plants. Some ideas for future consideration are a community project wall and some sort of seating, perhaps a reflection bench in the immediate area. These concepts need to be discussed with landscape architect and board and may, or may not be financially, feasible within the scope and resources of Phase 4.
- C. Maintenance-We are working in close alliance with West Kauai Business & Professional Association which wholeheartedly support our mission of erecting the Life size Bronze Kaumuali'i on the site. They are currently in a curatorship agreement with DLNR and maintain and care for the entire Pa'ula'la/Russian Fort Site. including regular monthly workdays to clear brush and trails. We jointly agree to write into our charter to include maintenance of statue in the the 5 yr. renewable lease format or another suggested by DLNR. They are most eager to expand the vision and use of this site as a historic visitor destination, which ideally include an onsite Visitiors' Center, more interpretive information and programs etc. they/realize this needs to be detailed in updating the master plan, where these ideas have been mention for over 30 yrs,

but unrealized due to lack of priority funding. We are jointly committed to prioritizing this as goals within our community missions, following statue erection phase.

D. Security- We are committed to ensure the security and safety of the Bronze King Kaumuali'i Statue as memorial heritage for locals and visitors to enjoy and receive inspiration. Currently there is a plan soon to be initiated by DLNR toward increasing security, but locking gate at dusk and preventing access in the night. Specifically for the statue, we wish to install cameras and other alarm type technology to prevent vandalism or off hour access. Additionally we are thinking of perimeter barrier fencing as an additional measure, but want to discuss this with landscape architect and and gain consensus approval for DLNR. We will integrate this phase as we engage in Phase 3 replacing estimates with specific costs and needs.

#### B. Facilities

The applicant shall provide a description of its facilities and demonstrate its adequacy in relation to the request. If facilities are not presently available, describe plans to secure facilities.

We intend the 8 foot Bronze statue of **King Kaumualii**, to be placed at the site of **Russian Fort/Pa'ula'ula** which is in a rural setting rising above Waimea Bay from the southwest. We would place the statue on a rise over the River & Bay just outside what now remains of the structure. The Fort, now a State Park, was modernized in design in 1816 by Anton Schaefer, working on behalf of the Russian-American. Trading Company. Now it is an unimproved archaeological site of 17.5 acres it has dirt walking trails meandering around the site where King Kaumuali'i lived, worked, worshiped and welcomed voyagers, missionaries, entrepreneurs and other diverse visitors from literally around the world. It is here also, at Waimea Bay where Captain Cook landed first, encountering a highly civilized, well-established culture, living in peace and prosperity. It is not our intention to disturb or modernize the site to 21st c style visitor destination.

Currently West Kauai Business & Professional Association has a curatorship agreement from DLNR for Pa'la'ula/Russian Fort site; and it is cleaned monthly by members and volunteers. Working closely in partnership with WKB&PA, Friends of Kaumuali'i is pursuing permission to DLNR for site placement of statue and expansion of this current curatorship to specifically include care & maintenance of the Bronze statue and area immediately surrounding it.

We will be working with a **local licensed landscape architect** to render a detailed drawing and plan for site plot needs. This will include a lava rock pedestal for the statue, maintenance, security-likely cameras and alarm, with possible fencing later. We feel this professional plan can address and mitigate the above-mentioned concerns that DLNR expressed in initial conversations. Our proposal will be based on these recommendations to insure a safe as well as inspiring and meaningful visitor (and local) experience. It should be noted that the entire site is locked from entry at dusk daily.

## V. Personnel: Project Organization and Staffing

## A. Proposed Staffing, Staff Qualifications, Supervision and Training

As a 501c3 with a cultural education mission, and have no paid staff at this time. Board members will accommodate Artist Caglayan's timelines, and requests for funding as available through grants and other monies as they become available. Should we deem it necessary we

may contact a temporary clerical bookkeeping staff for a few hrs weekly should the volume of paperwork, especially financial records and reports to grant becomes excessive.

The following is a brief resume of each officer or Board member, describing skills related to their assigned tasks as board liaison to statue process completion and/or site development for erection.

She is retired State of Hawaii librarian and a renown Hawaii Cultural Consultant, who was also a lecturer at Kauai Community College for seven years. She is a Grant Distribution Member of GN Wilcox Trust, Elsie Wilcox Trust and Mabel Wilcox Trust, and a Grant agent of the Dora Isenberg Trust. She has been President of Friends of King Kaumuali'i from its early year to incorporation in 2012 and receipt of separate non profit status in August, 2016.

Maureen Fodale-Secretary-Retired teacher after 18 yrs of service for Hawaii DOE on Kauai; and 20 years serves previously in California and Michigan as a Waldorf teacher, administrator and program assistant at UCSC Extension in Santa Cruz. Currently active in Ahahui Kiwila Hawaii O Mo'ikeha; Delta Kappa Gamma-XI chapter and Hawaiian Studies Kumu/Kupuna Program. She has been active with Friends initiative since 2013.

Owen Moe-Vice-President/Treasurer- holds degrees in Business Administration and Welding Technology, and was an Industrial Engineer and Supervisor for Gay & Robinson until 2009 when the sugar operation ceased. He has also worked for Kauai Electric Utilities and as President of Kekaha Federal Credit Union. Now retired, he is currently Vice President of Garden Island Resource Conservation and Development and a Director of Kaua'i Planning & Action Alliance as well as serving on many other county and community committees.

Mike Faye-Building Contractor and owner of Kikiaola Construction Company, he is an advocate to preserve & restore historic buildings. He rebuilt Kalahikiola Congregational Church, Kohala, damaged by earthquake. He has served as President of family-owned Kikiaola Land Company/ Waimea Plantation Cottages. He is longtime of member of *West Kauai Business & Professional Association*, and been has actively involved since early 1970s in preserving Pa'ula'ula/Russian Fort.

Dave Walker-Retired from Kauai Fire Department. Active in WKB&PA, and West Kauai Rotary and involved in curatorship of Pa'ula'ula /Russian Fort from DLNR, including monthly cleanups of site.

It is in the minds of some to reexamine and fulfill some decades-old goals in the master plan for a visitor/interpretive center nearby on the site.


