Hilo Medical Center Foundation (HMCF) is a non-profit 501(c)3 corporation incorporated in 1995 with the mission "to support Hilo Medical Center with projects that benefit the greater community". As part of that mission, the HMCF has undertaken many projects to support our geographically isolated area with access to high quality primary medical care. One of our greatest accomplishments has been our ability to work with our communities to build support for the Hawai'i Island Family Medicine Residency Program. A substantial amount of funding has been raised by HMCF to support the program over the last six (6) years to train physicians to serve our rural Hawai'i communities. At every step of the way, HMCF has been involved in recruiting residents, faculty and informing the community and legislators of the success and needs of the program. HMCF is a partner in the success of the Hawai'i Island Family Medicine Residency Program, which we are proud to say will be graduating its first class of residents in June 2017. HMCF believes that it brings a unique value by directing the funds raised to support elements of the residency program and clinic that we believe will have the greatest benefit to our rural island communities. One of the ways we have achieved this is by becoming the Area Health Education Center (AHEC) on Hawaii Island. The AHEC program comes from the Health Resources and Services Administration (HRSA) which is the primary federal agency for improving access to health care services for people who are uninsured, isolated, or medically vulnerable.


As the AHEC organization on Hawai'i Island, we provide community medicine opportunities for doctors training in the residency program as well as nursing residents training at Hilo Medical Center. We have established relationships with the nursing programs and student health occupation organizations at the secondary and post-secondary school levels to provide opportunities for students to learn about health careers and volunteer in clinical and non-clinical health settings. HMCF provides medical students with housing, transportation, educational and clinical opportunities for their medical rotations across Hawai'i Island.

HMCF conducts "hands on" Teen Health Camps on a quarterly basis to expose students to health career options on Hawaii Island and is in the process of developing a dynamic health career mentoring and coaching program for students pursuing health careers.

HMCF works closely with Kelly Withy, principal investigator for the HRSA grant, from Jon A. Burns School of Medicine (JABSOM), and our executive director is part of the research team for the "Hawaii Physician Workforce Assessment Project" as established in accordance with Act 18, SLH, 2009 and Act 186, DLH, 2012 by the Hawaii State Legislature.

## 2. The goals and objectives related to the request;

As part of HMCF's continued efforts to support the Hawai'i Island Family Medicine Residency Program; also, known as the: Hawai'i Health Systems Corporation Primary Care Training Program (HHSC PCTP) HMCF proposes to furnish the new 7,700 sq. foot clinic located in the acute building on the Hilo Medical Center campus with the furniture and equipment necessary to provide high quality patient centered care. The new expanded facility will contain two (2) procedure rooms, two (2) triage rooms and twenty-seven (27) exam rooms; three (3) of which will be outfitted with telehealth stations for patients to access specialists they would otherwise not have access to on Hawaii Island.



The second phase of this project will renovate and furnish an additional 1,500 square feet of identified space on the Hilo Medical Center Campus to provide the required resident training/work space, mandated faculty offices and clinic administration space as dictated by the Accreditation Council for Graduate Medical Education (ACGME).

## 3. The public purpose and need to be served;

### **Shortage of Primary Care Providers:**

Hawai'i Island, like much of the state of Hawai'i, is facing a shortage of primary care physicians; especially as our existing providers age. Currently, 57% of primary care doctors in Hawai'i County are working past retirement age, 65 years or over, and plan to retire within the next 5 years. Without access to primary care the health of our vulnerable populations will continue to decline. Hawai'i County has a federal designation as a Medically Underserved Area due to the low socioeconomic challenges and barriers that exist in our geographically isolated environment. Chronic diseases are prevalent as well as a high diabetes and obesity rate due to the lack of access to primary care.

#### Increased Access to Medical Services:

The need for greater access to medical services is evident through the year over year increases in the emergency room visits to Hilo Medical Center. Emergency Room visits for fiscal year 2015-16 reached a record high of 47,987; a 6% increase over the previous fiscal year which is on track to exceed itself once again in fiscal 2016-17. The ability to move patients into the Hawai'i Island Family Medicine Residency Program will redirect patients into the clinic setting from the emergency room setting for low-acuity visits and chronic disease management without changing the patients' existing patterns of behavior; showing up to the hospital for their medical care. Providing patients with a patient centered medical home that can treat highly complex patients; those patients with two or more chronic disease diagnoses, depression or other behavioral health diagnosis and socioeconomic based health disparities that receive fragmented care, if any care at all, and over utilize emergency rooms and hospitals will improve the health of the community.

Healthcare Savings can be realized by identifying and redirecting patients into the primary care setting that are inappropriately utilizing emergency room services for low acuity conditions; which will reduce the overall cost to provide services to Hawai'i County's medically homeless and most vulnerable patients with chronic disease and behavioral health diagnoses.

### 4. Describe the target population to be served;

Hawai'i County has the lowest per capita income in the state at \$24,400 compared to other counties that hover near \$30,000. 19.2% of households live at or below the Federal Poverty Level compared to just 9.8% in Honolulu County and 11.4% and 11.7% in Maui and Kauai counties. 71% of patients at Hilo Medical Center are Medicare, Medicaid or quest patients and have a difficult time finding access to primary care services. Likewise, 29.3% of Puna residents and 27.6% of Ka'u residents live below the Federal Poverty Level and have the highest number of households in the state receiving financial aid or food stamps (except for Wai'anae located on Oahu). The increased capacity and revenue from the proposed expansion of the Hawaii Island Family Medicine Residency Program at Hilo Medical Center will contribute to further expansion efforts, via satellite clinics within the Puna and Ka'u communities.

There is a recognized need within the County of Hawai'i for accessible and available medical and behavioral health services in very rural areas within this geographic district. Our rural environment and lack of population does not lend itself to sustainably recruiting and retaining specialist positions. Therefore, we propose to close the specialist gap through the implementation of Telehealth services.

Telehealth services proposed will allow for low-cost referrals by community primary care doctors for their patients to be seen by a specialist they would otherwise need to fly to Oahu or the U.S. mainland to see.

The telehealth stations would fulfill the promise of increased access to specialist physicians to our remote rural community, via technology to the patient. Patients will have the option to avoid

long and costly travel to a neighbor island to see a specialist who will be able to provide care via telehealth. The Hawaii Island Family Medicine Residency Program as a Department of Hilo Medical Center has the unique ability to aggregate demand, contract for services with providers on Oahu and the U.S. Mainland, share protected health information and a new facility to deliver an excellent telehealth patient experience.

The expanded clinic equipped with the latest technology will continue to serve our most vulnerable patients. The larger clinic will allow for more patient visits as each exam room can see up to 1,000 visits per year. Telehealth capabilities will open a new service line for the clinic, increase convenient cost effective access to specialist physicians and train our residents in the latest care delivery methods.

5. Describe the geographic coverage.

Hilo Medical Center's service area encompasses 2,048 square miles from Honoka'a in the North to Ka'u in the South. This equates to 58% of the island's total population; 43% of which live 100% below the Federal Poverty level. Hawaii County is a federally designated medically underserved area and has a shortage of primary care providers and specialists.

#### Quarter 2:

Committee will continue to meet to monitor progress of ordered items and identify staging areas for arrival of FF& E items ahead of installation and clinic set up. Telehealth equipment will be ordered and installed; pilot telehealth project will continue to progress.

### Quarter 3/4:

Hawai'i Island Family Medicine Residency Program will move into new clinic space with a planned clinic grand opening in December 2017. Hilo Medical Center will begin scheduling telehealth appointments to commence in January 2018.

For more than twenty years, HMCF has actively provided support to Hilo Medical Center ranging from small beautification projects and diabetes education to complete medical unit renovations. This support ranged from grant writing, fundraising and hands on sweat equity utilizing members of our all-volunteer board and passionate community members.

The HMCF undertook a complete renovation and expansion of the emergency room at Hilo Medical Center in 2005-06 with the Million/Million campaign; HMCF raised one million dollars through community donations and private grants and the state matched those funds. This was followed with back to back purchases of two transport vans, to accommodate patients for appointments as well as outings for the patients in our long-term care facility, in 2011 and 2013 respectively. Also in 2013, HMCF in collaboration with Hawaii Island legislators introduced a bill to support the creation of the Hawaii Island Family Medicine Residency Program to address the primary care physician shortage. These efforts evolved into greater collaboration between HMCF and our state legislators to continue funding of the residency program in the state budget.





  - d) Allows the state agency to which funds for the grant were appropriated for expenditure, legislative committees and their staff, and the auditor full access to their records, reports, files, and other related documents and information for purposes of monitoring, measuring the effectiveness, and ensuring the proper expenditure of the grant.
- 2) If the applicant is an organization, the applicant meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
  - a) Is incorporated under the laws of the State; and
  - b) Has bylaws or policies that describe the manner in which the activities or services for which a grant is awarded shall be conducted or provided.
- 3) If the applicant is a non-profit organization, it meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
  - a) Is determined and designated to be a non-profit organization by the Internal Revenue Service; and
  - b) Has a governing board whose members have no material conflict of interest and serve without compensation.

Pursuant to Section 42F-103, Hawai'i Revised Statutes, for grants used for the acquisition of land, when the organization discontinues the activities or services on the land acquired for which the grant was awarded and disposes of the land in fee simple or by lease, the organization shall negotiate with the expending agency for a lump sum or installment repayment to the State of the amount of the grant used for the acquisition of the land.
