### A BILL FOR AN ACT

RELATING TO CHARITABLE ORGANIZATIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 28-5.2, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[{] §28-5.2[}] Protection of charitable assets; attorney
4	general's authority. (a) The attorney general shall represent
5	the public interest in the protection of charitable assets and
6	may:
7	(1) Enforce the application of a charitable asset in
8	accordance with:
9	(A) The law and terms governing the use, management,
10	investment, distribution, and expenditure of the
11	charitable asset; and
12	(B) The charitable purpose of the person holding the
13	asset;
14	(2) Act to prevent or remedy:
15	(A) The misapplication, diversion, or waste of a
16	charitable asset; or

1	(B) A breach of fiduciary or other legal duty in the
2	governance, management, or administration of a
3	charitable asset; or
4	(3) Commence or intervene in an action to:
5	(A) Prevent, remedy, or obtain damages for:
6	(i) The misapplication, diversion, or waste of a
<b>7</b> .	charitable asset; or
8	(ii) A breach of fiduciary or other legal duty in
9	the governance, management, or
10	administration of a charitable asset; or
1	(B) Determine that an asset is a charitable asset.
12	(b) If the attorney general has reason to believe an
13	investigation is necessary to determine whether action is
14	advisable under this section, the attorney general may conduct
15	an investigation, including exercising administrative subpoena
16	power under sections 28-2.5 and 467B-9.3.
17	(c) This section shall not limit the powers and duties of
18	the attorney general under the laws of this State.
19	(d) As used in this section "charitable asset" means
2.0	property that is given, received, or held for a charitable

- 1 purpose. The term does not include property acquired or held
- 2 for a for-profit purpose.
- 3 (e) As used in this section, "property" includes all
- 4 interests in real property or tangible or intangible personal
- 5 property, including cash, remainder interests, land, and
- 6 conservation or preservation easements or restrictions. The
- 7 remainder interest in a charitable remainder trust is property
- 8 held for a charitable purpose, as is the current interest in a
- 9 charitable lead trust, property held for ten years in a building
- 10 fund, and property given to a charitable organization subject to
- 11 a restriction on its use. Property held in a revocable trust
- 12 that provides a remainder interest for a charitable purpose is
- 13 not a charitable asset while the settlor is alive because the
- 14 settlor can revoke or change the interest."
- 15 SECTION 2. Section 467B-2.1, Hawaii Revised Statutes, is
- 16 amended to read as follows:
- 17 "§467B-2.1 Registration of charitable organizations[-]:
- 18 deactivation. (a) Every public benefit corporation domiciled
- 19 in Hawaii and every charitable organization not exempted by
- 20 section 467B-11.5 shall register with the department prior to
- 21 conducting any solicitation of contributions or prior to having

- 1 any solicitation of contributions conducted on its behalf by
- 2 others. [Two] An authorized [officers] officer or agent of the
- 3 charitable organization shall sign the registration form and
- 4 shall certify that the statements therein are true and correct
- 5 to the best of [their] the officer's or agent's knowledge
- 6 subject to penalties imposed by section 710-1063. A central or
- 7 parent organization that has received a group exemption letter
- 8 from the Internal Revenue Service may submit a consolidated
- 9 application for registration for itself and any or all of the
- 10 subordinate organizations covered under the group exemption that
- 11 are included in the central or parent organization's annual
- 12 information return to the Internal Revenue Service.
- 13 (b) Any charitable organization registered in Hawaii or
- 14 any charitable organization exempted from registration pursuant
- 15 to section 467B-11.5 that will no longer be conducting any
- 16 solicitation of contributions or having any solicitation of
- 17 contributions conducted on its behalf by others and that wishes
- 18 to be deactivated shall file a request for deactivation with the
- 19 attorney general in writing. The attorney general shall
- 20 deactivate the organization after being satisfied that all
- 21 obligations of the organization under this chapter have been

- 1 met. Deactivation of a charitable organization shall not
- 2 deprive the attorney general of jurisdiction over the activities
- 3 of the charitable organization that occurred while the
- 4 organization was registered or should have been registered.
- 5 [\(\frac{(b)}{c}\)] (c) The attorney general may make available a
- 6 registration and a deactivation form to assist in the
- 7 registration or deactivation by charitable organizations.
- 8  $\left[\frac{(c)}{(c)}\right]$  (d) The attorney general may require that
- 9 registration or deactivation forms be filed with the department
- 10 electronically and may require the use of electronic
- 11 signatures."
- 12 SECTION 3. Section 467B-2.5, Hawaii Revised Statutes, is
- 13 amended by amending subsection (a) to read as follows:
- 14 "(a) Within ninety days after a solicitation campaign or
- 15 event has been completed [and on] or within ninety days of the
- 16 anniversary of the commencement of a solicitation campaign
- 17 lasting more than one year, a professional solicitor shall file
- 18 with the attorney general a financial report for the campaign,
- 19 including gross revenue from Hawaii donors and national gross
- 20 revenue and an itemization of all expenses incurred on a form
- 21 prescribed by the attorney general. The attorney general may

- 1 require the financial report to be submitted electronically  $[\div]$
- 2 and may require the use of electronic signatures. This report
- 3 shall be signed [under penalty provided by section 710 1063] by
- 4 the professional solicitor or by an authorized [contracting]
- 5 officer or agent [for] of the professional solicitor [and shall
- 6 report gross revenue from Hawaii donors and national gross
- 7 revenue from a solicitation activity or campaign.] who shall
- 8 certify that the statements therein are true and correct to the
- 9 best of the solicitor's, officer's, or agent's knowledge subject
- 10 to penalties imposed by section 710-1063. If a financial report
- 11 required under this section is not filed in a timely manner,
- 12 taking into account any extension of time for filing, unless it
- 13 is shown that the failure is due to reasonable cause, an initial
- 14 late filing fee of \$100 shall be imposed, and an additional late
- 15 filing fee of \$20 per day shall be imposed, for each day during
- 16 which the violation continues; provided that the total fee
- 17 amount imposed under this subsection shall not exceed \$1,000.
- 18 The attorney general may waive all or part of the late filing
- 19 fee imposed by this subsection if there is a reasonable cause
- 20 for the failure to timely file. The professional solicitor
- 21 shall provide a copy of the financial report to the charitable

- 2 days of its submission of the report to the attorney general. A
- 3 professional solicitor shall maintain during each solicitation
- 4 campaign and for not less than three years after the completion
- 5 of that campaign the following records, which shall be available
- 6 for inspection upon demand by the attorney general:
- 7 (1) The date and amount of each contribution received and the name and address of each contributor:
- 9 (2) The name and residence of each employee, agent, or other person involved in the solicitation;
- 11 (3) Records of all revenue received and expenses incurred 12 in the course of the solicitation campaign; and
- 13 (4) The location and account number of each bank or other
  14 financial institution account in which the
  15 professional solicitor has deposited revenue from the
  16 solicitation campaign."
- 17 SECTION 4. Section 467B-6.5, Hawaii Revised Statutes, is 18 amended to read as follows:
- 19 "§467B-6.5 Annual financial reports; fiscal records and
- 20 fees. (a) Every registered charitable organization shall
- 21 annually file with the department a report for its most recently

- 1 completed fiscal year. If the charitable organization files a
- 2 Form 990 [ex], 990-EZ, or 990-PF with the Internal Revenue
- 3 Service, the annual report shall be a copy of that Form 990
- 4 [or], 990-EZ[-], or 990-PF. If the registered charitable
- 5 organization is required to file a Form 990-T with the Internal
- 6 Revenue Service, the annual report shall include a copy of that
- 7 Form 990-T. If a charitable organization is not required to
- 8 file a Form 990 [ex], 990-EZ, or 990-PF with the Internal
- 9 Revenue Service, the annual report shall contain all information
- 10 prescribed by the department. The annual report for a
- 11 charitable organization that files a Form 990 [or], 990-EZ, or
- 12 990-PF shall be electronically submitted to the department
- 13 within ten business days of the date that the organization files
- 14 the form with the Internal Revenue Service. The annual report
- 15 for a charitable organization that files a Form 990-N or that is
- 16 not required to file a Form 990 [ex], 990-EZ, or 990-PF shall be
- 17 electronically submitted to the department not later than the
- 18 fifteenth day of the fifth month following the close of its
- 19 fiscal year. An authorized officer or agent of the charitable
- 20 organization shall sign the annual report and shall certify that
- 21 the statements therein are true and correct to the best of the

- 1 officer's or agent's knowledge subject to penalties imposed by
- 2 section 710-1063. A charitable organization that has obtained
- 3 an extension of time to file a Form 990  $[\Theta r]$ , 990-EZ, or 990-PF
- 4 from the Internal Revenue Service shall provide a copy to the
- 5 attorney general within twenty days after the copy is requested
- 6 by the attorney general. [The annual report shall be
- 7 accompanied by a filing fee as prescribed by subsection (d).]
- 8 The department shall accept, under conditions prescribed by the
- 9 attorney general, a copy or duplicate original of financial
- 10 statements, reports, or returns filed by the charitable
- 11 organization with the Internal Revenue Service or another state
- 12 having requirements similar to the provisions of this section;
- 13 provided that the attorney general may prescribe the form of the
- 14 annual financial report for charitable organizations that file
- 15 the Form 990-N with the Internal Revenue Service, or who are not
- 16 required to file a Form 990 [or], 990-EZ, or 990-PF with the
- 17 Internal Revenue Service.
- 18 (b) A charitable organization with contributions in excess
- 19 of \$500,000 in the year covered by the annual financial report
- 20 and a charitable organization required to obtain an audit report
- 21 by a governmental authority or a third party shall include with

- 1 its annual financial report, an audit report, prepared in
- 2 accordance with generally accepted accounting principles, by a
- 3 certified public accountant.
- 4 [(c) The department, upon written request and for good
- 5 cause shown, may grant an extension of time, not to exceed three
- 6 months, for the filing of the annual report required by this
- 7 section.
- 8 (d) (c) Each charitable organization filing a report
- 9 required by this section shall pay a filing fee to the
- 10 department based on the total amount of its gross revenues
- 11 during the time covered by the report at the close of the
- 12 calendar or fiscal year adopted by the charitable organization
- 13 as follows:
- 14 (1) \$0, if gross revenue is less than \$25,000;
- 15 (2) \$25, if gross revenue is at least \$25,000 but less
- 16 than \$50,000;
- 17 (3) \$50, if gross revenue is at least \$50,000 but less
- 18 than \$100,000;
- 19 (4) \$100, if gross revenue is at least \$100,000 but less
- 20 than \$250,000;

- 1 \$150, if gross revenue is at least \$250,000 but less (5) 2 than \$500,000; 3 (6) \$200, if gross revenue is at least \$500,000 but less 4 than \$1,000,000; 5 (7) \$250, if gross revenue is at least \$1,000,000 but less 6 than \$2,000,000;
- 7 \$350, if gross revenue is at least \$2,000,000 but less (8) 8 than \$5,000,000; or
- 9 \$600, if gross revenue is \$5,000,000 or more. (9)
- [<del>(e)</del>] (d) If a return, report, or filing fee required 11 under this section is not filed or paid, taking into account any
- 12 extension of time for filing, unless it is shown that the
- 13 failure is due to reasonable cause, a late filing fee of \$20
- 14 shall be imposed for each day during which the violation
- continues; provided that the total amount imposed under this 15
- 16 subsection shall not exceed \$1,000.
- 17 [<del>(f)</del>] (e) Every charitable organization subject to section
- 18 467B-2.1 and this section shall keep true fiscal records that
- 19 shall be available to the department for inspection upon
- 20 request. The organization shall retain the records for no less

- than three years after the end of the fiscal year to which they
  relate.

  [(g)] (f) The attorney general may require the annual
  financial report and audit report required by subsections (a)
  and (b) to be electronically submitted and to include electronic
- 6 signatures."
- 7 SECTION 5. Section 467B-11.5, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "§467B-11.5 Charitable organizations exempted from
- 10 registration and financial disclosure requirements. The
- 11 following charitable organizations shall not be subject to
- 12 sections 467B-2.1 and 467B-6.5, if the organization submits an
- 13 application for an exemption to the department and the
- 14 department approves the organization's application:
- 15 (1) Any duly organized religious corporation, institution,
  16 or society that is exempt from filing Form 990 with
  17 the Internal Revenue Service pursuant to [sections
  18 6033(a)(3)(A)(i) and (iii) and 6033(a)(3)(C)(i)]
- 19 <u>section 6033(a)(3)(A)(i) and (iii) and (C)(i)</u> of the
- 21 (2) Parent-teacher associations;

1	(3) Any	educational institution that is licensed or

3	accr	editing organizations[÷] or their successor

13	[ <del>-(4)</del> -]	(5) Any nonprofit hospital licensed by the State or
14		any similar provision of the laws of any other state;
15	[ <del>-(5)</del> ]	(6) Any corporation established by an act of the
16		United States Congress that is required by federal law
17		to submit to Congress annual reports, fully audited by
18		the United States Department of Defense, of its
19		activities including itemized accounts of all receipts
20		and expenditures;

1	$[\frac{(6)}{(7)}]$ Any agency of this State, another state, or the
2	federal government; and
3	[ <del>(7)</del> ] <u>(8)</u> Any charitable organization that normally
4	receives less than \$25,000 in contributions annually,
5	if the organization does not employ or compensate a
6	professional solicitor or professional fundraising
7	counsel. For purposes of this paragraph, an
8	organization normally receives less than \$25,000 in
9	contributions annually if, during the immediately
10	preceding three fiscal years, it received, on average,
11	less than \$25,000 in contributions.
12	The attorney general may require the application for exemption
13	to be filed electronically with the department and may require
14	the use of electronic signatures."
15	SECTION 6. This Act does not affect rights and duties that
16	matured, penalties that were incurred, and proceedings that were
17	begun before its effective date.
18	SECTION 7. Statutory material to be repealed is bracketed
19	and stricken. New statutory material is underscored.
20	SECTION 8. This Act shall take effect on July 1, 2017.
