RELATING TO JUDICIAL PROCEEDINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 48, Session Laws of Hawaii 2016, is amended
2	by amending section 14 to read as follows:
3	"SECTION 14. This Act shall take effect on August 1, 2016,
4	and shall be repealed on July 1, 2019; provided that sections
5	91-14, 174C-12, 183C-8, [206E-5.6(h),] <u>206E-5.6,</u> 269-15.5, and
6	[602-5(a),] <u>602-5,</u> Hawaii Revised Statutes, shall be reenacted
7	in the form in which they read on the day prior to the effective
8	date of this Act."
9	SECTION 2. Statutory material to be repealed is bracketed
10	and stricken. New statutory material is underscored.

11 SECTION 3. This Act shall take effect upon its approval.
