

## A BILL FOR AN ACT

MAKING AN APPROPRIATION TO THE DEPARTMENT OF THE PROSECUTING ATTORNEY OF THE CITY AND COUNTY OF HONOLULU.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$300,000 or so much 3 thereof as may be necessary for fiscal year 2017-2018 for a grant-in-aid to the department of the prosecuting attorney of 4 the city and county of Honolulu for the career criminal 5 6 prosecution unit. The sum appropriated shall be expended by the department of 7 8 the prosecuting attorney of the city and county of Honolulu for 9 the purposes of this Act.

SECTION 2. This Act shall take effect on July 1, 2017.
