MAKING AN APPROPRIATION TO THE OFFICE OF THE PROSECUTING ATTORNEY FOR HAWAII COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. There is appropriated out of the general
revenues of the State of Hawaii the sum of \$150,000 or so much
thereof as may be necessary for fiscal year 2017-2018 and the
same sum or so much thereof as may be necessary for fiscal year
2018-2019 as a subsidy to the office of the prosecuting attorney
for Hawaii county for the career criminal prosecution unit,
including the hiring of necessary staff.

8 The sums appropriated shall be expended by the office of 9 the prosecuting attorney for Hawaii county for the purposes of 10 this Act.
