A BILL FOR AN ACT

RELATING TO STAFF OF THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the Hawaii employer-SECTION 1. 2 union health benefits trust fund (EUTF) would operationally 3 benefit from employing certain EUTF staff through a civil 4 service system. The purpose of this Act is to permit the EUTF 5 board of trustees to employ certain EUTF staff through a civil 6 service system. 7 SECTION 2. Section 87A-24, Hawaii Revised Statutes, is amended to read as follows: 8 9 "§87A-24 Other powers. In addition to the power to 10 administer the fund, the board may: 11 (1) Collect, receive, deposit, and withdraw money on 12 behalf of the fund; 13 (2) Invest moneys in the same manner specified in section 14 88-119; 15 (3) Hold, purchase, sell, assign, transfer, or dispose of 16 any securities or other investments of the fund, as

1		well as the proceeds of those investments and any
2		money belonging to the fund;
3	(4)	Appoint, and at pleasure dismiss, an administrator and
4		other fund staff. The administrator [and staff] shall
5		be exempt from chapter 76 [and other]. Other fund
6		staff may be exempt from chapter 76 as determined by
7		the board. The administrator and staff who are exempt
8		from chapter 76 shall serve under and at the pleasure
9		of the board[+]; provided that civil service exempt
10		positions under this section that are created after
11		July 1, 2014, shall be exempt from section 76-
12		16(b)(17)(A);
13	(5)	Make payments of periodic charges and pay for
14		reasonable expenses incurred in carrying out the
15		purposes of the fund;
16	(6)	Contract for the performance of financial audits of
17		the fund and claims audits of its insurance carriers;
18	(7)	Retain auditors, actuaries, investment firms and
19		managers, benefit plan consultants, or other
20		professional advisors to carry out the purposes of
21		this chapter, including the retaining of an actuary to

1		determine the annual required public employer
2		contribution for the separate trust fund established
3		under section 87A-42;
4	(8)	Establish health benefits plan and long-term care
5		benefits plan rates that include administrative and
6		other expenses necessary to effectuate the purposes of
7		the fund; and
8	(9)	Require any department, agency, or employee of the
9		State or counties to furnish information to the board
10		to carry out the purposes of this chapter."
11	SECT	ION 3. There is appropriated out of the general
12	revenues	of the State of Hawaii the sum of \$ or so much
13	thereof a	s may be necessary for fiscal year 2017-2018 and the
14	and the s	um of \$ or so much thereof as may be necessary
15	for fisca	l year 2018-2019, for the EUTF to employ certain EUTF
16	staff through a civil service system.	
17	The	sums appropriated shall be expended by the EUTF for the
18	purposes	of this Act.
19	SECT	ION 4. The EUTF shall submit a report of its findings
20	and recom	mendations, including any proposed legislation,
21	regarding	changes to its personnel and operations as a result of

- 1 this Act, to the legislature no less than twenty days prior to
- 2 the convening of the regular sessions of 2018 and 2019.
- 3 SECTION 5. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 6. This Act shall take effect on July 1, 2050.
