# A BILL FOR AN ACT

RELATING TO EMERGENCY PREPAREDNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that firefighters are

2 important men and women who extinguish fires, administer first

3 aid, provide emergency services, and often risk their lives to

4 assist others.

5 The legislature further finds that firefighters serve both

6 the State with fire stations at Hawaii airports and the counties

7 with twenty-five fire stations in the county of Hawaii, forty-

8 four fire stations in the city and county of Honolulu, seven

9 fire stations in the county of Kauai, and fourteen fire stations

10 in the county of Maui.

11 The legislature also finds that the Hawaii emergency

management agency recommends that each resident stock an

13 emergency preparedness kit that includes enough food and water

for at least seven days. However, the legislature also finds

15 that city and county of Honolulu fire stations store only four-

16 day supplies of food and water. County of Maui fire stations

17 store only a one-day supply of MREs, or Meals Ready-to-Eat.

- 1 Although county of Kauai fire stations have special water
- 2 filters that can remove impurities for drinking and cooking,
- 3 those stations and the county of Hawaii fire stations do not
- 4 store emergency supplies of food and water.
- 5 The legislature further finds that it is in the best
- 6 interests of the State and the counties to ensure that
- 7 firefighters have adequate supplies of food and water for their
- 8 own use at fire stations, especially during times of natural
- 9 disasters or other calamities.
- 10 The purpose of this Act is to appropriate funds to supply
- 11 emergency, seven-day provisions of food and water for state and
- 12 county firefighters while they serve at fire stations; provided
- 13 that the county provides matching funds for provisions for its
- 14 firefighters.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so much
- 17 thereof as may be necessary for fiscal year 2017-2018 and the
- 18 same sum or so much thereof as may be necessary for fiscal year
- 19 2018-2019 to supply each fire station at state airports with
- 20 emergency provisions of food and water to sustain firefighters
- 21 on a fully-staffed shift for seven days.

1 The sums appropriated shall be expended by the department 2 of transportation for the purposes of this Act. 3 SECTION 3. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$ or so much 5 thereof as may be necessary for fiscal year 2017-2018 and the 6 same sum or so much thereof as may be necessary for fiscal year 7 2018-2019 to supply each county fire station in the county of 8 Hawaii with emergency provisions of food and water to sustain 9 firefighters on a fully-staffed shift for seven days; provided 10 that no funds shall be made available under this Act unless 11 matched on a dollar-for-dollar basis by the county of Hawaii for 12 the purpose for which the sums are appropriated. 13 The sums appropriated shall be expended by the county of 14 Hawaii for the purposes of this Act. 15 SECTION 4. There is appropriated out of the general **16** revenues of the State of Hawaii the sum of \$ or so much 17 thereof as may be necessary for fiscal year 2017-2018 and the

same sum or so much thereof as may be necessary for fiscal year

2018-2019 to supply each county fire station in the city and

county of Honolulu with emergency provisions of food and water

to sustain firefighters on a fully-staffed shift for seven days;

- 11 2018-2019 to supply each county fire station in the county of
- 12 Kauai with emergency provisions of food and water to sustain
- 13 firefighters on a fully-staffed shift for seven days; provided
- 14 that no funds shall be made available under this Act unless
- 15 matched on a dollar-for-dollar basis by the county of Kauai for
- 16 the purpose for which the sums are appropriated.
- 17 The sums appropriated shall be expended by the county of
- 18 Kauai for the purposes of this Act.
- 19 SECTION 6. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so much
- 21 thereof as may be necessary for fiscal year 2017-2018 and the

- 1 same sum or so much thereof as may be necessary for fiscal year
- 2 2018-2019 to supply each county fire station in the county of
- 3 Maui with emergency provisions of food and water to sustain
- 4 firefighters on a fully-staffed shift for seven days; provided
- 5 that no funds shall be made available under this Act unless
- 6 matched on a dollar-for-dollar basis by the county of Maui for
- 7 the purpose for which the sums are appropriated.
- 8 The sums appropriated shall be expended by the county of
- 9 Maui for the purposes of this Act.
- 10 SECTION 7. This Act shall take effect on July 1, 2099.
