
A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE II, SECTION 1, OF THE HAWAII
STATE CONSTITUTION TO CHANGE THE AGE QUALIFICATION FOR
VOTING IN STATE OR LOCAL ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the age
2 qualification to vote in any federal, state, or local election
3 is eighteen years of age. However, there are individuals whose
4 dates of birth fall between the primary and general elections
5 and therefore, due to current age restrictions, are unable to
6 participate in state and local primary elections, which
7 determine the ballot for the general election in which they will
8 later be eligible to vote. Granting voting rights to these
9 individuals to participate in the voting process for state and
10 local elections may improve voter turnout among youths and
11 better educate youths about the democratic process.

12 The purpose of this Act is to propose an amendment to
13 article II, section 1, of the Hawaii State Constitution to
14 change the age qualification for voting in certain state or
15 local primary elections to include individuals who are seventeen



1 years of age but will be eighteen years of age on or before the
2 next state or local general election.

3 SECTION 2. Article II, section 1, of the Constitution of
4 the State of Hawaii is amended to read as follows:

5 "QUALIFICATIONS

6 Section 1. Every citizen of the United States who shall
7 have attained the age of eighteen years, have been a resident of
8 this State not less than one year next preceding the election
9 and be a voter registered as provided by law, shall be qualified
10 to vote in any state or local election[-]; provided that every
11 citizen of the United States who is seventeen years of age but
12 will attain the age of eighteen years by the date of the next
13 state or local general election, has been a resident of this
14 State not less than one year immediately preceding the next
15 state or local general election and is a voter registered as
16 provided by law, shall be qualified to vote beginning with the
17 state or local primary election immediately preceding the state
18 or local general election by which the citizen will attain the
19 age of eighteen years."

20 SECTION 3. The question to be printed on the ballot shall
21 be as follows:

1 "Shall a United States citizen who is seventeen years of
 2 age but will attain the age of eighteen years by the date
 3 of the next state or local general election, has been a
 4 resident of this State not less than one year immediately
 5 preceding the next state or local general election, and is
 6 a voter registered as provided by law, be qualified to vote
 7 beginning with the state or local primary election
 8 immediately preceding the state or local general election
 9 by which the citizen will attain the age of eighteen
 10 years?"

11 SECTION 4. Constitutional material to be repealed is
 12 bracketed and stricken. New constitutional material is
 13 underscored.

14 SECTION 5. This amendment shall take effect upon
 15 compliance with article XVII, section 3, of the Constitution of
 16 the State of Hawaii.
