A BILL FOR AN ACT

RELATING TO AQUATIC LIFE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 188, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§188- Nearshore reef wildlife protection. (a) The
5	division of aquatic resources shall promote education about
6	nearshore reef wildlife and shall implement programs and
7	policies to increase reef health and restore nearshore reef
8	wildlife populations to their historically naturally occurring
9	levels.
10	(b) No program or policy implemented pursuant to this
11	section shall prohibit the exercise of traditional and customary
12	rights for subsistence, cultural, or religious purposes,
13	including native Hawaiian gathering rights and traditional
14	cultural practices, and subject to the right of the State to
15	regulate such rights, as specified in article XII, section 7, of
16	the Hawaii state constitution.

1	(c) No program or policy implemented pursuant to this
2	section shall prohibit the issuance of special activity permits
3	pursuant to section 187A-6.
4	(d) No program or policy implemented pursuant to this
5	section shall prohibit the taking of fish or other aquatic life
6	for human consumption or for sale for human consumption,
7	including the taking of fish for bait.
8	(e) For purposes of this section, "nearshore reef
9	wildlife" means marine life that occurs naturally in coral reef
10	ecosystems within three miles of the shoreline."
11	SECTION 3. The department of land and natural resources
12	shall develop a comprehensive plan for the sustainable
13	management of nearshore reef wildlife, which shall include
14	requirements for sustainable fishing and marine life collection
15	practices and limits on total rates of taking and collection.
16	The department shall submit a report of its plan, including any
17	recommended legislation, to the legislature no later than twenty
18	days prior to the convening of the regular session of 2018.
19	SECTION 4. A moratorium shall be placed on all aquarium
20	fish permits issued pursuant to section 188-31, Hawaii Revised
21	Statutes, until the department has developed a comprehensive

plan for the sustainable management of nearshore reef wildlife.
During the moratorium, all existing permits shall not be
transferable to new individuals.
SECTION 5. New statutory material is underscored.
SECTION 6. This Act shall take effect upon its approval.
