### A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE DEPARTMENT OF WATER, COUNTY OF KAUAI.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The following sums, or so much thereof as shall
2	be sufficient to finance the projects listed in this Act, are
3	hereby appropriated out of the general revenues of the State of
4	Hawaii for fiscal year 2017-2018:
5	1. To be expended by the county of Kauai:
6	A. Kilauea water system, Kauai.
7	Drilling and developing
8	(testing) of new Kilauea well
9	#3; provide a new source of
10	water for the Kilauea water
11	system; design and construct
12	a one million gallon storage

1 SECTION 2. The appropriation made for the capital 2 improvement projects authorized by this Act shall not lapse at 3 the end of the fiscal year for which the appropriation is made; 4 provided that all moneys from the appropriation that are 5 unencumbered as of June 30, 2020, shall lapse as of that date. 6 SECTION 3. The sums appropriated for the respective 7 capital improvement projects set forth in section 1 shall be 8 expended by the designated expending agency for the purposes of 9 this Act.

10 SECTION 4. This Act shall take effect on July 1, 2017.
