# A BILL FOR AN ACT

RELATING TO SECURITY GUARDS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 463-10.5, Hawaii Revised Statutes, is  
2 amended as follows:  
3           1. By amending subsection (c) to read:  
4           "(c) [~~Guards~~] Within sixty days after being hired as a  
5 guard, guards and individuals acting in a guard capacity shall  
6 successfully complete the classroom instruction specified by  
7 this section, pass a written test, and undergo four hours of on-  
8 the-job training supervised by an individual who has  
9 successfully completed all of the requirements of this section  
10 or who has otherwise been approved by the board for on-the-job  
11 training. Guards and individuals acting in a guard capacity  
12 shall successfully complete:  
13           (1) Eight hours of classroom instruction before the first  
14           day of unsupervised service[+] as a guard; and  
15           (2) Four hours of classroom instruction biennially  
16           thereafter; provided that in addition to relevant  
17           guard industry material, the required classroom



1 instruction shall include a refresher component on  
2 professional image and aloha training.

3 Effective July 1, 2017, each guard agency, private business  
4 entity, or government agency subject to this section shall  
5 transmit to the board, on a monthly basis, a list consisting of  
6 each newly hired guard, agent, operative, or assistant who will  
7 act in a guard capacity and who will be required to meet the  
8 requirements of this subsection."

9 2. By amending subsection (g) to read:

10 "(g) Prior to the June 30, 2016, renewal of the guard  
11 registration and every registration renewal thereafter, the  
12 applicant shall pay all required fees, and have had at least  
13 four hours of continuing education as specified in the rules of  
14 the board[-]; provided that after June 30, 2017, the first  
15 renewal of registration shall be completed no sooner than two  
16 years from the applicant's completion of an initial  
17 registration.

18 The board may conduct a random audit, pursuant to rules  
19 adopted pursuant to chapter 91, of registrants applying for  
20 renewal of a registration to determine whether the continuing  
21 education requirements of this subsection have been met.



1           The failure, neglect, or refusal of any registered guard to  
2 pay the renewal fee or meet the continuing education  
3 requirements shall constitute a forfeiture of the guard's  
4 registration. A forfeited registration may be restored upon  
5 written application within one year from the date of forfeiture,  
6 payment of the required renewal fee plus penalty fees, and  
7 meeting the continuing education requirements in effect at the  
8 time of restoration."

9           SECTION 2. Statutory material to be repealed is bracketed  
10 and stricken. New statutory material is underscored.

11           SECTION 3. This Act shall take effect on July 1, 2099.



**Report Title:**

Security Guards; Licensure; Registration; Renewal

**Description:**

Requires guards to meet mandatory instruction and training requirements within 60 days after hiring. Provides for first registration renewal no sooner than two years from initial registration. Requires employers to submit a monthly list of newly hired guards to the Board of Private Detectives and Guards. (HB1515 HD1)
