### A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the construction of
- 2 Hawaii Route 3000 bypass, better known as the Lahaina bypass,
- 3 was proposed as a way to mitigate traffic congestion on the
- 4 Honoapiilani highway through Lahaina town in West Maui.
- 5 Construction of the highway was also seen as essential for the
- 6 health and safety of residents, as Honoapiilani highway was
- 7 previously the only link between West Maui and Central Maui for
- 8 residents, visitors, and, most importantly, emergency vehicles.
- 9 The importance of the bypass has only grown since the project
- 10 was first proposed due to the steady increase in Maui's
- 11 population.
- The legislature further finds that a higher speed limit
- 13 along the Lahaina bypass would encourage individuals to use the
- 14 bypass, resulting in less traffic congestion along the main
- 15 Honoapiilani highway. This would allow for a higher quality of
- 16 life for Maui residents and faster response times for emergency
- 17 vehicles traveling along Honoapiilani Highway.

14	the speed limit for Hawaii Route 3000 bypass, also known as the		
15	Lahaina bypass or the Honoapiilani highway bypass, shall be:		
16	(1) Fifty-five miles per hour in the Mahinahina-bound

18	milepost 3.26;		
19	(2) Forty miles per hour in the Mahinahina-bound direction		
20	from route milepost 3.26 through Keawe Street;
