A BILL FOR AN ACT

RELATING TO ENERGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Act 159, Session Laws of Hawaii 2015, is
 amended as follows:

3 1. By amending subsection (a) of section 2 to read:

"(a) There is established within the department of 4 5 business, economic development, and tourism, a [two-year] four-6 year alternative energy research and development pilot program 7 to provide grants to qualified businesses conducting research 8 and development in alternative energy. The purpose of the pilot 9 program shall be to promote the research and development of 10 alternative energy in Hawaii by authorizing the high technology development corporation to provide matching grants to businesses 11 that meet criteria established in subsection (b)." 12

13 2. By amending subsection (c) of section 2 to read:
14 "(c) The alternative energy research and development pilot
15 program shall cease to exist on June 30, [2017.] 2019."

16 3. By amending section 3 to read:

"SECTION 3. There is established the alternative energy 1 2 research and development revolving fund for the purpose of 3 promoting alternative energy research and development in Hawaii. The alternative energy research and development revolving 4 fund shall be abolished on June 30, [2017,] 2019, and all 5 6 unencumbered balances shall lapse to the credit of the general fund." 7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ 9 or so much thereof as may be necessary for fiscal year 2017-2018 and the 10 11 same sum or so much thereof as may be necessary for fiscal year 12 2018-2019 to be deposited into the alternative energy research 13 and development revolving fund. SECTION 3. There is appropriated out of the alternative 14 energy research and development revolving fund the sum of 15 16 \$ or so much thereof as may be necessary for fiscal year 17 2017-2018 and the same sum or so much thereof as may be 18 necessary for fiscal year 2018-2019 for the purpose of providing grants pursuant to Act 159, Session Laws of Hawaii 2015. 19 20 The sums appropriated shall be expended by the high 21 technology development corporation for the purposes of this Act.


