MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to collective bargaining
4 statewide (BUF 102) the following sums or so much thereof as may
5 be necessary to fund for fiscal biennium 2017-2019 all
6 collective bargaining cost items in the agreement negotiated
7 with the exclusive bargaining representatives of collective
8 bargaining unit (2):

There are appropriated or authorized from the sources of funding indicated below to collective bargaining statewide (BUF 102) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2017-2019 the salary increases and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for state officers and employees in the executive branch who are excluded from collective bargaining and belong to the same compensation plans as those officers and employees within collective bargaining unit (2):


2 SECTION 5. Salary increases and cost adjustments provided

5 shall be paid wholly or proportionately, as the case may be,
6 from the respective funds.

7 SECTION 6. Funds appropriated or authorized by this Act
8 that are not expended or encumbered by June 30, 2018, and June
9 30, 2019, of the respective fiscal years, shall lapse as of
10 those dates.

11 SECTION 7. This Act shall take effect on July 1, 2017.
