# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to collective bargaining  
4 statewide (BUF 102) the following sums or so much thereof as may  
5 be necessary to fund for fiscal biennium 2017-2019 all  
6 collective bargaining cost items in the agreement negotiated  
7 with the exclusive bargaining representatives of collective  
8 bargaining unit (9):

14 SECTION 9. Salary increases and cost adjustments provided  
 15 in this Act for any officer or employee whose compensation is  
 16 paid, in whole or in part, from federal, special, or other funds  
 17 shall be paid wholly or proportionately, as the case may be,  
 18 from the respective funds.

19 SECTION 10. Funds appropriated or authorized by this Act  
 20 that are not expended or encumbered by June 30, 2018, and June



1 30, 2019, of the respective fiscal years, shall lapse as of  
2 those dates.

3 SECTION 11. This Act shall take effect on July 1, 2050.
