
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF THE ATTORNEY GENERAL TO ESTABLISH A
WORKING GROUP TO STUDY FORENSIC LABORATORIES IN THE STATE.

1 WHEREAS, forensic science is the process of using science
2 to resolve legal issues; and

3
4 WHEREAS, forensic science may involve the application of
5 various fields of science, including anthropology, biology,
6 chemistry, engineering, genetics, medicine, pathology, voice
7 analysis, psychiatry, and toxicology to matters involving law
8 enforcement; and

9
10 WHEREAS, the Honolulu Police Department's Scientific
11 Investigation Section includes the only full-service forensic
12 laboratory in the State; and

13
14 WHEREAS, the Scientific Investigation Section's forensic
15 laboratory is commonly referred to as the "crime lab"; and

16
17 WHEREAS, other law enforcement agencies in the State have
18 more limited facilities and trained staff available for the
19 application of forensic science; and

20
21 WHEREAS, there may be opportunities to improve the
22 application of forensic science for law enforcement purposes in
23 the State; now, therefore,

25 BE IT RESOLVED by the House of Representatives of the
26 Twenty-ninth Legislature of the State of Hawaii, Regular Session
27 of 2017, the Senate concurring, that the Department of the
28 Attorney General is requested to establish a working group to
29 study forensic laboratories in the State; and

1 BE IT FURTHER RESOLVED that the working group is requested
2 to include representatives from the Federal Bureau of
3 Investigation, the Department of Public Safety, the Judiciary,
4 the police department of each county, the office of the
5 prosecutor of each county, the Office of the Public Defender,
6 criminal defense attorneys, the Hawaii State Bar Association,
7 the American Civil Liberties Union, state legislators, and a
8 professor of forensic science from Chaminade University; and

10 BE IT FURTHER RESOLVED that the working group is requested
11 to study the capabilities, staffing levels, case loads, and task
12 completion times of forensic laboratories in the State; and
13 accreditation requirements and other issues related to the
14 operation of forensic laboratories; and

16 BE IT FURTHER RESOLVED that the working group is requested
17 to specifically analyze the following issues:
18

- 19 (1) The number of forensic tests conducted annually by the
20 Honolulu Police Department and other crime
21 laboratories in this State;
22
- 23 (2) The sources of requests to the Honolulu Police
24 Department and other crimes laboratories in this State
25 for forensic testing;

- 27 (3) The number of requests to the Honolulu Police
28 Department and other crime laboratories in this State
29 from state agencies for forensic testing;

- 31 (4) Methods in which the Honolulu Police Department sends
32 evidence to other states for forensic testing;

- 34 (5) The number of times each year that the Honolulu Police
35 Department sends evidence to other states for forensic
36 testing;

- 38 (6) The costs for forensic testing that is conducted in
39 other states for the Honolulu Police Department;

- 1 (7) Additional costs related to forensic testing,
- 2 including costs for experts from other states to
- 3 travel to this State to testify as prosecution
- 4 witnesses;

- 6 (8) Any projected increases in costs for forensic testing
- 7 in this State;
- 8
- 9 (9) The sources of funding for DNA testing of felons who
- 10 are convicted in this State; and
- 11
- 12 (10) The sources of funding for equipping and operating
- 13 forensic laboratories in this State and in other
- 14 states; and
- 15

16 BE IT FURTHER RESOLVED that the working group is requested
 17 to provide a report, including any findings, recommendations,
 18 and proposed legislation, through the Attorney General, to the
 19 Legislature no later than twenty days prior to the convening of
 20 the regular session of 2018; and

22 BE IT FURTHER RESOLVED that certified copies of this
 23 Concurrent Resolution be transmitted to the Attorney General,
 24 the Federal Bureau of Investigation, the Department of Public
 25 Safety, the Judiciary, the police department of each county, the
 26 office of the prosecutor of each county, the Office of the
 27 Public Defender, the Hawaii State Bar Association, the American
 28 Civil Liberties Union, and Chaminade University.
