A BILL FOR AN ACT

RELATING TO AIRPORTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a
- 2 compelling interest in protecting consumers from the effects of
- 3 the high prices of travel and transporting goods among the
- 4 islands. The legislature further finds that to promote
- 5 commerce, the State must create a transportation network to
- 6 encourage competition and lower the cost of conducting business
- 7 in the State.
- 8 Hawaii's air transportation planning, management, and
- 9 development functions are currently spread out among a number of
- 10 agencies, including the department of transportation's harbors
- 11 and airports divisions, the department of health with respect to
- 12 environmental concerns, and the office of Hawaiian affairs with
- 13 respect to ceded lands issues.
- 14 This multijurisdictional situation has resulted in
- 15 inefficiencies and conflicts that are difficult to resolve
- 16 between agencies. In addition, this situation sometimes leads

- 1 to conflicting plans of action among the different agencies
- 2 seeking to implement different goals.
- 3 Recent problems experienced by the medevac night services
- 4 in this State could expand to the loss of air travel options on
- 5 Molokai and Lanai if the current multijurisdictional system is
- 6 allowed to persist.
- 7 The economic well-being of the State depends in part on the
- 8 efficient use of all of its air transportation resources, to
- 9 enhance and complement efforts to improve Hawaii's economy. The
- 10 legislature believes that coordinated planning and development
- 11 of air transportation would be implemented more effectively by a
- 12 single entity having overall consolidated jurisdiction.
- 13 The legislature finds that the rational allocation and
- 14 administration of scarce and increasingly valuable airport
- 15 resources through the establishment of an airport authority is
- 16 vital for the well-being of the people and the economy of the
- 17 State. An airport authority will create new access to cargo
- 18 options, lower the cost of travel, increase medical flight
- 19 services, provide increased flexibility for civil defense, and
- 20 expand tourism options.

| 1 | It is the intent of the legislature that the employees of |
|----|--|
| 2 | the department of transportation currently charged with the |
| 3 | management of airports be eventually transferred to the Hawaii |
| 4 | airport authority without loss of seniority or benefits and that |
| 5 | future employees of the airport authority be state employees. |
| 6 | Accordingly, the purposes of this Act are to: establish the |
| 7 | Hawaii airport authority as an independent public entity to set |
| 8 | statewide policy on all matters relating to airports; and |
| 9 | provide for the orderly transfer of the department of |
| 10 | transportation's responsibilities with regard to airports to the |
| 11 | Hawaii airport authority. |
| 12 | SECTION 2. The Hawaii Revised Statutes is amended by |
| 13 | adding a new chapter to be appropriately designated and to read |
| 14 | as follows: |
| 15 | "CHAPTER |
| 16 | HAWAII AIRPORT AUTHORITY |
| 17 | § -1 Definitions. As used in this chapter: |
| 18 | "Administrator" means the administrator of the airport |
| 19 | authority. |
| 20 | "Airport authority" means the Hawaii airport authority. |

- 2 portions of the airports or airports that is used, or intended

- 7 facilities located thereon.

- 13 SECTION 3. Section 261-21, Hawaii Revised Statutes, is 14 amended by amending subsection (a) to read as follows:
- "(a) Except as provided in subsection (c), any person

 16 violating this chapter, or any of the rules or orders issued

 17 pursuant thereto and relating to:
- 18 (1) Safety measures, practices, or requirements;
- 19 (2) Airport security measures or requirements; or
- 20 (3) The licensing and regulation of persons engaged in21 commercial activities at public airports,



- 1 duly adopted or served, shall be [quilty of a misdemeanor.]
- 2 subject to a civil penalty not to exceed \$500."
- 3 SECTION 4. Jurisdiction over aeronautics and airports,
- 4 including airport functions under the department of
- 5 transportation's airports division, shall be transferred to the
- 6 airport authority on July 1, 2018.
- 7 SECTION 5. At least twenty days prior to the convening of
- 8 the regular session of 2018, the department of transportation
- 9 shall submit to the legislature a report recommending statutes
- 10 that must be amended to transfer the authority and corresponding
- 11 employees to the airport authority pursuant to this Act.
- 12 SECTION 6. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so much
- 14 thereof as may be necessary for fiscal year 2017-2018 for the
- 15 implementation of the Hawaii airport authority.
- 16 The sum appropriated shall be expended by the department of
- 17 budget and finance for the purposes of this Act.
- 18 SECTION 7. It is the legislature's intent that this Act
- 19 not jeopardize the receipt of any federal aid nor impair the
- 20 obligation of the State or any agency thereof to the holders of
- 21 any bond issued by the State or by any such agency, and to the



- 1 extent, and only to the extent, necessary to effectuate this
- 2 intent, the governor may modify the strict provisions of this
- 3 Act, but shall promptly report any such modification with
- 4 reasons therefor to the legislature at its next session
- 5 thereafter for review by the legislature.
- 6 SECTION 8. This Act does not affect rights and duties that
- 7 matured, penalties that were incurred, and proceedings that were
- 8 begun, before its effective date.
- 9 SECTION 9. This Act shall be liberally construed to
- 10 accomplish the purposes set forth herein. If any provision of
- 11 this Act, or the application thereof to any person or
- 12 circumstance, is held invalid, the invalidity shall not affect
- 13 the other provisions or applications of this Act that can be
- 14 given effect without the invalid provision or application, and
- 15 to this end the provisions of this Act are severable.
- 16 SECTION 10. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.

- 1 SECTION 11. This Act shall take effect upon approval;
- 2 provided that section 2 shall take effect on July 1, 2018, and

3 section 6 shall take effect on July 1, 2017.
