A BILL FOR AN ACT

RELATING TO THE REPEAL OF SECTION 325-15, HAWAII REVISED
STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that mandatory testing
2 for tuberculosis of United States citizens returning from
3 certain areas for absences of five or more years provides
4 marginal benefits to tuberculosis control in Hawaii and is
5 costly to maintain and impractical to enforce. Repealing this
6 requirement will diminish burdens for travelers without
7 significant risk to public health.

8 The purpose of this Act is to repeal section 325-15, Hawaii
9 Revised Statutes, which requires United States citizens or
10 nationals upon returning to the State after five years residence
11 in any United States territory or possession, or any foreign
12 country, with a high occurrence of infectious and communicable
13 diseases, to submit a medical examination report that shall
14 include a tuberculin skin test or a chest x-ray examination, and
15 in the case of a positive skin test, a chest x-ray report, to

1 the department of health within sixty days of returning to the
2 State.

3 SECTION 2. Section 325-15, Hawaii Revised Statutes, is
4 repealed.

5 ~~["§325-15] Infectious and communicable diseases,~~

17 SECTION 3. Statutory material to be repealed is bracketed
