
A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that an increasing number
2 of Hawaii voters are submitting their votes by mail. The 2014
3 Hawaii primary election was the first election in which more
4 ballots were submitted before primary election day than on that
5 day. Fifty-six per cent of Hawaii voters chose to vote early
6 during the 2014 primary, and approximately eighty-three per cent
7 of those voters did so through a mail-in absentee ballot. In
8 2016, the number of votes cast before election day exceeded the
9 number of votes cast at polling places on election day, except
10 in one county.

11 The legislature further finds that Hawaii's conversion to
12 elections by mail would significantly reduce the logistical
13 issues related to conducting elections at polling places.

14 Accordingly, the purpose of this Act is to:

- 15 (1) Require all elections statewide to be conducted by
16 mail beginning with the 2020 primary election;
- 17 (2) Establish a limited number of voter service centers
18 that would remain open from the tenth business day



1 preceding an election through the day of the election
2 to receive personal delivery of mail-in ballots,
3 accommodate voters with special needs, offer same day
4 registration and voting, and provide other election
5 services;

6 (3) Allow for additional places of deposit for personal
7 delivery of mail-in ballots; and

8 (4) Appropriate funds for the implementation and
9 administration of the election by mail program.

10 SECTION 2. Chapter 11, Hawaii Revised Statutes, is amended
11 by adding a new part to be appropriately designated and to read
12 as follows:

13 "PART . ELECTIONS BY MAIL

14 §11-A Elections eligible to be conducted by mail.

15 Beginning with the 2020 primary election, all elections shall be
16 conducted by mail in accordance with this title.

17 §11-B Procedures for conducting elections by mail. (a)

18 Ballot packages for elections by mail shall include:

- 19 (1) An official ballot;
- 20 (2) A pre-paid postage return identification envelope;
- 21 (3) A secrecy envelope; and



1 (4) Instructions.

2 (b) To the extent practicable, the clerk shall mail a
3 ballot package by non-forwardable mail to each registered voter
4 in the county so as to enable voters to receive the ballot
5 package approximately eighteen days before the election. The
6 clerk shall continue mailing ballot packages to voters who
7 update their voter registration address no later than fourteen
8 days before the date of the election. In determining the
9 initial mailing date of the ballot packages, the clerk shall
10 consider the mailing place of origin and the most recent postal
11 service delivery standards. The clerk shall not mail a ballot
12 package to any voter in the county register who is identified as
13 having an outdated or non-deliverable mail address. Nothing in
14 this part shall be construed to change the responsibilities of
15 the clerk or chief election officer under chapter 15D with
16 respect to uniform military and overseas voters.

17 (c) The clerks shall determine and provide for voter
18 service centers and places of deposit pursuant to this part and
19 section 11-92.1.

20 **§11-C Public notice of mailing.** Public notice of the date
21 or dates that the initial ballot packages are to be mailed shall



1 be given by the clerks before the ballot packages are made
2 available to voters.

3 §11-D Ballot instructions; ballot return. (a) After a
4 voter receives a ballot package, the voter shall comply with the
5 instructions included in the ballot package in order to cast a
6 valid vote. The instructions shall include directions for:

- 7 (1) Marking the ballot;
- 8 (2) Inserting the marked ballot in the secrecy envelope;
- 9 (3) Inserting the secrecy envelope with the marked ballot
10 in the return identification envelope; and
- 11 (4) Signing the return identification envelope before
12 mailing or delivering the return identification
13 envelope containing the secrecy envelope with the
14 marked ballot.

15 (b) The instructions shall include information on election
16 fraud and voter fraud, as provided in sections 19-3(5) and
17 19-3.5, and notice that violation of either section may subject
18 the voter, upon conviction, to imprisonment, a fine, or both.

19 (c) To cast a valid ballot, the voter shall return the
20 return identification envelope containing the secrecy envelope
21 with the marked ballot:



1 (1) By mail so that the return identification envelope is
2 received at the office of the clerk no later than the
3 time provided in section 11-131 on the date of the
4 election;

5 (2) By personal delivery at any place of deposit no later
6 than 6:00 p.m. on the day preceding the date of the
7 election; or

8 (3) By personal delivery to any voter service center no
9 later than the time provided in section 11-131 on the
10 date of the election.

11 (d) Once a voter has returned a return identification
12 envelope containing the secrecy envelope with marked ballot,
13 that voter's ballot is deemed cast and may not be recast in the
14 election.

15 **§11-E Replacement ballots.** (a) A voter may obtain a
16 replacement ballot if the ballot was destroyed, spoiled, or lost
17 by contacting the clerk. The chief election officer may
18 prescribe a replacement ballot application form that shall
19 include information that allows the clerk to verify the
20 registration of the voter and ensure that another ballot has not
21 been returned by the voter.



1 (b) Upon receipt of the replacement ballot application
2 form, the clerk shall:

3 (1) Verify the registration of the voter and ensure that
4 another ballot has not been returned by the voter;

5 (2) Record that the voter has requested a replacement
6 ballot;

7 (3) Mark the return identification envelope as containing
8 a replacement ballot; and

9 (4) Issue the replacement ballot package by mail or make
10 the ballot package available for pick-up by the voter.

11 (c) Voters who obtain a replacement ballot shall return
12 the return identification envelope containing the secrecy
13 envelope with the marked replacement ballot:

14 (1) By mail so that the return identification envelope is
15 received at the office of the clerk no later than the
16 time provided in section 11-131 on the date of the
17 election;

18 (2) By personal delivery to any place of deposit no later
19 than 6:00 p.m. on the day preceding the date of the
20 election; or



1 (3) By personal delivery to any voter service center no
2 later than the time provided in section 11-131 on the
3 date of the election.

4 **§11-F Deficient return identification envelopes. If:**

5 (1) A return identification envelope is returned with an
6 unsigned affirmation;

7 (2) The affirmation signature does not match a reference
8 signature image; or

9 (3) A return identification envelope contains another
10 condition that would not allow the counting of the
11 ballot,

12 the clerk shall make an attempt to notify the voter by first
13 class mail, telephone, or electronic mail to inform the voter of
14 the procedure to correct the deficiency. The voter shall have
15 five business days after the date of the election to cure the
16 deficiency. The chief election officer may adopt rules
17 regarding requirements and procedures for correcting deficient
18 return identification envelopes. The counting of ballots and
19 disclosure of subsequent election results may continue during
20 the time period permitted to cure a deficiency under this
21 section. The clerk's inability to contact voters under this



1 section shall not be grounds for a contest for cause under
2 section 11-172.

3 **§11-G Electronic transmission under certain circumstances.**

4 If a ballot package is not received by a voter within five days
5 of an election or a voter otherwise requires a replacement
6 ballot within five days of an election, the voter may request
7 that a ballot be forwarded by electronic transmission. Upon
8 receipt of such a request and confirmation that proper
9 application was made, the clerk may transmit the appropriate
10 ballot, together with a form containing the affirmations,
11 information, and a waiver of the right to secrecy under section
12 11-137. The voter may return the voted replacement ballot and
13 executed forms by electronic transmission, mail, or personal
14 delivery to a place of deposit no later than 6:00 p.m. on the
15 day preceding the date of the election, or personal delivery to
16 a voter service center; provided that the ballot and forms are
17 received by the issuing clerk no later the closing hour of
18 voting provided in section 11-131 on the date of the election.
19 Upon receipt, the clerk shall verify compliance with the
20 requirements of this part; provided that if the voter returns



1 multiple voted ballots for the same election, the clerk shall
2 prepare only the first ballot returned that is not spoiled.

3 **§11-H Counting of mail-in ballots.** Ballot processing for
4 tabulation may begin no sooner than the tenth day before the
5 election. In the presence of official observers, counting
6 center employees may open the return identification envelopes
7 and count the ballots; provided that any tabulation of the
8 number of votes cast for a candidate or question appearing on
9 the ballot, including a counting center printout or other
10 disclosure, shall be kept confidential and shall not be
11 disclosed to the public until the closing hour of voting
12 provided in section 11-131 on the date of the election. All
13 handling and counting of ballots shall be according to
14 procedures established by the chief election officer.

15 **§11-I Voter service centers; places of deposit.** (a)
16 Voter service centers shall be established at the office of the
17 clerk, and may be established at additional locations within a
18 county as may be designated by a clerk to service the particular
19 needs of a county's voters.

20 (b) Voter service centers shall be open from the tenth
21 business day preceding the day of the election during regular



1 business hours until the time provided in section 11-131 on the
2 date of the election and at the same times statewide.

3 Notwithstanding the foregoing, the clerk may establish varying
4 times and dates of operation for additional service centers as
5 may be necessary.

6 (c) Each voter service center shall provide the services
7 specified in section 11-1 under the definition of "voter service
8 center".

9 (d) The county clerks may designate and provide for places
10 of deposit to be open five business days before the election
11 until 6:00 p.m. the day preceding the election; provided that
12 the locations and apparatus for receiving voted ballots can be
13 securely maintained during the period of use for each election,
14 and as may be permitted by the operational hours.

15 **§11-J Election expenses and responsibilities for elections**

16 **by mail.** (a) Election expenses in an election by mail shall be
17 as follows:

18 (1) All expenses related to elections by mail involving
19 both state and county offices, or involving both
20 federal and county offices, unrelated to voter
21 registration, shall be divided in half between the



1 State and the counties. To the extent that a
2 particular expense is shared statewide, each county
3 shall pay a proration of expenses as a proportion of
4 the registered voters at the time of the general
5 election. The counties shall separately be
6 responsible for expenses associated with voter
7 registration;

8 (2) All expenses for county elections by mail, which do
9 not involve state or federal offices, shall be borne
10 by the county and paid out of appropriations as may be
11 made by the county council; and

12 (3) All expenses for state or federal elections by mail,
13 which do not involve county offices, shall be borne by
14 the State and paid out of appropriations as may be
15 made by the legislature. Expenses attributable to
16 registration of voters by the clerk for state or
17 federal elections that do not involve county offices
18 shall be borne by the State and paid out of
19 appropriations as may be made by the legislature.

20 (b) Election responsibilities for elections by mail shall
21 be as follows:



- 1 (1) For elections by mail involving both state and county
2 offices, or involving both federal and county offices:
3 (A) The counties shall be responsible for voter
4 registration, absentee voting, voter service
5 centers, places of deposit, and the mailing and
6 receipt of ballots;
7 (B) The State shall be responsible for the printing
8 and counting of ballots;
9 (C) The State and counties may otherwise agree to the
10 delegation of these responsibilities to each
11 other; and
12 (D) Any responsibilities not specified in this
13 paragraph may be assigned to the counties or the
14 State by the chief election officer;
- 15 (2) For elections by mail involving only county offices,
16 the respective county shall be solely responsible; and
- 17 (3) For elections by mail involving only state or federal
18 offices:
19 (A) The counties shall be responsible for voter
20 registration, absentee voting, voter service
21 centers, and places of deposit;



1 (B) The State shall be responsible for the printing,
2 mailing, receipt, and counting of ballots; and

3 (C) Any responsibilities not specified in this
4 paragraph may be assigned to the counties or the
5 State by the chief election officer."

6 SECTION 3. Chapter 11, Hawaii Revised Statutes, is amended
7 by amending the title of part VI to read as follows:

8 "PART VI. [~~PRECINCT OFFICIALS AND~~] VOTER SERVICE
9 CENTER WATCHERS"

10 SECTION 4. Section 11-1, Hawaii Revised Statutes, is
11 amended as follows:

12 1. By adding five new definitions to be appropriately
13 inserted and to read:

14 "Business day" means any day excluding Saturdays, Sundays,
15 and state or federal holidays.

16 "District" means, unless otherwise specified, the district
17 of political representation with the fewest eligible voters in a
18 particular election.

19 "Electronic transmission" means the transmission of a blank
20 or voted ballot by facsimile or electronic mail delivery, or the



1 use of an online absentee ballot delivery and return system,
2 which may include the ability to mark the ballot.

3 "Place of deposit" means a site within the county of the
4 voter's registration address designated pursuant to section 11-I
5 for the purpose of receiving return identification envelopes in
6 an election conducted by mail pursuant to part _____ .

7 "Voter service center" means a location within the county
8 of the voter's registration address established pursuant to
9 section 11-I to serve all of the following purposes:

- 10 (1) Receive return envelopes for absentee ballots pursuant
11 to chapter 15;
- 12 (2) Receive return identification envelopes in an election
13 by mail pursuant to part _____ ;
- 14 (3) Provide voting machine services for persons with
15 disabilities pursuant to the Help America Vote Act of
16 2002, P.L. 107-252, as amended, and any other federal
17 or state law relating to persons with disabilities;
- 18 (4) Provide any other voting services as provided by law;
19 and
- 20 (5) Any other purposes the chief election officer or clerk
21 may deem necessary in the event of a natural disaster



1 or other exigent circumstances occurring before an
2 election."

3 2. By amending the definition of "ballot" to read:

4 ""Ballot" [7] means a ballot, including an absentee ballot,
5 that is a written or printed, or partly written and partly
6 printed paper or papers, containing the names of persons to be
7 voted for, the office to be filled, and the questions or issues
8 to be voted on. "Ballot" includes a ballot used in an election
9 by mail pursuant to part , including a ballot approved for
10 electronic transmission. A ballot may consist of one or more
11 cards or pieces of paper, or one face of a card or piece of
12 paper, or a portion of the face of a card or piece of paper,
13 depending on the number of offices, candidates to be elected
14 thereto, questions or issues to be voted on, and the voting
15 system in use. [~~It shall also include the face of the~~
16 ~~mechanical voting machine when arranged with cardboard or other~~
17 ~~material within the ballot frames, containing the names of the~~
18 ~~candidates and questions to be voted on.] "~~

19 3. By amending the definition of "election officials" to
20 read:



1 "Election officials" [~~precinct officials and other~~] means
2 persons designated as officials by the chief election officer."

3 4. By amending the definition of "voting system" to read:

4 "Voting system" [~~7~~] means the use of paper ballots,
5 electronic [~~ballet cards~~] transmission, voting machines,
6 elections by mail pursuant to part _____, absentee voting
7 pursuant to chapter 15, or any system by which votes are cast
8 and counted."

9 5. By deleting the definition of "precinct".

10 ["~~"Precinct", the smallest political subdivision~~
11 ~~established by law.~~"]

12 SECTION 5. Section 11-4, Hawaii Revised Statutes, is
13 amended to read as follows:

14 "**§11-4 Rules [~~and regulations~~]**. The chief election
15 officer may make, amend, and repeal [~~such~~] rules [~~and~~
16 ~~regulations~~] governing elections held under this title, election
17 procedures, and the selection, establishment, use, and operation
18 of all voting systems now in use or to be adopted in the State,
19 and all other similar matters relating thereto as in the chief
20 election officer's judgment shall be necessary to carry out this
21 title.



1 In making, amending, and repealing rules [~~and regulations~~]
2 for voters who cannot vote [~~at the polls~~] in person or receive
3 or return ballots by mail, and all other voters, the chief
4 election officer shall provide for voting by [~~such~~] these
5 persons in [~~such~~] a manner [~~as to insure~~] that ensures secrecy
6 of the ballot and [~~to preclude~~] precludes tampering with the
7 ballots of these voters and other election frauds. [~~Such~~] The
8 rules [~~and regulations~~], when adopted in conformity with chapter
9 91 and upon approval by the governor, shall have the force and
10 effect of law."

11 SECTION 6. Section 11-15.2, Hawaii Revised Statutes, is
12 amended as follows:

13 1. By amending subsections (a), (b), and (c) to read:

14 "(a) Notwithstanding the closing of the general county
15 register pursuant to section 11-24, a person who is eligible to
16 vote but is not registered to vote may register by appearing in
17 person[+]

18 ~~(1) Prior to the day of the election, at any absentee~~
19 ~~polling place established pursuant to section 15-7 in~~
20 ~~the county associated with the person's residence; or~~



1 ~~(2) On the day of the election, at the polling place in~~
2 ~~the precinct associated with the person's residence.]~~
3 at any voter service center before and on election day.

4 (b) The county clerk shall designate a registration clerk,
5 who may be an election official, at each [~~of the absentee~~
6 ~~polling places in the county established pursuant to section 15-~~
7 ~~7, prior to the day of the election and at each of the polling~~
8 ~~places in the county on the day of the election.] voter service
9 center.~~

10 (c) The registration clerk shall process applications for
11 any person not registered to vote who submits a signed affidavit
12 in accordance with section 11-15, which shall include a sworn
13 affirmation:

14 (1) Of the person's qualification to vote;

15 (2) Acknowledging that the person has not voted and will
16 not vote [~~at any other polling place for~~] in that
17 election and has not cast and will not cast any
18 absentee ballot pursuant to chapter 15 [~~for~~] in that
19 election; and

20 (3) Acknowledging that providing false information may
21 result in a class C felony, punishable by a fine not



1 exceeding \$1,000 or imprisonment not exceeding five
2 years, or both."

3 2. By amending subsections (f) and (g) to read:

4 "(f) Notwithstanding subsection (a), registration pursuant
5 to this section may also be used by a person who is registered
6 to vote but whose name cannot be found on the [~~precinct list for~~
7 ~~the polling place associated with the person's residence.~~]
8 county register.

9 (g) The clerk of each county shall add persons who
10 properly register under this section to the respective general
11 county register. Within thirty days of registration [~~at the~~
12 ~~polling place~~], the county clerk shall mail to the person a
13 notice including the person's name, current street address,
14 district [~~and precinct~~], and date of registration. A notice
15 mailed pursuant to this subsection shall serve as prima facie
16 evidence that the person is a registered voter as of the date of
17 registration."

18 SECTION 7. Section 11-17, Hawaii Revised Statutes, is
19 amended by amending subsection (a) to read as follows:

20 "(a) The clerk, not later than 4:30 p.m. on the sixtieth
21 day after every general election, shall remove the name of any



1 registered voter who did not vote in that general election, and
2 also did not vote in the primary election preceding that general
3 election, and also did not vote in the previous general
4 election, and also did not vote in the primary election
5 preceding that general election, and also did not vote in the
6 regularly scheduled special elections held in conjunction with
7 those primary and general elections, if any, with the exception
8 of:

- 9 (1) Those who submitted written requests for absentee
10 ballots as provided in section 15-4; or
11 (2) Anyone who preregistered pursuant to section 11-12(b).
- 12 If a person voted, at least once, in any of the above-mentioned
13 elections, the person's name shall remain on the list of
14 registered voters. For this purpose, "vote" means the
15 depositing of the ballot in the ballot box regardless of whether
16 the ballot is blank or later rejected for any reason. In the
17 case of voting machines, "vote" means the voter has activated
18 the proper mechanism and fed the vote into the machine. In the
19 case of an election by mail pursuant to part _____, "vote" means
20 the voter has returned the ballot to the chief election officer
21 or clerk by the United States Postal Service, by personal



1 delivery of the ballot to a place of deposit or voter service
2 center, or by electronic transmission under certain
3 circumstances pursuant to part ."

4 SECTION 8. Section 11-21, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "**§11-21 Change of name, transfer on election day.** (a)

7 The county clerk may designate a registration clerk, who may be
8 an election official, at [~~any of the polling places~~] a voter
9 service center in the county on the day of the election.

10 (b) These registration clerks shall take applications for
11 change of name from voters who have been married or who have had
12 their names changed since the last election.

13 (c) Any person whose name appears on the registered voters
14 list whose residence has changed since the last election, and
15 whom the county clerk has not transferred under section 11-20,
16 may apply on a form prescribed by the chief [~~elections~~] election
17 officer [~~at the person's new polling place~~] on the day of the
18 election for transfer of registration to the [~~precinct~~] district
19 of the new residence. Any person so transferring voter
20 registration shall be immediately added to the register of the



1 new [~~precinct~~] district and may vote only at the new [~~precinct.~~]
2 district.

3 (d) Where a person was incorrectly placed on a list of
4 voters of a [~~precinct~~] district in which the person does not
5 actually reside, the person may correct the registration.

6 [~~(e) No person shall be prevented from voting at the
7 election in the precinct in which the person's name appears on
8 the voters list due to a change of name, or other correction
9 made under this section. However, any voter registered in the
10 wrong precinct who shall refuse to make the correction of
11 registration may be challenged in accordance with section 11-25.~~]

12 [~~(f) Any person changing name or transferring shall receive
13 a copy of the change or transfer form.] "~~

14 SECTION 9. Section 11-22, Hawaii Revised Statutes, is
15 amended by amending subsection (b) to read as follows:

16 "(b) In any case where the clerk refuses to correct the
17 register, the person may appeal to the board of registration and
18 the register shall be changed upon a written order of the board
19 of registration, setting forth the reasons for the change. The
20 order shall be directed to the clerk [~~or to the precinct
21 officials of the election precinct where the voter is entitled~~



1 ~~to vote if the register has been closed. The precinct officials~~
2 ~~shall thereupon correct the list of voters furnished them~~
3 ~~according to the terms of the order, noting on the list the~~
4 ~~reasons for the correction, and shall send the original order to~~
5 ~~the clerk as soon as may be possible after the close of the~~
6 ~~polls]. The clerk, upon receipt of any order from the board of~~
7 ~~registration [or from the precinct officials, as the case may~~
8 ~~be], shall correct the register according to the terms of the~~
9 ~~order, making on the register a reference to the order."~~

10 SECTION 10. Section 11-25, Hawaii Revised Statutes, is
11 amended to read as follows:

12 "**§11-25 Challenge by voters; grounds; procedure.** (a) Any
13 registered voter may challenge the right of a person to be or to
14 remain registered as a voter [~~in any preeinet~~] for any cause not
15 previously decided by the board of registration or the supreme
16 court in respect to the same person[~~; provided that in an~~
17 ~~election of members of the board of trustees of the office of~~
18 ~~Hawaiian affairs the voter making the challenge must be~~
19 ~~registered to vote in that election)]. The challenge shall be in
20 writing, setting forth the grounds upon which it is based, and
21 be signed by the person making the challenge. The challenge~~



1 shall be delivered to the clerk who shall [~~forthwith~~]
2 immediately serve notice thereof on the person challenged. The
3 clerk shall, as soon as possible, investigate and rule on the
4 challenge.

5 (b) Any voter rightfully in [~~the polling place, including~~
6 ~~absentee polling places established pursuant to section 15-7,~~] a
7 voter service center may challenge the right to vote of any
8 person who comes to the [~~precinct officials~~] voter service
9 center for voting purposes. The challenge shall be on the
10 grounds that the voter is not the person the voter alleges to
11 be, or that the voter is not entitled to vote [~~in that precinct,~~
12 ~~provided that only in an election of members of the board of~~
13 ~~trustees of the office of Hawaiian affairs, a person registered~~
14 ~~to vote in that election may also challenge on the grounds that~~
15 ~~the voter is not Hawaiian]~~. No other or further challenge shall
16 be allowed. Any person [~~thus~~] challenged pursuant to this
17 subsection shall first be given the opportunity to make the
18 relevant correction pursuant to section 11-21. The challenge
19 shall be considered and decided immediately by the [~~precinct~~
20 ~~officials~~] clerk, and the ruling shall be announced.



1 (c) If neither the challenger nor the challenged voter
2 [~~shall appeal~~] appeals the ruling of the clerk [~~or the precinct~~
3 ~~officials~~], then the voter shall either be allowed to vote or be
4 prevented from voting in accordance with the ruling. If an
5 appeal is taken to the board of registration, the challenged
6 voter shall be allowed to vote; provided that the ballot is
7 placed in a sealed envelope to be later counted or rejected in
8 accordance with the ruling on appeal. The chief election
9 officer shall adopt rules in accordance with chapter 91 to
10 safeguard the secrecy of the challenged voter's ballot."

11 SECTION 11. Section 11-76, Hawaii Revised Statutes, is
12 amended to read as follows:

13 "**§11-76 Compensation.** [~~(a) Electronic ballot and voting~~
14 ~~machine elections. Precinct officials and related election day~~
15 ~~nonprofit groups or employees~~] Election day officials under the
16 supervision and control of the office of elections shall be
17 compensated pursuant to a schedule established by the chief
18 election officer. The schedule shall be contained in rules
19 adopted pursuant to chapter 91.

20 [~~(b) Paper ballot elections. The chairperson of the~~
21 ~~precinct officials and the precinct officials shall receive the~~



1 ~~same base amounts as in subsection (a). In addition, all~~
2 ~~precinct officials shall be paid \$5 for each three hundred~~
3 ~~ballots or portion thereof cast at that precinct.] "~~

4 SECTION 12. Section 11-77, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "~~§11-77~~ **Appointment of watchers; service.** (a) Each

Allows for additional places of deposit for personal delivery of mail-in ballots. Appropriates funds for the implementation and administration of the election by mail program. Takes effect on 1/7/2059. (SD1)
