Your Committee on Transportation, to which was referred H.B. No. 1152 entitled:

"A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF TRANSPORTATION, AIRPORTS DIVISION, PROJECT ADJUSTMENT FUND,"

begs leave to report as follows:

The purpose of this measure is to add a budget proviso to the General Appropriations Act of 2015 to enable the Department of Transportation to use the Airports Division, Project Adjustment Fund to supplement any currently authorized capital investment cost elements for Airports Division capital improvement projects.

The Department of Transportation supported this measure.

Your Committee finds that the Supplemental Appropriations Act of 2016, Act 124, Session Laws of Hawaii 2016, item C-38.02, project adjustment fund, statewide, establishes a contingency fund for Airports Division project adjustment purposes, subject to the provisions of Act 124. However, Act 124, which amends Act 119, Session Laws of Hawaii 2015, does not contain a budget proviso that permits the utilization of the Department of Transportation Airports Division Project Adjustment Fund. This measure authorizes the Governor to make supplemental allotments from the Project Adjustment Fund to supplement any currently authorized capital investment cost elements for Airports Division capital improvement projects.
