Your Committee on Conference has amended this measure by:

 Changing the appropriation amount from an unspecified amount to \$250,000;

- (2) Appropriating the funds for one fiscal year, FY 2017-2018, rather than two fiscal years;
- (3) Providing the State Procurement Office with flexibility in how it allocates the appropriation amount;
- (4) Changing the small business procurement coordinator position from permanent to temporary;
- (5) Changing its effective date to July 1, 2017; and
- (6) Making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B.
