The purpose of this measure is to require pharmacy benefit managers that conduct business in this State to register with the Insurance Commissioner.

Your Committee received testimony in support of this measure from the American Diabetes Association, Hawaii Community Pharmacists Association, CVS Health, and two individuals. Committee received testimony with comments on this measure from the Department of Commerce and Consumer Affairs and Express Scripts.

Your Committee has amended this measure by:

- (1) Changing its effective date to July 1, 2090, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purpose of clarity and consistency.

As affirmed by the record of votes of the members of your Committee on Health that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No.
