Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 301, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO RESPONSE TO WRIT FOR CERTIORARI,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to require the Clerk of the Court to grant, upon the timely written request of a party, a single extension of no more than fifteen days for filing with the Supreme Court a response to an application for writ of certiorari.

Your Committee on Conference has amended this measure to make it effective upon its approval.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of
