Your Committee on Human Services, to which was referred
H.C.R. No. 35 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE UNIVERSITY OF
HAWAII CENTER ON AGING TO CONVENE A TASK FORCE TO ASSESS
CURRENT ELDER AND KUPUNA CARE SERVICES AND THE ANTICIPATED
DEMAND FOR THOSE SERVICES IN ORDER TO IMPROVE THOSE SERVICES
AND MEET ANTICIPATED DEMAND,"

begs leave to report as follows:

The purpose of this measure is to request the University of
Hawaii Center on Aging to convene a task force to:

- (1) Review current elder and kupuna care services and
anticipated demands for these services and determine
requirements for adequate training, workforce expansion,
service expansion, and financing to address current
needs and anticipated demands; and
- (2) Submit a report to the Legislature prior to the Regular
Session of 2018 on its findings and recommendations.

Lanakila Pacific, AARP Hawaii, and two individuals testified
in support of this measure. The Executive Office on Aging and
Dean of the University of Hawaii at Manoa Myron B. Thompson School
of Social Work commented on this measure.
