Your Committee on Intrastate Commerce, to which was referred
S.B. No. 392, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO CONDOMINIUMS,"

begs leave to report as follows:

The purpose of this measure is to clarify the circumstances
under which a proxy, for condominium association meeting purposes,
shall be counted for quorum purposes only.

Specifically, this measure clarifies that if a proxy is a
standard proxy form authorized by a condominium association, and
the proxy is returned with no box checked or more than one box
checked, the proxy shall be counted for quorum purposes only.

Hawaii State Association of Parliamentarians, Associa, Hawaii
Council of Apartment Owners, and three concerned individuals
supported this measure. Hui 'Oia'i'o and a concerned individual
offered comments.

Your Committee has amended this measure by changing its
effective date to July 1, 2090, to promote further discussion.

Committee on Intrastate Commerce that is attached to this report,
