Your Committee on Finance, to which was referred S.B. No. 808, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII ASSOCIATION OF CONSERVATION DISTRICTS,"

begs leave to report as follows:

The purpose of this measure is to appropriate funds to the Department of Land and Natural Resources for the operational expenses and staffing costs of the Hawaii Association of Conservation Districts.

The Hawaii Association of Conservation Districts, East Kauai Soil and Water Conservation District, West Kauai Soil and Water Conservation District, South Oahu Soil and Water Conservation District, Hawaii Farm Bureau, Maui Chamber of Commerce, Local Food Coalition, Edmund C.
