Your Committee on Ways and Means, to which was referred  
S.C.R. No. 146, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE ESTABLISHMENT OF  
A PHILIPPINES-HAWAII TOURISM COLLEGE STUDENT EXCHANGE PROGRAM  
COMPACT,"

begs leave to report as follows:

The purpose and intent of this measure is to request the  
University of Hawaii System to establish a student exchange  
program compact between the University of Hawaii System and the  
University of Northern Philippines College of Hospitality and  
Tourism Management and the Ilocos Sur Community College Tourism  
Management Program.

Your Committee received written comments in support of this  
measure from the University of Hawaii System.

Your Committee finds that the State of Hawaii and the  
Province of Ilocos Sur in the Philippines have had a long  
relationship. The first "sakadas," or plantation workers, from  
Ilocos Sur arrived in Hawaii on December 20, 1906. Since 1985,  
Hawaii has had a sister-state relationship with Ilocos Sur.

Your Committee also finds that a student exchange program  
compact between the University of Hawaii System and the University  
of Northern Philippines and the Ilocos Sur Community College will

benefit students of those institutions and the sister-state relationship between Hawaii and Ilocos Sur. Consequently, your Committee supports this measure.


