the Office of Hawaiian Affairs.


Your Committee finds that section 171-64.7, Hawaii Revised
Statutes, requires the prior approval of the Legislature by
concurrent resolution to sell or gift certain state lands in fee
simple, and specifies information that must be included in the
resolution and other prerequisites to the sale. Your Committee
further finds that the sale of the leased fee interest in 95-029
Kuahelani Avenue, No. 128, Mililani, Hawaii, falls under section
171-64.7, Hawaii Revised Statutes, and that the Hawaii Housing



Finance and Development Corporation has met all statutory prerequisites to request approval of the sale of the property.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 24 and recommends its adoption.
