Your Committee on Ways and Means, to which was referred  
S.C.R. No. 30, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION APPROVING ACTION TAKEN BY THE  
BOARD OF LAND AND NATURAL RESOURCES ON A LAND EXCHANGE,"

begs leave to report as follows:

The purpose and intent of this measure is to provide  
legislative approval of an exchange of land between the State and  
Parker Land Trust.

Specifically, this measure:

- (1) Expresses legislative approval of the exchange of 0.78  
acre of state land currently set aside to the Department  
of Education in exchange for 5.445 acres of nearby land  
owned by Parker Land Trust; and
- (2) Classifies the 5.445 acres of land to be conveyed to the  
State as ceded lands pursuant to Section 5(b) of the  
Admissions Act.

Your Committee received written comments in support of this  
measure from the Department of Land and Natural Resources, the  
Department of Education, and Parker Ranch, Inc.



Your Committee received comments on this measure from the Office of Hawaiian Affairs.

Your Committee finds that the State will substantially benefit from this transaction by trading a small parcel of land valued at \$13,000 in exchange for a larger parcel of land valued at \$1,521,000. Your Committee further finds that this exchange serves a public purpose by increasing the land available for the future expansion of Waimea Elementary and Intermediate School.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 30, S.D. 1, and recommends its adoption.


