<u>HB 192</u> <u>Status</u>	RELATING TO HOMEOWNERS' ASSOCIATIONS. Expands the law on planned community associations to apply to homeowners' associations.	CPC, JUD
<u>HB 193</u> <u>Status</u>	RELATING TO PROPERTY. Increases the amount of the exemption from attachment or execution of (1) real property that is owned by any individual who is not delinquent on income taxes, real property taxes, or mortgages; and (2) a motor vehicle. Exempts one month of child support and spousal support from attachment or execution.	CPC, FIN
