Status

RELATING TO TAXATION.

TRN, FIN

Authorizes a county that has established a county surcharge on state tax to extend the surcharge for a limited time period. Authorizes counties that have not established a surcharge to adopt an ordinance to establish a surcharge prior to 7/1/2018. Provides that the State shall retain an unspecified portion of surcharge. Requires the mayor of the county to submit certain plans with respect to the alternative transportation system.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.


Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.
